The Washington Senators remained in a second place tie with the Yankees by beating to the Boston Red Sox, 6 to 5 at the national capital. Goose Goslin's third home run of the year was the high spot.

Successive circuit drives by Mickey McManus and Easterling— gave Detroit three runs in the second inning against St. Louis. That was all the scoring the Tigers did but it was plenty for Earl Whitfield blanked the Browns with only four hits.

In the National League at Chicago, Eppa Rixey, elongated left hander, threw the ball past the head hitting Chicago Cubs with monotonous regularity and the Cincinnati Reds galloped off Wrigley Field with a six to nothing decision.
