"LIMPY" CLEAVER LEADS BREAK FROM JAIL IN ILLINOIS

5 Men Awaiting Trial Flee
in Jailer's Auto After
Slugging Him With
Can of Milk.

(Associated Press Leased Wire)
CHICAGO, June 11.—A 54-year-old road-hauler man with a limp, held for trial as leader of the Evergreen Park mail robbers, led a sensational and apparently unpremeditated break from the Du Page county jail at Wheaton, a suburb, yesterday. Four prisoners followed him to freedom while 15 others who witnessed the break refused to leave their cells.

"Limpy Charlie" Cleaver was to have appeared in federal court tomorrow to answer the charge of robbing a mail train at Evergreen Park last winter of \$133,000. He is understood to have confessed his part in the robbery. Yesterday morning, as the jailer was about to serve the prisoners breakfast, Cleaver and four others not involved in the mail hold-up saw their chance and took it.

With a home-made black jack, a can of condensed milk inside a sock—they slugged the jailer into submission as he appeared at the door of the "bullpen." Taking his keys, they unlocked the door, ran to the jail office, seized a sub-machine gun and three shotguns and then ran into the yard where they piled into the jailer's own car.

With Cleaver were Joseph Farina, alias Joe West, 21, facing sentence for a bank robbery; Charles W. Clark, 24, held as a burglar; Oscar Olson, alias Frank Geste, under indictment for robbery; and Thomas P. McGorty, 42, under indictment for shooting and wounding a policeman.

Sheriff Lawrence Hattendorf ran after the escaped prisoners just as they got the car started and fired several revolver shots as they drove away. When the car was found abandoned last night there was a bullet hole in the body which gave rise to the belief that one of the men may have been struck.

BAKER GETS ONE YEAR

H. H. Baker, arrested in Roseburg recently on a bad check charge and released to Multnomah county officers on a like accusation, was sentenced to one year to the penitentiary at Portland last week, according to word received here. Baker was wanted in numerous cities along the coast.

CLOSE-UPS SHOW WASHINGTON'S GREAT ARE JUST PLAIN HUMANS

WASHINGTON, June 11.—No man is a hero to his valet, as the old saying goes, and for the same reason, perhaps, the famous senator or congressman whose name often fills the headlines in hundreds of newspapers, is no more than just a human being in the eyes of Washingtonians.

Distance may lend enchantment to the view in lots of cases, but not in the case of Washington's great; in fact, it seems to have just the opposite effect. A close up tends to dissolve them into just ordinary human beings who prefer certain shades in neckties, perhaps pick their teeth in public and, to a large degree, act just like the rest of us.

House Likes Sideburns—As one who has but of late returned from a sojourn in the galleries of our house and senate, I beg to report the fashion note that morning coats and sideburns are commonly worn in the house but that clean shaves and garden variety business suits predominate in the senate.

Boutonnieres flourish in the senate, too, but one doesn't see even a sunflower or geranium in a house buttonhole, with the exception of the daily carnation, generally pink, in the lapel of Speaker Nick Longworth's usually gray suit.

One of those pretty little human interest stories about the capital has it that the young Paulina decorates her famous father with the nosegay every morning when he leaves for work and sometimes calls with her nurse at his office with a fresh blossom for the afternoon.

Sen. Copeland's Flower

The senate has its flower story, too, in the person of Senator Royal S. Copeland of New York, who hasn't appeared for years without his carnation. This adornment dates romantically back to the early days of his marriage when his wife put a carnation within his buttonhole every morning.

But the house always holds one high spot which the womanless senate cannot. This is the little cluster of sideburns and morning coats always hovering about the seats of the widow congresswomen, Mesdames Rogers and Kahn. Such bowing and scrapping and genuflections over the ladies' hands one does glimpse from the gallery!

Toothpicks are valiantly wielded in the house. The gallery counted down below all working as though timed by a metronome. The 37 were wielded by wearers of almost as many varieties of hirsute trimmings—members with goatees, Van Dykes, sideburns, toupees, and plain bald domes.
