ENGINEER OREGON NATIONAL GUARD FORCED TO QUIT

Capt. Forester Parks Auto in Wrong Place, Then Disrespectful to His Superior.

(Associated Press Leased Wire) PORTLAND, Ore., June 28.—Mutiny of a company of National Guardsmen at Camp Clatsop during the encampment which ended yesterday, and forced resignation of the captain, was revealed today, the Portland Telegram says. The unit involved, the Telegram says, was Company A, 116th Engineers and the officer Captain Abraham Forester, Portland. The trouble, which led to appointment of a board of review by General George A. White, was said to have started over parking of Captain Forester's automobile. Forester was said to have had an altercation with a guard after driving his car into Camp at night instead of leaving it in a place designated for officers' cars. The Telegram's report continues: "During the altercation, it was reported, an officer who

outranked Capt. Forester appeared suddenly on the scene, his identity unknown to Forester, who is said to have unbraided him for meddling in the affair. "Forester discovered only too late that he was addressing a senior officer, who is said to have been a colonel, in his night shirt. The officer of the day later ordered Capt. Forester to his quarters under arrest and Gen. White was informed.

"General White then named a board of review.

"Meanwhile, word of the disciplinary action reached the ears of Company A, 116th Engineers, commanded by Capt. Forester. When time for duty came they refused to participate in maneuvers. "The entire company was placed under arrest at Gen. White's orders, but later was released when matters were patched up. Meanwhile, the board of review returned its finding to Gen. White who is said to have requested Forester's resignation 'for the good of the service.'

"The resignation is now in the hands of Gen. White at Salem."

WILL INCREASE CAPITAL STOCK S. AND L. ASSN.

Authority Given to Raise Its Capitalization to Two Million.

DIVIDEND 8 PER CENT

Fine Showing Made During Past Year by Umpqua Building and Loan Association.

The annual meeting of the stockholders of the Umpqua Savings and Loan Association was held last night at the Douglas Abstract building where the association's offices are located. The meeting was well attended and the stockholders were well pleased with the showing that has been made during the past year.

Despite the fact that during the past year the association has matured over \$100,000 worth of stock a dividend of 8 per cent was declared. It was shown that the assets of the company are now well over the half-million dollar mark, while the capital stock of one million dollars has all been subscribed. A resolution increasing the capital stock to two million dollars was adopted.

Authority was also given the secretary to issue 6 per cent debentures, which will permit the investment of funds for definite periods of time, this action on the part of building and loan associations having been sanctioned by an act passed by the last legislature.

A. G. Sutherland, E. N. Ewart and Guy Condon were named directors. The new officers are E. N. Ewart, president; A. G. Sutherland, vice-president; H. O. Parrotter, secretary; V. J. Micelli, treasurer; Carl Wimberly, attorney; James Ewart, S. D. Evans and G. C. Finlay, auditors.

Skirmish For Banners The skirmish took place in the Kansas alternate section in the rear and was quieted after several officers had appeared on the scene. Finally Ed Hawes, an alternate from Larned, captured that part of the broken standard bearing the name of the state and took it along in the shouting stream that was paying a tribute of loyalty to a candidate who had kept his word to stand by his guns until the end.

It developed that both the Nebraska and Philippine standard had been captured by Reed enthusiasts as they marched by Mrs. Otto J. Bauman of Omaha, wife of a delegate, sought out two policemen and with their aid retrieved the Nebraska sign post which was put back in its place. Eddie Tall, of Manila, recaptured the Philippine banner, without much trouble and it went back to its home station.

Reed's Following Small The Reed parade was not so strong in numbers, perhaps, but it had noise to spare, including the eternal clatter of the cow bells. It also had the aid of all three bands and the row was terrific. Twenty minutes after the Reed demonstration started, and when the tired voices of the sweating, steaming Reed boosters were beginning to fall, Senator Robinson reached for his bug starter gavel and let go a mighty bang for order.

With one or two of the nominating speeches still to be heard, the convention adjourned at 12:37 p. m. until 3 p. m.

Ticket Thought Settled

By BYRON PRICE Associated Press Staff Writer. SAM HOUSTON HALL, Houston, Tex., June 28.—With the prohibition tangle straightening itself out in committee, the democratic national convention cared itself today with scarcely a threat of trouble left on its horizon.

By early afternoon tomorrow, at the latest, the convention managers fully expected to adjourn finally and go home, after having put before the country a ticket composed of Smith of New York and Robinson of Arkansas, and a platform promising, among other things, strict enforcement of the dry laws and a comprehensive program of farm relief.

Today's opening session was given to a continuation of the long interlude of nominating speeches begun last night. It was the tentative plan to adopt the platform during the afternoon and cast tonight the one ballot now considered certain to result in the nomination of Smith. An overnight adjournment is expected before the selection of Smith's running mate and the final windup.

Boots For Smith The Smith procession was continued with a seconding speech by Andrew Nelson of Duluth, Minn., who said the people of Minnesota were determined that "the reign of graft and greed and privilege at Washington should end."

"The farmers of Minnesota spurn with contempt the meaningless farm relief plank of the republican platform," he continued. "At Kansas City they were handed a stone. Here at Houston they shall receive the nourishing bread of economic fair play. With such a platform of principles and with Gov. Smith as our trusted leader, the result cannot be in doubt."

Governor Albert C. Ritchie of Maryland, his state's favorite son who withdrew just a few days ago in favor of Smith, made the first speech of the day, seconding the nomination of the New Yorker. He was given a fine ovation. Many of the delegates stood and cheered as two convention bands joined in "Maryland, My Maryland."

The candidate whose cause he espoused was described by Gov. Ritchie as a man possessing all of the qualities of a great president. "I am desirous for Governor Smith's beginnings which were humble," he said. "She moulded him in the fashion of a man and he was destined to realize to their fullest and their richest degree the possibilities of America as the land of opportunity."

Another seconding speech for Smith was made by former Mayor Andrew J. Peters of Boston, who said the whole background of the New York governor was truly "American."

Mississippi passed on the roll call of the states without putting formally into nomination her favorite son, Senator Pat Harrison, who is to receive a complimentary ballot.

Noise for Jim Reed When the clerk then called the name of Missouri, the "Jim" Reed delegates of that state stood up and cheered. They raised a picture of their candidate at the end of a long pole and jingled cow bells and waved small flags in emphasis to the convention that they were standing but despite the majority against them.

Carson, of Portland.
