REMUS AND HEATH GREER AND AMERICAN JUSTICE

We Americans, as the whole world admits, are sticklers for the observance of laws. Whatever our faults, we insist that our statutes be respected and obeyed. The latest dangerous lawbreaker to learn this is named Heath Greer. Heath Greer lived in the Laurel Run region of mountainous Kentucky. He quarreled with a friend, one Luther Partin, drew a gun and shot him dead. He has been sentenced to a life term in prison. The murder was not premeditated, so he couldn't very well be hanged; but a life term will serve to teach him that America's laws cannot be defied with impunity. The only trouble is that Heath Greer is just 13 years old. The judge that sentenced him did not let that stand in his way, however. Law is law, and the judge was familiar with it. Murder is murder. Life prison, the judge said, was the only sentence he could give. On the day that Heath Greer left for the reformatory, where he will live until he is old enough to enter the penitentiary to serve time with the other murderers, the doors of Ohio's hospital for the criminally insane, at Lima, swung open and George Remus walked out a free man. Remus had killed his wife, planning the deed in advance, and had been acquitted, according to law, by virtue of insanity. Now he has demonstrated, again, according to law, that the insanity which made him a murderer has happily left him; so Ohio's law decrees that he cannot be confined any longer. It is from such examples as these that we freeborn Americans draw that admiration for law which distinguishes us above all other peoples. Liberty, we are fond of saying, can only be had by respect for law. Heath Greer doubtless will absorb that lesson during the next three or four decades of confinement. One wonders, though, just where the states of Kentucky and Ohio stand in all this. Has no one brought any action against them? Ohio rears a bootlegger and sees him commit a shocking murder; it grabs at him and discovers its own law compels it to set him free. Has no citizen of Ohio any ground for action there? And Kentucky. Kentucky rears a mountain white lad in the backwoods country; a boy who says he carried a gun "because all the other boys did, some of 'em little than me"; a boy who saw all his elders carrying guns every day of their lives; a boy who saw such children as did not carry guns carrying bottles to their play; a boy who was sinned against by society from the day of his birth. Kentucky sees this lad, in hot anger, use the gun he was carrying. Kentucky pounces on him, appalled—and finds that its own laws compels it to send him to prison for life. Has no Kentuckian grounds for action against his state? What are we to make of these two cases, anyway—unless it is that our methods of dealing with crime would be a disgrace to Fiji Islanders? Are we 100 per cent stupid, after all? When a dangerous criminal commits a brutal murder must we slap his wrist and set him free? When an ignorant backwoods boy does something much less criminal must we jail him forever instead of trying to find out what is wrong and making it right? The millennium isn't at hand yet, despite our mass production and boom days on Wall Street. We have a few jobs to do. Ohio and Kentucky can tell you what they are.

OREGON BALLOT MAY CONTAIN TEN OR 12 MEASURES

SALEM, June 30.—With the period about to expire within which initiative measures may qualify for the November ballot by the filing of completed petitions, only two of the many measures started have qualified.
The period expires next Thursday, July 5. Before 5 o'clock on that date it is known that some other completed petitions will be filed. Some are in a state of uncertainty, as far as information reaching the office of Secretary of State Kozar is concerned. Some others are obviously failing to get the required 12,228 verified signatures, while several were abandoned outright by their sponsors soon after they were started. There is a possibility that 10 or 12 measures may get on the ballot.

The two measures for which completed petitions have been filed and which are assured passage on the November ballot are Senator Dunne's bill affecting the state highway fund through automobile licenses and the gasoline tax.

The most important subject on which the voters will be asked to pass will be the income tax, for it is understood that the measure sponsored by the state grange, the state federation of labor, the farmers' union, and the order of railway conductors will be petitioned for the required number of electors. Stillard and Bylander each had an income tax bill, but it is believed their petitions will fail.

The International Uniform Sunday School Lesson for July 1. The Early Life of Paul the Apostle. Deut. 6:4-9; Phil. 3:4-6; Acts 22:3, 27, 28.

The early life of Paul reminds us that it was lived under another name. Paul the apostle was formerly Saul of Tarsus, devout, intense in his faith as a Pharisee, and passionate in his opposition to those of this new Christian way whom he regarded as dangerous heretics and whom he persecuted.

The story of Paul's change of heart and mind is not exceptional in the history of religious experience. Again and again in great religious movements those who have at first fought against the light have come to see it and have become the foremost exponents of truths and principles which formerly they opposed.

It is important to see that despite the change in his name and the crucial change in his attitude and convictions the spiritual life of Paul is one. He referred to this at one time when before the high priest he said, "I have lived in good conscience until this day."

Always Sincere.
All through his life he had been sincere and honest, faithful to the early teaching of the strict sect in which he was brought up, and passionate in his purpose to make his life effective for God.

Paul, however, illustrates the great truth that a man may be honest and sincere and yet be not only ignorant and unenlightened but utterly wrong in his conception both of God and of his fellow men. Earnestness without knowledge may very easily become bigotry, and honesty without love and kindness may become both tyrannous and dangerous.

A fanatic is none the less a fanatic because he may be sincere in what he is doing, and the havoc and wrong that he does will be none the less havoc and wrong in his persecuting zeal he destroys the structure of truth and inflicts disaster upon those who have sought to build it.

From every standpoint the life of Paul is profoundly important for consideration. Especially today when in the complexity of the modern world narrowness and the persecuting spirit so easily become emphasized and take to themselves the defense that they are the expression of strength and

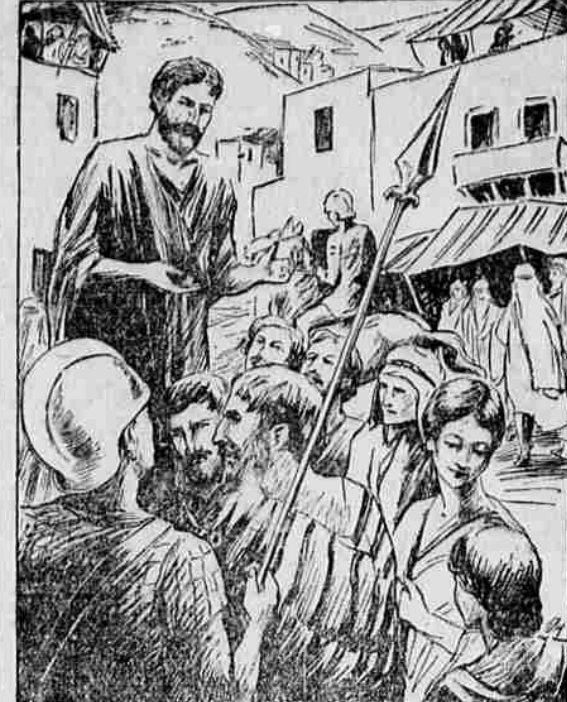

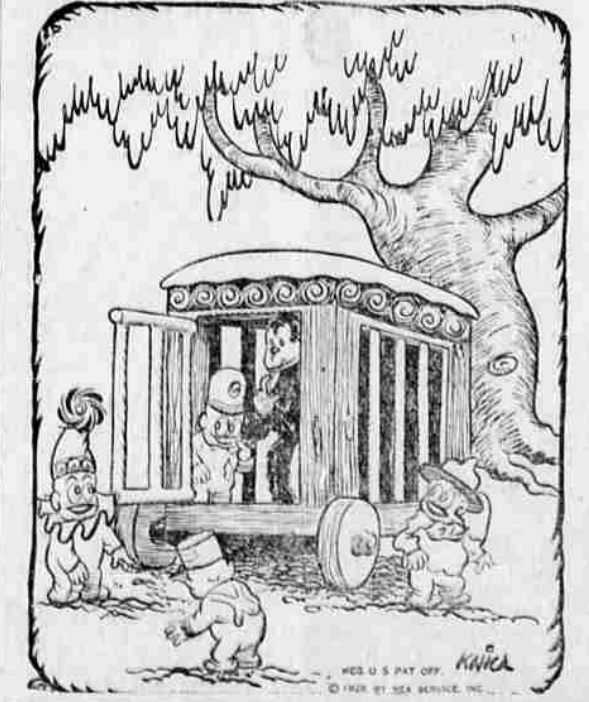
