FAMOUS SPEAKERS TO BE HEARD OVER RADIO MONDAY

President Coolidge, General Pershing and Others Join Armistice Day Program.

WASHINGTON, D. C., Nov. 8.—President Coolidge, General Pershing and Paul V. McNutt, national commander of the American Legion, will be speakers in a one-hour radio broadcasting program that will have a complete national hook-up Armistice night.

The program will be held in the Washington auditorium, tickets of admission being under the control of the American Legion Armistice day committee of the Legion department of the District of Columbia. Major Wallace Streeter is chairman of the committee.

The program will start at 9:15 p. m., eastern standard time, with the U. S. army band playing "Stars and Stripes Forever."

All the broadcasting stations, and the entire facilities of the National Broadcasting company, have been contributed to the Legion for the program by M. H. Aylesworth, president of the company. This was made possible through the courtesy of the Atwater Kent manufacturing company postponing their regular program until 10:15 p. m.

Following the first selection by the band, "Hail to the Chief" will be played as President Coolidge enters. He will speak first, then Gen. Pershing, possibly from Lincoln, Neb., and last Commander McNutt, known throughout the Legion as an orator with few equals.

After the address, the program will be taken through the courtsey of the National Broadcasting company exclusively.

Lyde R. Hunt of New York, chairman of the Legion's national radio committee, has advised Commander McNutt that in his negotiations with the National Broadcasting company, the latter has agreed it will be a magnificent thing to give a similar program each Armistice day and that the broadcasting company will do this.
