McEWAN DRILLING OREGON HARD FOR CORVALLIS GAME

Defense Working O. K. and Passing Is Perfected—Huskies Off to Meet Stanford.

EUGENE, Ore., Nov. 15.—Unless some of the players are incapacitated from injuries in practice this week, the University of Oregon will start its entire first team against Oregon State college in their annual football game at Corvallis Saturday. The three players who were injured in the California game—Stadelman, center; Robinson, half; and Christensen, tackle—have rejoined the team early this week and all are in fine condition.

Coach McEwan has been drilling his backfield in offensive play. Oregon lacked offensive power in the California game, mainly, McEwan believes, because he has been laying great stress on the defensive play. Now with the defense working satisfactorily, the Webfoot coach will concentrate the rest of the week on his attack. It is no secret that McEwan will bank heavily on forward passes for yardage. The Orangemen also use the aerial as their most effective weapon, to the extent they may develop into a battle of the air.

Huskies Primed for Fight
SEATTLE, Nov. 15.—With their heads crammed full of new plays, Washington's entire string of usable football players—34 of them—were enroute today for Palo Alto to take on the Stanford eleven Saturday. In the early days of this week virtually all of the Huskies old plays were rehearsed and new ones grillingly learned. In the hope of showing the Cardinals something heretofore not already seen, practically every tackle turning out was taken with the goal, for it is the tackle Coach Elmer Ferguson expects will receive the brunt of the Stanford attack.

One more man was lopped from the purple and gold cripple list when Bill Broz, fullback, saw action in the final scrimmage a few hours before the gridiron. Three injured men are being taken south in the hope that they will recover sufficiently to see action at Palo Alto. Big Ten Prospects
CHICAGO, Nov. 15.—The race for big ten championship honors won't be ended by the Iowa-Wisconsin game Saturday if Minnesota and Michigan succeed in their ambitions to scramble the conference standings.

Only a victory Saturday and another November 21 can insure either Iowa or Wisconsin a clear claim to the championship. A defeat for either or both would allow Ohio and Illinois a chance to tie for the title.

Whether Iowa or Wisconsin wins, they face their stumbling blocks in Michigan and Minnesota. Iowa must meet Michigan's up and coming eleven, Nov. 24, while Wisconsin faces a final game with its traditional rival, Minnesota, two days later.

With non-conference opponents carded for this week, Minnesota and Michigan have forgotten everything but the two championship contenders—Iowa and Wisconsin—and are working overtime for next week's games. Minnesota, especially, looks dangerous for its game against Wisconsin.

Twelve times since 1896, when the championship race became an annual prize, two or more teams have been deadlocked at the pinnacle of the percentage column.

The Iowa-Wisconsin game, this Saturday's elimination battle, apparently will be straight. Football development forward passes Wisconsin has developed a passing game and it is likely to be unleashed at the first opportunity. Iowa, on the other hand, will depend on straight smashes and flying wedge plays.

Rockne Remembers
SOUTH BEND, Ind., Nov. 15.—Route Rockne has announced he will positively be on hand to personally direct his Notre Dame eleven when it clashes with Carnegie Tech on Carter field Saturday.

Two years ago, Rockne learned a lesson from Carnegie Tech and he hasn't forgotten it. He hasn't that no matter how weak Coach Wally Steffen's eleven is, it is always dangerous.

Notre Dame was headed to ward a national football championship in 1924 when the team invaded Carnegie Tech's ballfield. The "great old man" of the big ten football was the only one to receive compliments from the alumni at their annual banquet last night as they arranged the football team for its failure to win a single conference game this season. The school administration received criticism because of its

high scholastic standing, 85, and the \$200 tuition fee.

John Schommer, end of the Chicago team in 1896, '97, and '98, one of the two men to win the maximum 12 "U's" at Chicago, and the Ten football referee, was profile in his praise of Stagg's ability and his criticism against the players and administration.

"Every year, I have watched Stagg wave his magic wand and turn a bunch of wooden men into football players," Schommer said. "But this year even he couldn't do that. They do not seem to have the fight or even enough wood."

"And one big reason for Chicago's failure to develop a winning team is the lack of cooperation from the administration. With our required scholastic standing of 85 and our \$200 tuition, few fathers can afford to send their boys to Chicago."

"Unless the condition is remedied, Schommer said, "Chicago might as well kiss athletics goodbye."
