PHONE CONCERN TO SPEND \$272,000,000 IN COAST STATES

The states included comprise the whole area of the company's activities: California, Oregon, Washington, Western Idaho and Nevada.

DRY LAW ENFORCEMENT IN OREGON FOR DECEMBER

(Associated Press Local Wire) SALEM, Ore., Jan. 8.—The December report of George Alexander, state prohibition commissioner, shows 83 arrests by operators of the department during the month. Fines were imposed in a total of \$7,925. A total of 2743 gallons of mash and 2,638 gallons of liquor were destroyed. Officers seized 12 stills and confiscated three automobiles.

LOCK OF HAIR IS LEADING ITEM IN 'WITCH' MURDER

(Associated Press Local Wire) YORK, Pa., Jan. 8.—The magic word "witch" has been made a defunct part of the murder trial of John H. Blymyer, reputed "poison" doctor.

First injected by a commonwealth witness, Clayton C. Hess, a brother of one of Blymyer's two alleged accomplices in the slaying of Nelson D. Holmeyer, another alleged "hexer," that single word dominated the early hours of the trial. The cross examination of Hess by the defense brought out the whole witchcraft angle of the killing.

District Attorney Amos W. Herriman, who said he hopes to convince the jury that robbery was the prime motive, fought in vain against the elaboration of "hexism."

Judge Ray P. Sherwood ruled that Hess' statement in direct testimony late yesterday that "Blymyer told me he got the witch" opened the way.

Hess told what he claims was the cause for the slaying.

"Blymyer said he had to get a lock of hair. The man has a spell over your parents," he told me.

"He said he would dig a hole and put it eight feet in the hole to take the spell off my parents."

That conversation took place Monday night, November 26, after which Hess said he took Blymyer and John Curry, one of the others awaiting trial, to a woods near the Rehmeier home.

The next night Blymyer went back to the Hess home, the witness said.

"Blymyer said, 'I need help to get the hair. The man's too strong. I'm going down to get the hair again,'" Hess testified.

Hess' brother, Wilbert, also awaiting trial with Curry, then went with the other two and Clayton Hess said he drove all three to the same woods. This was on the night Rehmeier was killed.

DEATHS FROM FLU ARE DECREASING

(Associated Press Local Wire) WASHINGTON, Jan. 8.—Preliminary reports to the public health service today showed that deaths from influenza and pneumonia increased during the week ending January 5, while the prevalence of influenza decreased.

Twenty-three states and New York City reported a total of 42,750 cases of influenza for the latter period, compared with 47,600 for the former. Forty-one cities reported a total of 746 deaths from influenza during the latter week, compared with 539 deaths in the same cities during the preceding week. Pneumonia deaths reported were 1,295 for the week ending January 5, and 998 for the preceding week.

BOY OF 9 SLAYS SISTER, AGED 7

(Associated Press Local Wire) EUGENE, Ore., Jan. 8.—Mary Margaret Grimes, 7, was fatally shot by her brother, Robert, 9, while the two were playing with a small rifle Sunday afternoon at their home 14 miles northwest of Junction City. The coroner said the shooting was accidental.

WRESTLING CHAMP BEATEN BY WISCONSIN LUMBERJACK

(Associated Press Local Wire) CHICAGO, Jan. 8.—A disputed world's middleweight wrestling championship was held today by Charles "Midgit" Fisher, Butternut, Wisconsin, lumberjack.

On Fisher's shoulders rested the somewhat questionable toga that had been won by Johnny Meyers, Chicago, defeated by Fisher last night at the Broadway armory.

Although Meyers claimed the title and had obtained a court injunction restraining the Illinois state athletic commission from awarding the crown to anyone else, the commission recognized Gus Kallio, Louisville, as champion.

Fisher's claim to the crown was gained via the decision row. Both men had won a fall when the decision was awarded the Wisconsin lumberjack after thirty-six more minutes of wrestling.

Markets

(Associated Press Local Wire) PORTLAND, Ore., Jan. 8.—Eggs and dairy products for the most part held to Monday's levels, while poultry underwent some fluctuations, with a slight upward trend for the better kinds and a downward trend for the under grades. Ducks were quoted from 11 to 30 cents, a two cent drop in the lower grades and an advance of 5 cents in the best grades. Hens over 4 months held firm at the one price of 25 cents. Medium hens sold at 22 cents. Lighter hens were quoted at 18 cents. Springs were readily disposed at 23 cents.

Standard eggs were unshakable at 45 cents, while mediums declined two cents to 23 cents for extras and 29 cents for firsts.

Potatoes were reported scarcer because of the cold weather, and this has served to strengthen the market.

Local cranberries have been exhausted. Seattle and Los Angeles berries are selling at \$7.25 for one-third barrel boxes.
