SCRIBE DENIES CHARGE IN ALIEN DOCUMENT CASE

WASHINGTON, Jan. 10.—Publication today of the hearings of the senate committee which investigated Mexican and Russian forged documents disclosed testimony that more than 200 documents alienated, expressed today according to a written report to Superior Judge George R. Freeman.

NEW YORK, Jan. 10.—George Barr Baker, former newspaper man, today denied that he had brought into this country from Mexico the forged documents that were the subject of an investigation by a committee.

"I did not bring those documents into this country," said Mr. Baker, when informed of the contents of the committee's hearings as made public in Washington.

"I was influential in having them sent into this country to an agency of this government. They were not in my possession. No effort was required to have them turned over to the government because the only interest I had in them was in getting them to our government when I had learned of their existence."

FORMER RESIDENT DEAD

PORTLAND, Jan. 10.—J. H. Dixon, 86, one of Oregon's covered wagon pioneers who came to the Roseburg district in 1832 with his father, died Dec. 30 in Good Samaritan hospital. Mr. Dixon, who was born in Kenton, Ill., in 1842, resided at Roseburg for about 20 years, lived in Salem for a time and then came to Portland where he lived for 20 years.

For the last 20 years Mr. Dixon had been a resident of Brush Prairie, Wash. Mr. Dixon was connected with early Oregon steamboating and ran a sidewheeler out of Scottsburg on the lower Umpqua. He was also a farmer and forester.

He is survived by a sister, Mrs. Amanda Jones, and a daughter, Mrs. W. K. Newell, wife of the federal prohibition director for Oregon.

SENATOR B. L. EDDY TALKS ON TAXATION

Members of the Rotary club today had the privilege of listening to a very interesting and instructive address by Senator B. L. Eddy on taxation, the one problem that is uppermost in the minds of the people of the entire state at the present time, particularly on account of the convening of the state legislature Monday, which body will have the knotty problem to solve as best fitted to the taxpayers.

Mr. Eddy made it plain that he was not taking a stand for or against any particular measure proposed for action by the present legislature. He simply pointed out the difficulties under the state constitution as to some of these proposed measures. He said that he considered it the duty of every legislator to keep his mind open and get the benefit of the best judgment of the state. As to the reduction of the taxes on motor vehicles the speaker said he believed every member of the legislature would favor a reduction provided highway revenues were kept substantially intact. At all events it is necessary to avoid dumping the outstanding highway bonds upon the tangible property of the state. He called attention to difficulties lingering in legislation of the kind, which are ordinarily not taken into consideration by those who proposed new remedies.

BOY, 14, DEFENDANT FOR "WITCHCRAFT" MURDER

YORK, Pa., Jan. 10.—Separate trials for John Curry and Wilbert G. Hess, youthful alleged accomplices of John H. Blymeyer in the "witchcraft slaying" of Nelson D. Rehnberger, were granted today by Judge Ray P. Sherwood. Curry's case was first called. He is 14 years old.

Curry, according to the testimony of Blymeyer, who yesterday was convicted of murder, helped club the aged recluse "pop waw" doctor to death when the three went to his home seeking a lock of hair to break a "spell."

Flu Epidemic Is Creating Record Demand for Vicks

432,000 Jars Every 24 Hours Needed to Keep the Nation Supplied with Vapor-Salve

Flu Milder But Widespread

That the public has not forgotten the lesson of 1918 is indicated by its prompt response to the warning of health authorities to combat the flu by keeping free from colds.

The demand for Vicks Vapor Rub, the vaporizing salve which proved so valuable during the 1918 epidemic, has already shattered by a wide margin all previous records.
