SPOKANE POLICE NAB DOYLE M'CREA. BAD CHECK EXPERT

(Associated Press Leased Wire) SPOKANE, Mar. 7.—Doyle McCrea, 36, an electrical engineer of Westwood, Calif., arrested here on a forged check, is believed to be wanted in several Pacific coast cities for forgery operations against banks, officers said. The man admitted having served in jail at Oakland, Calif., and in the federal prison at Leavenworth, Kans. McCrea, with a young woman companion, was arrested at a hotel last night after he had given a check for \$50 for some wearing apparel. The young woman also was held. Papers found in the man's possession indicated, officers said, that he had obtained \$100 each from the Metropolitan bank of Seattle; the First National bank of Longview, Wash.; the Oregon Bank and Trust company, Klamath Falls, and the Bank of America at Oakland. He carried purported letters of credit from the Westwood National bank and the Red River Lumber company of Westwood, bearing signatures of H. Rodman, cashier of the bank and T. A. Walker, secretary of the lumber company. Police said he admitted that he forged the letters of credit. He told police that he got the idea while serving a sentence in jail at Oakland. The young woman, whose name was withheld, told police she had come to Spokane from Seattle today at the suggestion of McCrea, who was to have given her \$150.

When Almazan reached Monterey Escobar had fled but in a conflict at Saltillo the loyal general's troops were overcome by rebels and General Almazan captured, the friends said. U. S. Interests Huge WASHINGTON, Mar. 7.—American diplomatic and consular officials in Mexico are exerting every effort to protect the lives of Americans and their property in the sections of the republic where revolutionary disturbances are in progress. EL PASO, Texas, Mar. 7.—An unconfirmed report that Mayor Gallo of Juarez had been executed by a firing squad of Mexican federal troops, Governor Fausto Topete, who led the reinforcements, said that nearly a thousand more troops from southern Sonora would be concentrated at Nogales, Sonora, late today.

Juarez Attacked

EL PASO, Texas, Mar. 7.—The rebel forces opened fire on Juarez at 1 p. m. The city of Juarez was completely cut off from communication with El Paso. The bombardment could be heard plainly in El Paso. Through field glasses people were seen scurrying down the streets for shelter. Telephone communication was cut off.
