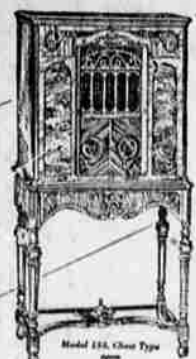
extend himself. In meeting Ramsey he will be able to prove his ability and if he wins will step into a greatly advanced position in boxing circles.

PROOF CONCLUSIVE, SAYS MAN SUING AIMEE'S MOTHER

Rev. H. H. Clark Declares Mrs. Kennedy Will Be Shown Liable at Time of Trial.

(Associated Press Leased Wire) SEATTLE, April 10.—The Rev. H. H. Clark, middle-aged, unemployed preacher, who jumped into front page publicity with the announcement of a \$50,000 breach of promise suit against Mrs. Minnie Kennedy, mother of Aimee Semple McPherson, Los Angeles evangelist, asserted here yesterday that he had "conclusive evidence" to back up the sensational allegations in his complaint.

Clark, a middle-aged man of rather slight build and under average height, declined to elaborate on the nature of his evidence, but asserted he would produce it at the proper time.

"When the case comes to trial I shall back up the allegations of my complaint with conclusive evidence, and I have such evidence you may be certain," was all the minister would say during a conference with newspaper men in the offices of his attorney.

Clark's assertion was in reply to Mrs. Kennedy's reported statement in Portland that the suit was a "blackmail" attempt and the charges "ridiculous."

Complaint Displeasing Clark's suit was filed by Attorney G. M. McGowan of Medina, across Lake Washington from Seattle. McGowan asserted papers in the case had been served on Mrs. Kennedy 26 days ago and that W. L. Grill, an attorney representing Mrs. Kennedy, had sought to have certain paragraphs in the complaint quashed.

The "short hairs" angle of the case was not made public until the complaint was filed Monday.

In the complaint, Clark asserted that Mrs. Kennedy obtained a reluctant promise of marriage from him after an intensive courtship in which she promised to finance a tabernacle here and a gospel ship for an Alaskan tour.

HOPE SLIGHT FOR FINDING OF THE SOUTHERN CROSS

(Associated Press Leased Wire) SYDNEY, N. S. W., April 10.—Yesterday's lively hopes for the safety of Captain Charles Kingsford-Smith and the missing Southern Cross fliers were not entirely abandoned today, although they seemed to rest on very frail ground.

A reef plane flying yesterday over Drysdale mission station, exchanged signals from the air with mission workers there in a dramatic fashion, gaining the information that the Southern Cross was down between that station and Port George.

A point on the coast about 30 miles distant was specified and the pilot, whose name was Woods, was believed to believe the mission workers and gained their information from bushmen or natives. They were unable to tell him of the condition of the castaways.

He traveled in the direction indicated and saw some natives and smoke signals but failed to locate the Southern Cross. After flying around a wide area he went to Derby and filed messages relating his adventure. It was understood here it was intended to follow the clue by searchers afoot who could make attempts to question the natives.

PRESBYTERIES OF SOUTHERN OREGON TO CONSOLIDATE

A joint meeting of the Southern Oregon and Coos Bay presbyteries will be held in Roseburg tonight and tomorrow. One of the chief items of business to come before the church gathering will be the proposal to consolidate the two districts into one presbytery, which will include Douglas, Coos, Curry, Jackson, Josephine and Klamath counties. The meeting will open with a banquet tonight and will be followed by a laymen's meeting. Tomorrow the presbytery sessions will be held in Roseburg while the presbyterial meetings will be held at Sutherlin, where the ladies have arranged for an interesting missionary program. A banquet for all pastors and lay delegates, together with the women's representatives, will be held at Sutherlin tomorrow night.

It is expected that the proposal to consolidate the two existing Southern Oregon presbyteries, will receive unanimous approval, as it is believed that the union will make administration much easier. Consolidation is made possible through the better means of communication provided in recent years.

"Those people have tried to frame me nineteen times before," Catts inquired about the amount of his bond, saying he could "raise \$1,000,000 if necessary."

No warrant had been served the former governor. It was understood that capias was mailed from Jacksonville to Pensacola last night.

(Associated Press Leased Wire) LOS ANGELES, April 10.—The Los Angeles sheriff's office was informed by Brawley, Calif., police today that Mrs. Ruth Jackson, mentioned as a companion of Mrs. Mabel Lewis, missing companion, Calif., woman, has disappeared from her home at Brawley.

Mrs. Jackson was described by Clifford Lewis, husband of the missing woman, and held by Salt Lake City police, as an acquaintance of his wife who planned to drive with her to the home of Mrs. Lewis' mother, Mrs. John Blanton, of Colorado Springs, Colo., and has not been seen since. He expressed fear that his wife might have been slain; that the torso found in the Los Angeles river last Thursday was hers.

REBELS FORCED TO QUIT STATE OF CHIHUAHUA

(Associated Press Leased Wire)

MEXICO CITY, April 10.—Mexican federal forces proceeded today to complete their occupation of the state of Chihuahua, a movement which will confine the rebellion to Sonora and a small section of northern Sinaloa.

General Almazan, commanding the army of the north, entered Chihuahua city last night and found it had been evacuated by the rebels 24 hours before. He was greeted with cheering and rejoicing.

It was announced Luis L. Leon, elected provisional Governor of the state to succeed rebel governor Caraveo, would take charge of the offices today. Leon, who was a former secretary of agriculture in the cabinet of President Calles, announced a program of immediate civil and social reform including partition of the great haciendas among agrarians.

Successes of General Cedillo's army in the "Christiano" country of Aguadulce and Jalisco were reported. He said there had been several minor skirmishes, none of consequence. The so-called religious insurgents have been driven from Durango and he hoped to engage them in battle at Tepic, Jalisco.

Rebels Quit Juarez

JUAREZ, Chihuahua, Mexico, April 10.—Rebel troops who infested this city after a sanguinary street battle a month ago, abandoned their prize last night in the face of advancing loyalists and stemmed away westward, apparently intending to combine forces with the revolutionary army in Sonora.

A train of 26 cars, commanded by General Caraveo and heavily laden with men, horses and equipment, left Juarez last night for an unannounced destination. The city practically was deserted of troops, only a handful of rebels remaining behind to serve as a rear guard.

At Coenen, 28, of El Paso, airplane mechanic, was forced to accompany the evacuating army. It was reported the American was lured aboard the rebel troop train and held under guard until it left. Coenen, who has a wife and two children in El Paso, had been a mechanic for standard air lines before being pressed into service by the revolutionists.

Only three other rebel fliers accompanied the train, the remainder of General Caraveo's pilots having deserted and crossed the Rio Grande before the troop movement started. Two airplanes, in need of repair, were towed to the American side of the river and left there so they would not fall into the hands of the federalists.

There was one serviceable plane aboard the train, a Vought Corsair captured by insurgents after it had been brought down at Jimenez.

Junction Sought General Caraveo indicated he would remain in western Chihuahua for a few days, using Casas Grandes as a base for guerrilla operations. It was believed he hoped to join forces with the rebel General Nicolas Fernandez who was reported on his way to Casas Grandes from Chihuahua City overland with 400 cavalrymen, destroying branches of the Mexican North-western railroad en route. The combined rebel forces then were expected to proceed into Sonora for a further concentration of the revolutionary army.

Federal forces last night were reported only a few miles from Juarez, advancing from Guadalupe. They had promised the United States they would not attempt to occupy the city until rebel troops had evacuated.
