AREAS IN THREE STATES SWEEP BY HIGH WATER

Farm Regions in Oklahoma, Kansas, Missouri Hit Hardest - Three Lives Lost.

Many Families Forced to Quit Homes - Arizona Fire Burns Over 15,000 Acres.

Three lives were lost and great property damage was the toll exacted over the week-end by swirling waters.

The Smoky Hill river, at Salina, was breaking over residential sections. The river, two feet under the 1927 flood peak, still was rising at Marquette, farther up stream, however.

PARENTS OF TEN SUSPENDED GIRLS THREATEN SCHOOL

LONG BEACH, Calif., May 12.—The father of Margaret Lindsay, 18, who attained her majority at the price of taking her meals from the marketplace, and the parents of nine other young ladies who inflated Margaret with paddles, today threatened war on the board of education for suspending their daughters from Polytechnic high school.

"I will send Mary Jane to school tomorrow," said Mrs. M. J. Meisenheimer, "and we will see whether they refuse to admit her to classes. I am proud of the girl because she told me the truth."

"The girls were suspended for belonging to a sorority, contrary to a state law. The sisterhood became known to officials when Jean Lindsay protested that the girls were 'too rough' in initiating his daughter into the secrets of the order with wooden paddles. Miss Lindsay, he said, was forced to stay in bed two days and was still dazing in the buffet or free lunch counter style."

"They are not going to suspend her," declared Lindsay. "The experience already has been painful enough for any girl. She's resigned from the order, anyway."

"Oh, well, girls will be girls," said the father of one of the suspended young ladies. "These girls are just jumpy, full of pep, that's all. It's the climate."

SLAYING YOUTH SEES ONLY LOSS OF CLUB HONORS

SEATTLE, Wash., May 13.—While Leo Axtell, 17, wept in jail because his arrest would keep him from being elected president of a high school boys' club next year, his step-father Wad Axtell, 48, died at a hospital here last night from a bullet wound in the head.

"I just meant to shoot him in the arm," Leo told reporters. "But he must have ducked his head down and got it there. This thing will cost me the chance to be president of the boys' club."

Friction started between the two when three weeks ago the boy was arrested for burglarizing the high school.

DENTON G. BURDICK, STATE LEGISLATOR, SUED FOR \$47,500

PORTLAND, May 12.—Charges that Denton G. Burdick, former speaker of the house of representatives and present member from Deschutes county, extorted large sums of money from her by "false and fraudulently representing his status and ability," were made here today by Sarah E. Smith, of Bellingham, Wash., in a civil action filed in circuit court.

Named defendants with Burdick, who is a Redmond, Ore., attorney, are his wife, 50a, his brother and sister-in-law, Mr. and Mrs. Nelson Burdick, and Joseph Marsh.

Mrs. Smith declares in her complaint that she lost a considerable sum of money and property several years ago and that Joseph E. Marsh, an old acquaintance, gained her confidence in 1927 and brought Burdick to her residence in Bellingham in October of that year, urging that she retain him in a legal capacity in connection with her losses.

The complaint alleges that Burdick told Mrs. Smith he was very influential, was an intimate friend of a former governor of Oregon and could bring to justice the people who had defrauded her. He said, too, the complaint declares, that he could bring about the recovery of her money and property, whereupon she paid to Burdick and Marsh as a starter \$15,000.

The complaint sets forth that Burdick cautioned her not to reveal the transaction to any banker or lawyer, saying his plans to aid her would be disrupted in that event.

Mrs. Smith is suing to recover all the money she says she turned over to Burdick, in the amount of \$47,500.

Death Calls George Stallings, "Miracle Man," Who Led Boston From Cellar to Pennant in 1914

HADDON, Ga., May 13.—George T. Stallings, who won fame in 1914 by capturing the world's baseball championship for the Boston Braves, died today at his home near here. Stallings was 63 years old.

Death came after an illness of several months which had forced his retirement from the management of the Montreal club of the International league.

Stallings was given the name of the "miracle man" in the baseball world after his remarkable record in 1914 in leading the tall-ent Boston Braves to the pennant and the world championship.

That memorable triumph was achieved in a ten weeks' baseball marathon, during which the Braves passed all other entries, shattered the hopes of the Giants for four straight pennants and closed the season in front with a margin of ten games.

Stallings began his career in professional baseball as a catcher with the Oakland club of the Pacific coast league.

Heinrich analyzed a coffee cup from which Carroll Rabien drank shortly before his death at Tuttle town on the night of April 26 and announced the cup contained a sufficient amount of poison to cause death.

HOUSE IS READY TO PUT QUETUS ON DEBENTURE

As Revenue Raising Plan, Senate Had No Right to Initiate It, View of Leaders.

Hoover Said Worried Over Party Split - Tariff Measure Due for Revamping.

WASHINGTON, May 13.—Holding the export debenture plan of farm relief, constituting revenue legislation and under the constitution therefore should originate in the house, republican house leaders today decided to move to refuse to accept the senate farm measure after its approval by that body.

Although house leaders have indicated they will confer with senate leaders on the subject, the house group intends to insist that the constitutional provision be observed strictly.

The farm bill passed by the house does not embody the debenture proposition and before house action on the bill its agriculture committee overwhelmingly voted down a move to incorporate the principle.

The senate, however, last week over the wishes of President Hoover, wrote the debenture plan into the measure. The difference between the houses on this proposition will delay final disposition of the farm question.

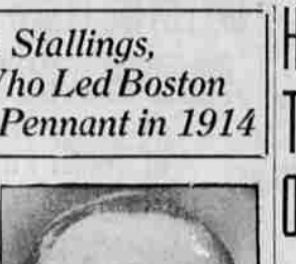
MEXICAN KILLED IN AUTO WRECK NEAR WOLF CREEK

GLENDALE, May 12.—One Mexican was killed and four others were bruised and cut by glass when a Chevrolet touring car driven by Jose Amendezor went into a ditch and turned over on the Pacific highway just south of Wolf Creek, not far from Laurel Camp, about 9 o'clock Sunday forenoon.

Carlos Flores, who was riding in the front seat, was caught underneath the automobile and his skull fractured. He was taken to Wolf Creek where an ambulance was summoned which rushed him to the hospital at Grays Pass, where Flores died a few hours later.

MISSING TAXI MAN FOUND MURDERED

BIRBE, Ariz., May 13.—The body of Tom Chambers, missing Douglas, Ariz., taxi-driver, was found by a deputy sheriff. The body was in a shallow grave on one of the principle streets of Agua Prieta, Sonora, Mexico, across the international line from Douglas. The head had been battered in, and an identification was completed only by papers, Chambers disappeared Wednesday.
