Despite the fact that the Strawberry Carnival this year was limited to the baby parade, which was held at 10:15 o'clock this morning, this event was well worth the effort made to continue the annual festival this year.

The parade was not as large as last year, but was fully equal in beauty, and was highly praised by all who saw it.

The first section was devoted to baby carriages and go-carts, preceded by two youthful pages blowing lustily upon their toy trumpets.

The carriages and go-carts were for the most part decorated in brilliant seasonal flowers or bright crepe paper, ribbons and streamers. Riding in the vehicles were the brightly dressed, happy-faced babies, who appeared to be taking a great deal of interest and enjoyment in their participation in the event.

The second section was for tricycles and wagons and a great deal of originality was displayed by the parents in preparing the entries for this division.

Diamond Jubilee of G. O. P. Held At Birthplace In Wisconsin City

RIPON, Wis., June 8.—A seventy-five-year-old echo was picked up in this historic little town today and amplified to gigantic proportions by the thousands came to attend the republican diamond jubilee celebration. Its genesis was a meeting in 1854 of a handful of political-conscious pioneers, who, moved by the crushing defeat of the Whig party and the threat of slavery to gain a foothold in the north, were determined on drastic action.

"The same building that sheltered the leaders of this then remote hamlet, nestled in the green wooded hills of the new state of Wisconsin was the center of today's ceremonies commemorating the birth of the republican party three quarters of a century ago.

Ripon bulged with a visiting list four or five times greater than the total number of inhabitants. Approximately 20,000 persons were here for the celebration.

Fourteen bands, cavalry, military escorts, Ripon college R. O. T. C. unit, drum corps, historical floats, and a two-ton elephant, symbol of the G. O. P., featured the three-mile parade which was to precede a pageant picturing the growth of the party.

Cabinet Member Speaks Commemorating the 75th anniversary of the founding of the republican party, Secretary of War James W. Good declared that through republican leadership the country reached its present state of prosperity, contentment and well being.

OFFICER FATALLY SHOT IN BATTLE IN STRIKE CITY

Four Other Men Hurt, Two Of Them Seriously; 44 Unionists Are Put Under Arrest.

GASTONIA, N. C., June 8.—Chief of Police O. J. Aderholt, who was shot last night in a fight between guards about the tented colony of striking Loran cotton mill workers and city policemen, died today.

Chief Aderholt was hit in the lungs with birdshot. Three other men were in hospitals, two of them in a serious condition. A fourth was nursing birdshot wounds, and forty-four members of the National Textile Union were in custody charged with assault with intent to kill as a result of the fight.

The city, which for several hours last night was thrown into a turmoil, had grown calm with rapid work by special police detectives in rounding up suspects. A request for troops made to Governor Gardner met with a statement that the local officials should handle the situation if possible and the request was withdrawn.

A. J. Roach, a patrolman, was peppered by scores of shot and was regarded as being in a serious condition while it was expected that patrolman Tom Gilbert would recover. Patrolman Charles Ferguson received a number of shot in his arm and shoulder and Joseph Harrison of Passaic, N. J., who claims to be a National Textile Workers' union organizer, was struck in the arm and side. Harrison was held under guard at the hospital.

The shooting, all agree, was done by guards posted about a tent, established by the National Textile Workers' union for some 150 persons, strikers and members of their families, who were evicted from houses in the Loran mill village a month ago. The policemen fired only one shot, it is claimed. Patrolman Ferguson's gun was discharged when he fell to the ground to avoid a load from a shotgun.

Among those arrested were all of the strike leaders or the ground (Continued on page 5)

FRENCH PRISON IS STORMED BY MOB; 20 PERSONS HURT

(Associated Press Leased Wire) LIMOGES, France, June 8.—Twenty persons were seriously injured here today in an outbreak of rioting incident to storming of the prison by a mob of 10,000.

The disturbance followed return of a sentence of life imprisonment for Charles Bataud, degenerate son of a local merchant, who was convicted of two serial murders, but by a strange twist of court procedure saved from the guillotine.

The mob formed outside the prison and demanded Bataud be handed over to them. Troops finally joined police to quell the uprising but it was not until after mounted police had charged again and again into their midst that order was restored.

Fourteen of those injured were republican guards. There were a large number of minor injuries.

CITY'S FLORAL SHOW DELIGHTS MANY VISITORS

Admiration and Praise Won By Varied Exhibit Of Blooms Staged By Women's Club.

Wild and Domestic Types In Commingling of Beauty; Prizes Awarded For Best Entries.

TALLMAN IS NOT ACCUSED, BUT JURY ADVISES ARREST

(Associated Press Leased Wire) LOS ANGELES, June 8.—William L. Tallman, 24-year-old, radio man, last night was recommended for apprehension and interrogation in the coroner's jury's verdict, following inquest into the death of pretty Mrs. Virginia Patten, 28, slain wife of a Portland business man. The verdict declared:

"We find the deceased came to her death through being struck on the head with a brick in the hands of a person unknown to us, but we recommend officers apprehend and interrogate William L. Tallman in the case."

Tallman, who was placed under arrest about the steamer Admiral Benson, enroute to San Francisco, was missing from his stateroom when San Francisco officers boarded the vessel Wednesday night at San Francisco to take him to jail. Since then no clue has been found indicating the wireless operator's whereabouts.

WALTER FINKE, JR., WAIVES HEARING ON CHARGE OF MURDER

(Associated Press Leased Wire) PORTLAND, Ore., June 8.—Walter J. Finke, Jr., 16, slayer of Herbert Beem, 18, his high school rival for the affection of a 16-year-old girl, today sat in municipal court while his attorney waived preliminary hearing on the charge of first-degree murder placed against the boy. Finke was bound over to the juvenile court.

The course of Finke's case now will depend upon the discretion of the juvenile court. He may be sent to the state reform school, or stay until he is 21 years old, or be turned over to the grand jury.

9 2-5 SECONDS NEW WORLD'S RECORD FOR 100-YD. DASH

(Associated Press Leased Wire) STAGG FIELD, Chicago, June 8.—George Simpson, Ohio State sprinter, established himself as the outstanding sprinter in the world today when he won the 100-yard dash in the finals of the national collegiate track and field championships today in 9 2-5 seconds, eclipsing all world records.

Simpson capped a fifth of a second off the official recognized world's record of 9 6-10 seconds by his marvelous victory. He beat Claude Bracey, the Dixie flier of Rice Institute, Houston, to the tape in a step in a thrilling finish. Thundering back of them came Eddie Tolson, sensational negro sprinter from the University of Michigan, with Cy Leland of Texas Christian fourth.

SENATE GROUP GRILLS McNARY ON DEBENTURE

House's Rejection Of Plan Doesn't Satisfy Those Who Differ on Farm Bill Status.

Approval of Moot Measure in Present Form Looked For—Half Million Fund Available.

(Associated Press Leased Wire) WASHINGTON, June 8.—Final disposition of farm relief legislation was undertaken in the senate today with doubt prevailing whether the export debenture group would be able to prevent acceptance of the farm bill agreed upon by the conference committee which eliminated that proposition.

The house approved the conference agreement yesterday. If the senate does likewise, the measure will go to President Hoover as once.

McNary Under Fire Asking approval of the conference bill, Senator McNary, of Oregon, in charge of the measure, declared he and other senate conferees had exhausted every argument to have the house vote on the debenture plan and failing to obtain this had decided to recede from their support of the proposal.

Friends of the export debenture plan subjected McNary to a severe grilling in questioning him as to why the senate conferees had agreed to eliminate the plan.

The senator, however, insisted that the senate conferees had done their best but were forced to admit defeat.

"I felt then, and I feel now," he said, "that it was necessary to get farm legislation soon. I believe this conference bill will be a considerable assistance to agriculture."

Senator Caraway, democrat, Arkansas, asked if the senate had receded because "any senator" was promised by President Hoover the opportunity of selecting some members of the proposed farm board.

McNary replied such an assumption was groundless.

Senator Robinson, of Arkansas, the democrat leader, asked if the conferees had discussed the merits of the debenture proposition and McNary answered that practically all of the discussion was over what the house conferees considered the constitutional rights of the house to initiate such legislation.

Other senators asked if an agreement was entered into with house members after they had walked out of the conference that the debenture section would be eliminated if they would agree to resume negotiations. The Oregon senator replied he knew of no such agreement.

11 NEGROES FACING CHARGE OF TRYING TO POISON FAMILY

(Associated Press Leased Wire) WEST POINT, Miss., June 8.—Eleven negroes implicated in an alleged plot to revenge a whipping administered one of their number by poisoning the family of Walker Gonzales, farmer, faced preliminary hearing today on charges of attempted murder.

Sheriff Lon H. Miller announced he had obtained a confession from one of the negroes, but did not reveal his name. Six of those involved, including two women, were in jail here, four were free on bond and one was held in Aberdeen, Miss. All live near the Gonzales farm, ten miles from West Point.

Poison was found in a drinking cup used by the farmer's family which includes several children. Sheriff Miller said. The officer did not give the nature of the trouble Gonzales had with the negroes which resulted in the alleged whipping.
