PIONEER RIDDLE RESIDENT DIES AT AGE OF 78

(News-Review Douglas County Special)
RIDDLE, June 8.—John David Cornutt was born December 22, 1851, in Bates county, Missouri. His parents, Alfred and Mary Cornutt, with their 13 children, of which the deceased was the youngest, emigrated in the spring of 1853 to the west, crossing the plains with ox teams, and in the fall of the same year settled on a farm near Gresham, Oregon.

This pioneer family lived there for 11 years. While there another child was born, making seven boys and seven girls in the family. Here Mr. Cornutt, while a mere boy, saw Oregon in its making, Portland at that time consisting of only a few houses along the Willamette river. In 1864 the family with their 14 children moved again and located in Missouri Bottom near Riddle. Here the family lived a few years and then moved across the Umpqua river on what is now known as the Pruner place.

This pioneer family suffered the hardships with other early settlers in this valley, hauling their provisions by team and wagon from Portland and Scottsburg, and Mr. Cornutt only a boy made these trips with other settlers many times.

On May 31, 1874, he was married to Sultana Jane Duncan, another daughter of the early settlers, and moved on a farm near Riddle, where they resided until his death.

Six children were born to this union, of which three are still living. He was well known and liked by his many friends and neighbors throughout this community and at ways had a cheerful word for those who met him.

May 31, 1924, this happily wedded couple celebrated their golden wedding anniversary at their home to a large number of friends and relatives throughout the state, receiving many tokens of love and happiness.

He became a member of the South Methodist church over 50 years ago and was active in Christian and church work until his death. He was also associated with other social and fraternal organizations, being a member of the Masonic and Woodman of the World orders for many years.

The ending of this life closes the life history of this well known and highly esteemed pioneer family as he was the last survivor. Those left to mourn his death are his dear and beloved wife and three children, Perry E. and John M. Cornutt of Riddle, and Mrs. Minnie Jackson of Los Angeles; also seven grandchildren.

He died after a brief illness June 5, 1929, at the age of 77 years, 5 months and 13 days.

MAC DONALD NAMES FIVE MEMBERS OF HIS NEW CABINET

Attorney General Deserter
From Liberals; Woman
Said Slated for
One Place.

LONDON, June 8.—An official labor party announcement today said that W. A. Jovitt, a distinguished member of the bar who was elected to the new parliament by the Preston division as a liberal, had joined the labor party. It was generally understood that he would be appointed attorney general in the cabinet being formed by Ramsay MacDonald.

The labor party recruit has been a king's counsel since 1922. He was a member of parliament as a laborite from the Hartlepool division in 1924.

Five other appointments in the new cabinet were listed as certain they were:

J. H. Thomas, lord privy seal, a post of little duty which will allow him to be minister in charge of unemployment. He was secretary of state for the colonies in the former MacDonald government.

Arthur Henderson, minister for foreign affairs. Henderson was home secretary in the first labor government and has been president of the labor and socialist international since 1925.

Phillip Snowden, chancellor of the exchequer, replacing Winston Churchill. He will hold again his post in the first MacDonald government.

John R. Clynes, home secretary. He was Lord Privy Seal in the 1924 government.

George Lansbury, first commissioner of public works. He was formerly editor of the Daily Herald, chief labor organ.

In addition appointments of three others were regarded as virtually certain. They were:

Sir John Sankey, to lord high chancellor, giving up his lifetime post of lord justice of appeal.

Viscount Chelmsford, secretary of state for India. He was former viceroy of India and first lord of the admiralty.

The following were considered probabilities for remaining offices: Arthur Greenwood, who was undersecretary for health in the last labor government, to become minister of health.

William Graham, former financial secretary of the treasury to become president of the board of trade.

Tom Shaw, former minister of labor, to become minister for war.

Wedgewood Benn, who abandoned the liberals in 1927 to become first lord of the admiralty; Sir Charles Trevelyan to resume as minister of education.

In addition Miss Margaret Bondfield, who was parliamentary secretary to the ministry of labor in the 1924 government almost certainly will receive some post of cabinet position. She will be the first woman to achieve that honor.

It is understood also on good authority that Lord Parmoor will be lord president of the council and leader of the labor party in the house of lords, where he also will represent the foreign office.

COPCO ANNUAL REPORT SHOWS GOOD PROGRESS

The annual report of The California Oregon Power company recently distributed to over 5000 shareholders shows that the local company continued its consistent record of development and progress throughout the year 1928.

Not construction expenditures during 1928 were \$1,212,442, the most important projects being the completion of the new 32,000 kilowatt capacity Prospect No. 2 hydroelectric generating station on the north fork of the Rogue river at Prospect, Oregon, which was placed in service early in the year, and the high voltage transmission line connecting this plant with the Copco No. 2 station on the Klamath river in California. Various improvements and additions to equipment were made in other plants and substations on the company's system, and lines and service were extended to serve many new customers.

In the water department, a 400,000 gallon reservoir was constructed in the city of Klamath Falls, increasing the total reservoir capacity of the water system in that community to approximately 1,650,000 gallons. The new reservoir not only improves service to customers already on the lines, but it also provides adequate capacity to take care of the rapidly growing residential sections of this thriving city. In addition, it was necessary to construct new transmission mains and install additional fire hydrants in the cities of Klamath Falls and Roseburg, Oregon, and Dunsmuir, California. Considerable additional installation of pipes and mains was also required to meet the growing demands for service in these communities.

The company's policy of providing for the future by additions and improvements to its properties will continue during 1929. In order to keep ahead of the growth and development anticipated in southern Oregon and northern California, The California Oregon Power company has planned to expend approximately \$1,392,000 for construction purposes to provide en-

larged and improved facilities for serving the public.

Plans are under way for the construction of a transmission line from Dixonville to Marshfield, Oregon, for the purpose of a more extensive interchange of power between the Copco system and the system of the Mountain States Power company, which is also one of the subsidiary public utility companies of Standard Gas and Electric company, Marshfield is the headquarters of the Coos Bay division of the Mountain States Power company. Construction of this line will improve service in the respective territories by supplying a dual source of power through an inter-connected transmission network. Detailed plans are now in course of completion and active construction will begin in the near future. It is expected that the line will be ready for service by fall.

Reference to the comparative earnings statement which appears in the first part of the report shows that the gross earnings of the company for the year 1928 increased \$471,760.59 over the previous year's figures, representing a 16.29 per cent growth. Net earnings increased \$439,247.99, or 25.51 per cent. The increase in revenue from the electric department amounted to \$449,826.42, or 16.53 per cent. The balance of the increase in gross earnings reflects the growth of the water department and amounted to \$21,934.17, or 11.45 per cent. Earnings of the electric department constitute more than 93 per cent of the company's gross earnings.

Death Disbands Gang of Mark Twain's Book.

Missouri Section Now Has Only
Memories of Characters
in "Tom Sawyer."

HANNIBAL, Mo., June 8.—Tom Sawyer's band of adventurers all have gone on to the great adventure.

Those who now would learn of them must take their lore from the imprint that Mark Twain and his boyhood associates left in this corner of Missouri.

The last of those, who, with "Sam" Clemens, fought the imaginary pirates of the Mississippi, passed with the death of "Gull" Brady.

Others identified with the Twain group were S. H. Honeyman, Jim McDaniel, B. O. Farthing, Ed Pierce and, of course, Laura Fraser, who the humorist immortalized as "Becky Thatcher."

Young Clemens, Brady recalled, was a bashful boy, with a fondness for pretty little girls.

"He had to do his 'sparklin' by proxy," he once said. "Once I heard him say to his school deskmate, 'John, if you will go and tell Laura at recess that I like her, and think she's the prettiest girl in school, I'll give you the next apple I get.'"

The "Laura" was Laura Fraser. She preceded "Gull" to the grave by a few weeks.

And so has passed the "old Twain gang," but the years only etch deeper its mark on Hannibal. And the dirty faced, pantalooned leader left the adventures' imprint on literature's shelves for succeeding generations to read—and chuckle over.

Twain's mark is deeply etched in the communities that knew him first, if not best.

The two-room house at Florida, Mo., where Clemens was born, is a shrine. On its walls are commendatory letters from three presidents: Wilson, who "greatly admired" the only married girl in school, "foremost among men of letters," and Coolidge, who called him "distinctly American." A memorial bust in Florida's square is inscribed: "He cheered and comforted a tired world."

Twain's Hannibal home is a museum.

LOYALTY SUNDAY TO BACK HOOVER'S POLICY IS URGED

NEW YORK, June 8.—A proposal to proclaim Sunday, June 30, as loyalty Sunday, dedicated to "the Hoover program of law enforcement" has been endorsed by Henry Ford and other influential individuals and groups.

The proposal with the list of signers was announced by Edward, executive director of the religious information service of the Christian Herald association. It reads in part:

"The American people have been summoned by President Hoover to pledge anew their loyalty to the laws of the land.

"We urge that Americans of whatever faith join on that day in a solemn resolution to observe the law, beginning that observance in their own homes and extending it, in so far as they are able through the communities in which they live."

The proposal has been endorsed by the general assembly of the northern Presbyterian churches and the Anti-Saloon league of America.

Individual signers include: William E. Sweet, former governor of Colorado; J. C. Penney; Dr. William Hiram Foulkner; George F. Milton, editor of the Chattanooga News; Dr. Daniel E. Poling, president of the International Society, Christian Endeavor; Ernest H. Cherrington, bishop James Cannon, Jr., and Mrs. Ella Boole, president of the National W. C. T. U.
