

COUNTY OFFICES BEING MOVED TO NEW QUARTERS

Next week will be moving week at the court house. Already some of the offices have been changed to the new building, and it is expected that the complete transfer will be made early next week. Miss Agnes Pitchford was the first to occupy quarters in the new building, and Assistant Frank Calhoun has also moved into his new rooms. The sheriff's department has completed moving part of their furniture, and will take possession of the new rooms as soon as the telephones are connected, which will probably be Monday. The health unit will also move Monday, according to present plans, and the tax department will probably make the change Monday and Tuesday. Some of the records already having been placed in the new files. The clerk's office will probably be the last to move, as it will take considerable time to place the new files and transfer the voluminous records.

As soon as the present structure can be completely vacated it will be torn down at once. The court recently advertised for bids for wrecking the building, but was unable to secure a satisfactory proposition, so will have the work done by force account, using some of the county prisoners as laborers.

The front entrance to the new building cannot be completed until the present building is out of the way, but while the additional construction work is being done a temporary entrance will be used from the west side, a board walk having been built in from the street.

spectators had to say about the failure to reach Paris.

"Oh well," the youth remarked, "I'll tell the world we're on the other side of the Atlantic, aren't we? How about that?" Then he added, "anyway we have plenty of time to get to Paris after we get some gas."

Took a Chance.

Schreiber said he and his friend flipped a coin to see which one would take the Yellow Bird and crawled into the tail cavity where he was sheltered from casual view by struts and the baggage. He and his friend previously had reconnoitered and remarked that there was room for a person in the tail, nothing else that none of the aviators ever seemed to look back there.

He planned to go aboard just before the aviators reached the plane to prepare for a start. He knew there were people about who might see him but he boldly got in and took his chance.

He said his ride was not always pleasant but he was decidedly glad to get his feet on earth again. He added he was ready now for a parade in Paris and the welcoming yells of thousands who expected to greet "him."

Pilot's "Throw" Scare.

Describing the discovery that a stowaway was aboard, Rene Le Fevre told the Associated Press correspondent:

"He came creeping out from the tail of the ship. He was on his knees at first, but when finally he stood up he had 'seen legs' and swung from side to side.

"We would have been people of little heart if we had turned back and put him off, or—laughing—"thrown him overboard, as we made him believe we were going to do.

"But our own fear for our safety was as nothing compared with the trepidation we felt for him and the assurance we had that if something happened we would be blamed for not having put him off."

Armeno Lotti said: "I'll have committed a crime on this voyage if I shall never commit one. My intention when I saw the boy crawling out from the tail of the plane was so great, I was much tempted to throw him off and lighten our load, which was just sufficient to keep us from achieving our goal."

The youth knew few words of Spanish. With those few he told some who talked to him he was a vaudeville actor and that his parents were from Budapest. He said he hid in the tail of the plane on the night prior to the flight.

He was unable to sleep all last night, the clamor of the little town's inhabitants outside the hotel keeping him all four awake.

Youth Envisions Fame.

Schreiber considered he had placed himself on the hall of fame by stowing away on the Yellow Bird and seemed oblivious of the danger and disappointment he had caused the gallant French aviators.

"Before the trip I was weighing in my mind the difficulties to be encountered because of added

weight, but I decided to take a chance, fearing only to be discovered before the hop off. When the plane got off the ground I felt a great relief, and I felt sure that the stunt would succeed."

Whenever the photographers came to take his picture, he seized the American flag which the Yellow Bird brought and waved it theatrically.

LEG FOUND MAY BE LINKED WITH "TORSO" MURDER

LOS ANGELES, June 15.—A woman's leg, severed at the knee, was found by J. E. Van Wing, on his ranch near Pismo, who reported the discovery to the sheriff's office early today.

Deputy Sheriff A. L. Hutchinson, who received the report said the limb, from all appearances, had been lying in an exposed position for several months. Hutchinson added that Van Wing said he had noticed the leg in a walnut grove, a week ago, but thought it to be that of an animal. The severed member will be held by the local town coroner pending arrival of a detail of deputies who will start for the ranch later today.

Hutchinson said an examination will be made to determine if the limb belonged to the torso found some months ago in the Los Angeles river bed near Compton. Three weeks after finding of the torso, a skull was uncovered some distance away and both were identified as belonging to the body of Mrs. Laura Belle Sutton, missing Artesia woman. Dr. Frank P. Westlake, a retired physician, is held in the county jail on charge of the murder of Mrs. Sutton. Arms and legs of the torso were never found.

Puebla is located several miles from the Los Angeles river. The deputies were to search the entire vicinity to determine if any other parts of a human body were there. A coroner's physician will investigate and decide whether the limb could have been a part of the torso which a few days ago was positively identified as belonging to Mrs. Sutton.

Mentioned Engagement.

Police learned that the girl had gone to the hospital Thursday night to inquire about part-time employment there to defray expenses at the school of medicine during the summer semester. At 7:45 o'clock she left telling Bertha Dillon, switchboard operator, that she had to keep an engagement and that she would return before ten o'clock.

She failed to reappear at the hospital or her home, but it was not until late yesterday that alarm was felt for her safety, the girls' roommates believing she had spent the night with friends.

Their inquiries that she had mentioned a "date" started authorities on a line of investigation which revealed that several times

RADIO, SCREEN AND STAGE INDUSTRIES NEARING FUSION

ST. LOUIS, June 15.—Jesse L. Lasky, first vice-president and head of production of the Paramount Pictures-Lasky corporation, today announced elevation of six screen actors and actresses to the rating of stars, effective immediately.

The six are Gary Cooper, Richard Arlen, Nancy Carroll, Evelyn Brent, Ruth Chatterton and William Powell.

Lasky made the announcement in connection with a discussion of the new season's products at an international convention here of executives and other representatives of the Paramount corporation. He said Paramount plans to release 55 all-talking pictures for its season from August, 1929, to August, 1930, and also announced new issues of the Paramount news reels in sound.

Coincident to the opening of the convention, an arrangement whereby the Paramount corporation acquires a half interest in the Columbia broadcasting system, with 53 stations in its national hookup, was announced by Adolph Zukor, president of Paramount, and William S. Paley, president of the Columbia system, last night. The consideration was not revealed, but the announcement said the idea was to fuse three forms of entertainment—radio, screen and stage, and to add impetus to development transmission of pictures by radio.

Opening the convention today, E. E. Shaefer, New York, general manager of the foreign department of Paramount, declared that the revolutionary period in the manufacture of dialogue and sound moving pictures is just and that the industry is now well into the evolutionary era.

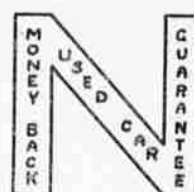

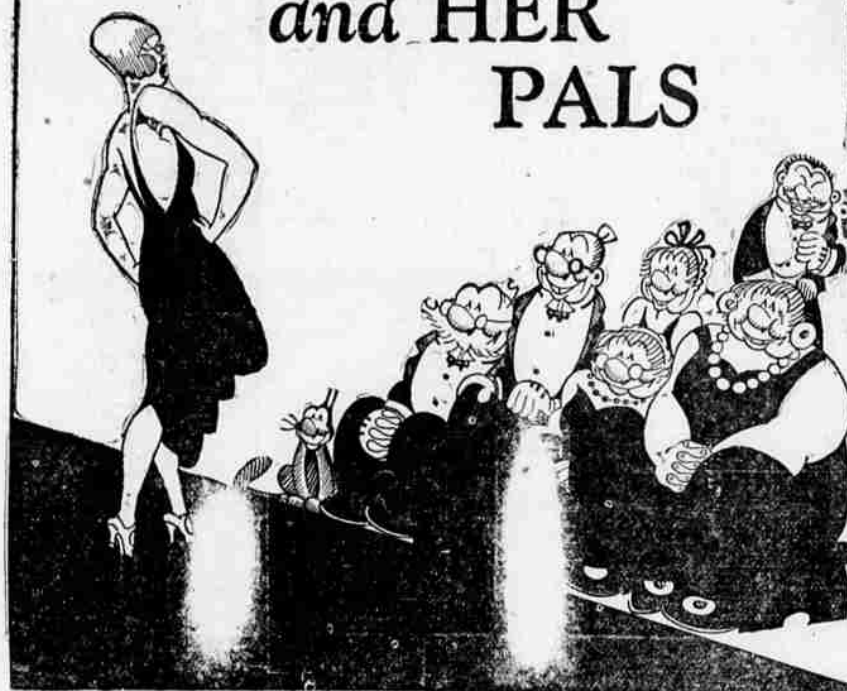
