

UMPQUA RIVER IS HIGHLY PRAISED IN LOS ANGELES TIMES

The Umpqua river territory is receiving some exceptionally fine advertising in California, and already the publicity given by Los Angeles and Pasadena papers has been reflected in the large number of residents from that locality who have been visiting the river. Joe Welsh, Jack Boaz, Major Mott and numerous other prominent sportsmen have been personally broadcasting the wonders of the Umpqua valley to their friends. Los Angeles and Pasadena papers have given a great deal of space to information regarding the Umpqua, and in a recent issue of the Los Angeles Times under large, black headlines, appeared the following article:

"Douglas county, Oregon, God's gift to the nature lover and the vacationist, extends from the crest of the Cascade mountains westward 150 miles to the Pacific ocean. It embraces the complete watershed of two rivers both of which rise in the crest of the Cascades. It is the North Umpqua in which we are most interested as a sportsman's paradise. It plunges, roaring and foaming,

through a virgin mountain wilderness.

Below Roseburg, the county seat of Douglas county, the two Umpqua join forces in their course to the ocean. The Chinook are said to be the finest of the Pacific coast. The steelhead, a game fish that takes second place to none, roams the waters from the ocean way back to the mountains, and trout! Rainbow that give you a fight for your life—how would you like to hook a twenty-pounder on a four and a half-ounce rod?

The country lying easterly from Roseburg on the proposed "Diamond Lake to the Sea Highway" is rapidly acquiring fame for its recreational, hunting and fishing facilities. For approximately sixty miles from its source near Diamond Lake the North Umpqua is an ideal fishing stream, flowing through deep canyons, foam-lashed in the rapids, perfectly clear in its quiet stretches, dark, deep, green mirroring the tall green pines which border its banks.

A road from Roseburg winds along the river to a point known as "Steamboat" within the Umpqua national forest reserve. This road passes by Circle H Lodge, where any type of accommodation may be obtained.

The lodge is extremely well situated as headquarters for hunting and fishing parties. Pack and saddle horses and splendid guides may be obtained or one may rest and absorb the wonder nature has painted with a lavish brush.

Government trails lead to all parts of the forest and mountains. Wonderful deer, cougar and bear may be had. Those who love na-

ture in her wild and untouched state will find it to their hearts' content and can be soothed by delicious food served daintily, wonderful beds, pure mountain waters, and the wonderful hospitality of Oregon's hotels and resorts.
