Mr. Lee calls attention to the fact that but two automobile clubs are licensed to operate in Oregon at the present time—the Oregon State Motor Association (A.S.M.A.) and the Union Automobile club of Los Angeles—and the solicitors for these organizations are equipped with state licenses as evidence of their bona fides and authority. He asks the motoring public to cooperate in the stamping out of this fraudulent practice by demanding to see the license of every solicitor and by reporting every suspicious case to the district attorney and sheriff of his county without delay.
