

ATHLETICS TAKE SERIES OPENER

MAYOR LOSES IN ANOTHER ROUND WITH COUNCIL

Hoover's Effort to Carry
Frew Case to Supreme
Court at His Own
Expense Fails.

Defeat Also Marks Attempt
of City's Executive to
Block Finality of
Proceedings.

The usual and expected wrangle marked last night's meeting of the city council with the situation regarding George Frew as the bone of contention. Mayor Hoover presented a statement demanding an appeal from the findings of Circuit Judge Hamilton, who in a recent decision held that warrants authorized by the council in payment to Frew were legal without the mayor's signature. Mayor Hoover offered, if the council would enter into the appeal to the supreme court, to pay the costs out of his own pocket. He agreed to post a bond to insure payment of all costs by himself.

The council, however, voted to put the mayor's statement "on the table." In placing the motion Mayor Hoover inserted the words "for further consideration," but the council immediately called him for the attempted alteration, and the motion went through as originally made.

Then a resolution was introduced instructing the city attorney to make no further appearance in the case, and this was passed.

The court action was brought by Mr. Frew, who is holding the office of street superintendent with the sanction of the council but in opposition to the mayor, to collect money for his labor, the mayor having refused to sign warrants authorized by the council.

There was no further discussion of the matter until further along in the council proceedings, when Mayor Hoover instructed the city recorder to read the resolution laid on the table at the previous meeting, the resolution instructing the city attorney to acknowledge judgment.

After considerable discussion the council ordered the resolution placed on file without action.

The mayor then came back to the matter of an appeal to the supreme court.

"I will direct the city attorney," he declared, "to prepare an appeal in this case."

The mayor's attention was called by the council to the fact that a resolution had already been passed (Continued on page 7)

EIGHT CITIES WANT YOUTH OF 21 FOR ALLEGED CRIMES

SPOKANE, Wash., Oct. 8.—The list of cities in the northwest in which Clay De Shaw, 21-year-old Oregon youth, was wanted in connection with criminal charges ranging from alleged forgery to embezzlement of an automobile, today had grown to eight in Idaho, Washington and Oregon. De Shaw, arrested here Sunday under the name of Dr. C. A. Moore, of Portland, on a forgery charge, was accused by police of criminal activities in Portland, Seattle, Tacoma, The Dalles, Ore.; Moscow, Coeur d'Alene and Lewiston, Idaho, and Dayton, Wash. When taken De Shaw claimed to be the son of a staff surgeon at St. Vincent's hospital, Portland. It was believed that he lived in La Grande, Ore.

Police here had not been notified whether the prisoner would be taken to other cities after his trial in Spokane on two charges of forgery.

SMOOTH SAILING FOR PEACE PLANS, PRESIDENT SAYS

WASHINGTON, Oct. 8.—President Hoover said today the conversations with Prime Minister Ramsay MacDonald were being carried on in an atmosphere of absolute frankness and that "neither of us has anything in reserve."

The chief executive said since there were no controversies between the United States and Great Britain to be settled at this time it was possible to carry on the talks with a prospective of the future in a broad sense.

The two, he added, were searching for those things that would promote a good feeling between the American and British peoples.

Mr. Hoover asserted that more important than the conversations themselves was the reaction of the American people and the great friendliness they had shown to the prime minister and through him to the British people.

This evidence, the president said also was more important than any conclusion that he and Mr. MacDonald might reach.

GOLD DISCOVERY IN IDAHO REGION STARTS STAMPEDE

WALLACE, Idaho, Oct. 8.—A gold rush that had all the color and glamor of the early day stampedes into the vast wilderness of the Idaho region was in progress today, over which thousands of men trekked in the earlier rush.

The announcement of an old sourdough, John Stout, one of the first to "get in" some 25 years ago, that he had discovered outcroppings which assayed more than \$2,500 per ton in gold, \$21 in silver and \$3 in copper, started the stampede to the North Fork river country, over which thousands of men trekked in the earlier rush.

DOUGLAS UNITS TO VOTE ROAD TAXES

Road districts throughout the county are preparing for their annual meetings to consider the matter of voting special taxes for road improvement work in the various sections. Several petitions for meetings have already been received by the county court, which has set November 2 as the date upon which the meetings will be held. Nearly 50 districts in the county vote special taxes each year, the law providing the method in which the meetings are held, and the money is expended under the supervision of the county court, which gives cooperation wherever possible as an encouragement to the districts willing to vote taxes upon themselves. The law requires notice to be given of the dates of the meetings for several weeks in advance, and those notices will be published in the newspapers of the county during the next few weeks.

FEDERAL O. K. FOR LITTLE RIVER PARK

The secretary of the Interior has reported to the chairman of the senate committee that there will be no objection to the passage of a bill by congress giving a tract of 160 acres on Little river to Douglas county. This tract, located in the Umpqua national forest, directly across the river from the mouth of Wolf creek, will be used as a public park, and will be named "Darryl Park," according to present plans, in honor of H. C. Darryl, who initiated the movement to secure this tract. W. C. Hawley, Oregon congressman, is working on the bill and states that he will endeavor to secure favorable action by the senate committee at the December session of congress.

Defense Attorney Fails to

One "Eye Witness" Swears
Theatre Man Held Girl
by Ankle to Check
Her Escape.

LOS ANGELES, Oct. 8.—Eunice Pringle, 17-year-old coed dancer, having completed her story of an alleged attack which she says occurred in the "cubby hole" office of Alexander Pantages, multi-millionaire theatre man, the state today prepared to introduce the testimony of its list of "eye witnesses" in Pantages' trial on a statutory charge.

W. L. Gordon, the state's first witness to the alleged attack, was to resume the witness stand today for cross-examination by defense attorneys. Gordon, who operates a women's apparel shop in the theatre building on the same floor as Pantages' suite of offices, testified yesterday that on the afternoon of August 9 he was attracted to the Pantages office on the mezzanine floor by a woman's screaming.

The witness testified he saw a girl's hand protruding from the office door, and when he pushed the door open he saw a man's hand holding the girl's ankle. He said he pushed the door farther, and the girl ran in screaming, crying and hysterical.

"What did you hear when you had the door open?" Assistant Prosecutor Robert P. Stewart asked.

"Miss Pringle was screaming 'help, save me, he's ruining me,'" the defense indicated that an attempt would be made to impeach (Continued from page 6)

S. P. EMPLOYEES OF ROSEBURG STAND HIGH IN CONTEST

O. O. Jennings, locomotive engineer, and L. F. Wagonman, locomotive fireman, are among the several railroad men of Roseburg who receive prominent mention in the current issue of the Southern Pacific Bulletin, according to J. E. Clark, local agent for the company.

SLASHING BLAZE DESTROYS SCHOOL AND THREE HOMES

HILLSBORO, Ore., Oct. 8.—A school house, gymnasium, two homes and contents, another home without contents, a barn and logging equipment were destroyed by a forest fire in the Brix Logging company slash, near here yesterday, but a heavy rain today put the blaze under control after it spread over 3,000 acres.

The Wallace schoolhouse was destroyed a few hours after children had been marched from it as the flames approached. The gymnasium was constructed near the school.

The homes of Harry McEdwards and John Tannack, with furniture and clothing, were reduced to ashes leaving the families in a near destitute condition. Pete Johnson, another farmer, succeeded in removing the furniture and clothing from his home before the flames engulfed the residence. A barn belonging to Fred Kauffman was destroyed.

The blaze is believed to have spread from a slashing fire started by the Brix company, although it is said they had been issued a permit.

CRAZED VETERAN SHOOT 2 PERSONS THEN KILLS SELF

SPOKANE, Wash., Oct. 8.—The aberration of a disease-crazed mind that impelled a former service man to violence yesterday was blamed for the death of the ex-soldier by his own hand, the critical shooting of Dr. Mitchell Langworthy, prominent northwest orthopedic surgeon and the wounding of his secretary.

John Salmi, 41-year-old World war veteran, who police said was suffering from a "persecution mania," yesterday entered Doctor Langworthy's office, shot the surgeon twice, fired one shot into the shoulder of Miss Gale Rogers, his secretary, and then shot himself in the temple, dying an hour later.

Of the six shots fired, one entered Doctor Langworthy's abdomen after shattering his arm, another grazed his temple and two went wild. Two blood transfusions were ordered for the stricken surgeon and early this morning he fell asleep. Surgeons said there were "hopes" for his recovery, but his condition was "extremely critical."

WRIGLEY FIELD, Chicago, Oct. 8.—Howard Ehmkke, veteran right hander of the Athletics, justified his expected selection today for the opening game of the World's Series by beating the Chicago Cubs, 3 to 1, and smashing all series records by striking out thirteen men before a crowd estimated at 50,000.

The first score of the game for either side was the home run in the seventh inning of Jimmy Foxx. Athletic first baseman. The next two runs of the Mackmen came in the ninth on two successive errors by the Cubs' shortstop, Woody English, and Bing Miller's single.

Kiki Cuyler, fastest base runner in the National league, scored his team's only run in the ninth inning, when he went to first and second on an infield hit that Dykes stopped but followed with a wild throw to first base. He later scored on successive singles by Stephenson and Grimm.

STRIKE TIES UP \$6,000,000 WORTH OF PERISHABLE GOODS

NEW YORK, Oct. 8.—The metropolitan area cut off from its supply of fresh vegetables and fruits today by a rail embargo while market truckmen and their employers strove to settle the strike which has closed terminals with \$6,000,000 worth of perishable produce.

Threatened by a blockade in their freight yards where 2,000 cars of produce have accumulated since the strike was called Saturday night, the New York Central, Pennsylvania, Central railroad of New Jersey, Lehigh Valley, Delaware, Lackawanna and Western and the Erie railroad put the embargo into effect at midnight.

Agents throughout the country were instructed not to accept shipments of perishable produce consigned to New York until further notice. Shipments enroute east of Chicago were ordered directed to Boston, Philadelphia or back to Chicago. Goods in transit west of Chicago were sidetracked to be returned to the shippers.

DOUGLAS PRUNES SOLICITED TO TRY FOR SWEEPSTAKES

A very determined effort is being made by County Agent J. C. Leedy and C. O. Garrett to secure a large display of high quality prunes for the county exhibit at the Pacific International exhibition. In the last years Douglas county prunes have taken first prize in all departments in which they were entered, and this year it is hoped to be able to secure a large enough exhibit to take every prize prize offered. Heretofore, exhibits have not been large enough to take the sweepstakes, because exhibits must consist of 250-pound boxes to enter. Prizes range from \$15 to \$25 for prunes. Mr. Leedy and Mr. Garrett are anxious to communicate with the growers who are willing to cooperate in this exhibit. They will arrange for transportation of the prunes, and for the sale of the fruit following the exposition.
