THE city of Medford, where these words are written, has to its credit two interesting enterprises—one of them a practically completed achievement and the other an undertaking that is still in the experimental stages.

The completed achievement is its airport, which is by long odds the finest in Oregon and of which more will be said in a succeeding article in this column.

The experimental undertaking is an effort to weld together in one effective body all the various civic organizations of the city.

THIS super-organization is known as the Central Civic Council. It is an actual completed entity, but it has not been in existence long enough to be judged accurately as yet on the basis of results.

If determination to achieve results, however, counts for anything, this new Central Civic Council of Medford will give a good account of itself.

ON this new organization, which is sponsored by the chamber of commerce, all the service clubs and all the numerous organizations of the city having for their purpose the advancement of the public welfare will have representation.

It will seek concentration of civic effort, as opposed to the diffusion which has been the marked result of the condition of over-organization that has been so apparent in nearly all American cities in recent years.

It will try to weave together in one strand the efforts of large numbers of public-spirited citizens.

THIS intelligent, thoughtful plan to cure an evil that is present in nearly all American communities at the present time is characteristic of the spirit of the new Medford that has arisen out of the confusion and the disillusionment that followed the wild boom of a couple of decades ago.

The Medford of today is up and coming. It has its eye on the future, and what it sees for itself in the future is a pleasing vision. If there are obstacles in the way of realization of this vision, the new Medford is firmly determined to remove them.

Hence this movement to prevent the scattering of effort through over-organization.

OTHER Oregon cities, which face this same problem, will watch what is being done in Medford. If its results are good, they will follow in Medford's footsteps.

THE people of this new Medford have courage. They realized a couple of years ago that their water supply was not what it should be, so they set out to get what they wanted. Their first step was to vote a bond issue of a million dollars.

With this money they brought water from a huge mountain spring 32 miles away—water that never sees the light of day from the time it bubbles up in the spring until it comes out of the tap in the city.

It is so pure at the source and is kept so free from contamination in delivery that it needs no filtering. Even in midsummer it comes from the tap at a temperature of about 44 degrees.

If you read the report of the state superintendent of banks yesterday, you noted that Medford was NOT one of the cities showing a loss in deposits over last year.

One reason for this fact is the \$5,000,000 pear crop which has just been harvested and is selling at top prices on the markets of the big Eastern cities.

A crop of that size certainly helps in keeping up a city's bank balances.

THIS \$5,000,000 pear crop was harvested this year from about 11,000 acres of bearing orchards. It is estimated that there are 50,000 acres of land capable of cultivation in the Rogue River valley, tributary to Medford.

The pear growers of the Rogue River valley are going thoughtfully about the business of expanding the markets for their product, so that in time it will be safe to plant an increasing portion of this area to bear orchards.

NEW YORK, at present, is the big market for Rogue River valley pears.

VETS' PROGRAM ASSURES LIVELY ARMISTICE DAY

Street Stunts, Parade and Venison Barbecue Are Listed—Football in Afternoon.

Justice Coshaw Will Speak, Two Bands to Be Heard; Machine Gun Unit Will Exhibit.

Umpqua post of the American Legion is hard at work preparing for a big Armistice day celebration to be held Monday, November 11. The program will provide plenty of amusement and entertainment for everyone, whether members of the Legion or not, as practically all of the events will be put on for the general public.

The big feed at noon is for veterans only, but is open to every World war veteran whether a member of the American Legion or not, and every ex-serviceman is urged to be present as a guest of the local post. The feed is to be in the nature of a venison barbecue. Seven big bucks, killed by Legionnaires, have been in storage since the hunting season and are to be barbecued for the big feed, which is being arranged by Ted Post with the help of a large group of assistants. Venison, with all the trimmings, will be provided in generous quantities, together with plenty of other eatables.

In the event of good weather the feed will be served army style at Finlay field. But if the weather is not good the veterans will be fed at the armory.

Stunts and Parade starts with street stunts at 9 o'clock, with contests provided for boys, girls and Legionnaires. Some unique and clever stunts have been arranged for that part of the celebration, the chariot race, dog races, driver race and other such (Continued on page 4)

FUGITIVE BATTLES THREE POLICEMEN: 2 DEATHS RESULT

WINCHESTER, Ky., Nov. 8.—A gun fight between three members of the Winchester police department and man whom they had been called to arrest resulted in the fatal shooting of two men here late yesterday.

Patrolman P. Lloyd Faulkner, 65, died an hour after he was taken to a hospital, and Mike Wills, 52, former railroad contractor, who battled the officers, succumbed shortly after he fell pierced by nine bullets.

The fight, in which nearly a score of bullets were fired, followed an automobile chase. The officers were called to a pool room, where it was reported Wills had been causing a disturbance. He had driven away when they arrived.

Near the city limits the officers overtook Wills, who leaped out of his car as the police machine drove alongside, and with an oath and an exclamation, "You've followed me far enough," opened fire. Faulkner fell as he stepped from the rear seat, pierced by a single bullet.

Wills was shot down by Chief of Police Sid Bush and Patrolman Mal Talley, both on the front seat.

ROBBER SUSPECT AND OFFICER DIE IN PISTOL BATTLE

SHAWNEE, Okla., Nov. 8.—Death of an alleged bank robber to "shoot it out" rather than face a possible death sentence in court had resulted today in his own death and that of one of two officers with whom he waged a short but bloody gun battle.

Robbery with firearms is a capital offense in Oklahoma. Courts have inflicted life terms recently for minor robberies of that character and police had heard that Owen Edwards, sought for complicity in bank holdups at Prague, Kendrick and Minero, Okla., had threatened to die shooting rather than face an end in the electric chair.

James A. Kiersey, 39, veteran assistant chief of police of Seminole, Okla., entered a house at Harjo, Okla., where Edwards was hiding, and ordered the fugitive to put up his hands.

Edwards replied with bullets and Kiersey fell, mortally wounded by three shots from two automatic pistols. Claude Tyler, operative of the state bureau of criminal investigation and identification, fired from a doorway behind Kiersey and Edwards dropped. He died almost instantly.

THAW PADDLE BALM REDUCED TO \$25,000

Justice Levy States "Deterrent" Needed to Slash in Amount Would Have Been More

NEW YORK, Nov. 8.—The \$75,000 verdict awarded by a jury to Marcela Estardis, night club hostess, in her \$100,000 suit for mistreatment against Harry K. Thaw was reduced today to \$25,000 by Supreme Court Justice Aaron J. Levy.

The verdict was returned two weeks ago after second trial of the suit in which the girl charged that Thaw had bitten her and paddled her with a hairbrush at a New Year's day party in his apartment in 1927.

The jury disagreed at the first trial but returned a verdict after 55 minutes of deliberation in the second hearing of the case. The lawsuit was another of the many episodes that have kept the former husband of Evelyn Nesbit in the limelight since he shot and killed Stanford White, noted American architect, in old Madison Square Garden in 1906.

Justice Levy had under consideration a motion by Thaw's attorney to set aside the verdict, and announced he would grant the motion unless the girl, whose real name is May G. O'Neill, would take \$25,000. Her counsel said he felt confident she would take the smaller sum.

Thomas A. McGrath, Thaw's lawyer, announced after Justice Levy's ruling that he still intended to appeal.

"I am frank in telling you," Justice Levy said in reducing the award, "that if it were not for the clear manifestation of the jury that this man must be punished as a deterrent, I would have reduced the verdict much more. I think, however, that the element of the deterrent must be considered."

After the slaying of White, Thaw was found insane and placed in an asylum from which he escaped to Pennsylvania, where he was later adjudged sane.

ARISTOCRATS OF TURKEYDOM TO VIE FOR PRIZES

Northwestern Exhibit Will Be Staged by Breeders' Assn. at Oakland on December 13-14.

Missouri Expert Will Act as Judge—Awards for Winners Come From Four Counties.

The Northwestern turkey show, sponsored by the newly formed turkey breeders' association, is to be held at Oakland, December 13 and 14, and is attracting a great deal of attention. Hundreds of dollars worth of prizes are being offered so that there will be ample awards to attract all exhibitors. The prize committee has arranged the prizes in a manner that will give the greatest number of exhibitors chances to win one or more. Trade journals have been particularly interested and a great many subscriptions are being offered in connection with the numerous other prizes.

The association put the site for the show up to the people of both Roseburg and Oakland, but Roseburg withdrew in favor of Oakland for the first show, and will probably bid for the next exhibit.

A. D. Walker, of Memphis, Missouri, has been secured as judge. He has national reputation in this line and his work is of high quality. He has officiated at practically all of the national shows in recent years and this year his assignments include the following: St. Louis, Chicago, International, St. Louis, National, Denver National, Boise National, Madison Square Garden, N. Y., "All World," Dallas, Texas, and "All American," Grand Forks, North Dakota, in addition to the Northwestern turkey show at Oakland.

Program Features
In connection with the show an annual banquet is to be held on Friday evening, December 13, at 6:30 o'clock, at which time a show program is being arranged. Turkey growers and others interested are being urged to make early reservations.

The educational program in connection with the show is in charge of H. E. Crosby, extension poultryman of Oregon State college.

A turkey calling contest is another feature being arranged and will take place in the afternoon of the first day. Winners will repeat their calls the banquet in (Continued on page 5)

INSULT DICKERING FOR HOLDINGS OF FOSHAY COMPANY

MINNEAPOLIS, Nov. 8.—The Journal today said it had learned from reputable financial circles that the insult public utilities interests of Chicago had started preliminary negotiations for the purchase of the W. R. Foshay company properties, which went into receivership last week.

The Journal understands the projected deal would involve all or a majority of the properties owned by the Public Utilities Consolidated corporation, a subsidiary of the Foshay company.

It was considered unlikely, however, the Journal said, that any transaction involving sale of the properties would reach the final stage until completion of the inventory work on which has been started by Joseph Chapman, receiver.

Valuation of the Foshay company properties has been estimated to be in the neighborhood of \$20,000,000 or more.

The company operated utilities throughout the United States, Canada, Alaska and Central America.

TEXAS YOUTH AGAIN SENTENCED TO HANG

EASTLAND, Tex., Nov. 8.—Clayde Thompson today was assessed the death penalty for the second time by a jury here for the slaying of Lucian Shook near the latter's oil field home at Leroy, Texas, in September, 1928.

Thompson was accused of slaying Leon and Lucien Shook, oil field workers, in September of 1928. The state contends he was 18 years old at the time, while defense witnesses declared he was 17. A companion of Thompson said he killed the brothers "just to see them kick." He once was sentenced to execution for the killings but was saved from the electric chair by an order granting a new trial.

FIRST TURKEYS IN OF HIGH QUALITY

Maturity of Fowls Better Than Anticipated and Agent of Buyers Well Pleased

Exceptional quality marked receipts for the first Douglas county turkey pool today, the birds far exceeding expectations in weight and development. Owing to unusually warm fall weather turkeys generally have not started to fatten, but growers found upon examination that the hens were further matured than they had anticipated, so that buyers are well pleased with the birds killed for the early Thanksgiving shipment. Only a small portion of the birds are being killed, however, so that the pool will consist of only four or five carloads.

Birds received at Roseburg are being taken by G. N. Savage and company of New York, and Swift and company are taking the turkeys on consignment basis, paying 32 cents advance net to the grower on fancy hens and toms, and 29 cents for No. 1. Practically all of the birds received at Oakland were in the two top grades.

Charles F. Lucas, of Seattle, Washington, arrived in Roseburg last night to act as inspector for the New York company. The association is doing its own grading, and the representative of the New York company expressed himself as being well pleased with the manner in which the association upheld quality standards.

Birds will be received at Yoncalla and Eugene tomorrow.

LOCAL COMMUNITY CHEST DRIVE OPENS NEXT WEDNESDAY

Definite arrangements for Roseburg's annual community chest drive were completed by the committee last night. Noble R. Goetz was named general chairman, and is today organizing his soliciting committees which will start their drive on Wednesday of next week. The budget for 1930 is the same as last year, \$6,000, and the distribution is practically the same, except for two minor changes. The community chest system of local charity and support for important municipal organizations has proven very successful during the several years that the plan has been followed, and little difficulty is expected in the effort to raise the needed funds.

Distribution of the 1930 budget is planned as follows: Juvenile home \$200, Louise home \$200, Roseburg municipal band \$600, administration \$500, boy scouts \$2,500, local relief \$1,000, Campfire girls \$500, child farm \$200. The budget eliminates an item for the boys' band, formerly carried, and increases assistance for the Campfire girls.

Soliciting committees will canvass the entire business district and also the residential section starting Wednesday of next week and continuing until the budget has been raised or all residents solicited. The community chest system, eliminating solicitations by the various organizations throughout the year, and gives a systematic means of distribution of funds to needy cases. The budget is figured on the lowest possible basis, and it is important that the full quota be subscribed.

LAWRENCE E. ADAMS DIES OF PNEUMONIA

SENATOR MOSES GETS PERSONAL AND STIRS FOES

New Hampshire Solon Said to Have Labeled Group of Independents as "Jassasses Sons."

Senator Wheeler, Montana, Answers That Note of Remark Will Come Next Election.

WASHINGTON, Nov. 8.—The term "sons of wild jassasses," a remark attributed to Senator Moses, republican, New Hampshire, in referring to the republican independent group of senators was assailed in the senate today by Senator Wheeler, democrat, Montana, who said constituents of the group would resent such statements and would take note of them in the next election.

Moses was quoted as having made the remark at dinner for New Englanders here last night. Continuing Wheeler said Senator Reed, republican, Pennsylvania, had described the western group as "worse than communists."

"These statements," said the Montana addresser himself, "to the republican independents, not only reflect upon you but they reflect upon your fathers and your mothers."

He cautioned the western group to remember those statements when they go out to campaign for the republican party in the next elections.

Moses Draws Replies
Senator Brookhart, a republican independent of Iowa, narrator of the story of the 1928 "Wall Street Rooster" in Washington, said it was apparent that the republican regulars did not need "house at these dinners to rise to the highest pinnacle of eloquence."

Referring to Moses, Wheeler with a smile said "there is no telling what he would have said if the dinner had not been dry."

Senator Heflin, democrat, Alabama, observed that perhaps the remarks of the New Hampshire senator were inspired by the Biblical idea that "the ox knoweth his owner and the ass his master's crib."

Wheeler suggested an interpretation by the president officer, Senator Moses was smiling. He asked with a smile if Wheeler were propounding a parliamentary question. Answering his own question, Moses said:

"If the senator from Montana will find a more appropriate appellation (Continued on page 6)

CHARGE OF WIFE MURDER AWAITING WALTER C. VOGES

PORTLAND, Ore., Nov. 8.—Walter C. Voges, the 25-year-old longshoreman, who with two vicious assaults of a razor killed his estranged wife, Mrs. Mary Voges, 22, and attempted to end his life by slashing his throat, realized fully today that he would recover to face a charge of first degree murder.

Inmate jealousy, police said yesterday, caused Voges to slay his wife in her apartment after she is said to have received a former husband, and father of her child. Voges, a friend said, remarked that "someone would see blood if I see any more men around here."

Physicians informed the district attorney today that Voges' injuries were superficial and that he would recover. A murder charge was placed against him and a police guard over the hospital where he lay was doubled.

Voges, fully conscious, refused to discuss the crime until he had talked with an attorney.

"I can't remember it all. I tell you I can't remember it all. Why say anything?" he would only blacken his character," he continually remarked.

WARREN BILLINGS ASKS FOR PARDON

Petition of Alleged Accomplice of Mooney Backed by Former Officials and 3 Jurors

SAN FRANCISCO, Nov. 8.—A petition by Warren K. Billings, asking permission to appeal to Governor C. C. Young for a pardon, was on file in the state supreme court today. Billings was convicted of a felony must obtain the permission of the supreme court before he may seek executive clemency.

With the petition were offered letters signed by Duncan Matheson, former captain of detectives here; District Attorney Matthew A. Brady, and three of the jurors who convicted Billings.

Brady's letter contended that there had not been sufficient evidence to convict Billings. The letter of the three jurors, William Thomas Baker, Edward T. Franks and John T. Adeock, asserted they had based their verdict on the testimony of Estelle Smith and John McDonald and they now "doubt the veracity of the testimony."

Mooney's petition for a pardon has been under consideration by Governor Young for several months. The governor declared the pardon made by him would assist him in his consideration of the Mooney case.

LYSTUL-LAWSON LUMBER CO. WILL BUILD NEW MILL

GLENDAL, Nov. 8.—(Special to News-Review)—The Lystul-Lawson Lumber Company has decided to rebuild. Actual construction of a new sawmill on the site of the one destroyed by fire September 4 last will soon be under way. Tentative plans for a sawmill with an eight-hour cutting capacity of about 40 thousand feet are being considered. These provide for a plant that will be efficient and economical to operate and which will embody a number of ideas taken from some of the more modernized coast mills.

Shortly after the fire in September we opened negotiations with several parties for the sale of our sawmill property here," said John O. Lystul, a member of the company, "but as they wanted to pay us but a small fraction of the actual worth of our holdings, no sale was made. As we already have our own logging equipment and railroad and as there is much that can be salvaged at the mill site, it was decided to rebuild."

The September fire, which was of unknown origin, destroyed the company's entire plant, consisting of sawmill, planing mill, block, smith shop, tool shed and docks, together with considerable lumber.

The company owns an excellent mill site just east of this city also a complete logging equipment, railroad tracks, and considerable timber of high grade quality.

COMPANY BEGAN IN 1919

The Lystul-Lawson Lumber company was organized in 1919 to operate the Pe-Pine Lumber company's sawmill under a lease, buying the logs from the owner. In 1922 the Lystul-Lawson Lumber company purchased the property. Numerous extensions and improvements were made from time to time both in the mill equipment and woods and a number of improvements made just shortly before being burned.

The officers and principal stockholders are: John O. Lystul, president; J. H. Lystul, vice president; J. H. Lystul, secretary; J. H. Lystul, treasurer; J. H. Lystul, general manager.

ALLEGED CATTLE RUSTLERS JAILED

They were arrested late yesterday on a road leading into Portland in a truck which carried a live cow, three skunking knives, a hatchet, two sharpening steels, an oil can, a saw, one loaded rifle, one loaded pistol and a pair of rubber boots.

DYNAMITE BLAST KILLS FIVE MEN

WORCESTER, Mass., Nov. 8.—Five workmen were killed in a premature explosion of 80 pounds of dynamite in a shaft of the Melroe granite water development at Colbrook early today.

The men were blown to pieces and several hours later the parts of the bodies had not been recovered.

PROPOSED LEVY FOR 1930 FIXED AT 16.3 MILLS

Douglas County and State Expense Requirements Increased \$27,000 Over This Year.

Estimate for 1929 Was Too Low by \$15,000—Two Elections Coming Take \$4,000.

The tentative county budget for 1930, completed by the county court and budget committee today, calls for an increase of \$27,000 in total expenditures, increasing the tax levy from 15 1/2 to 16.3 mills. Last year's budget totaled \$515,826, while the proposed budget for 1930 totals \$542,824.

Last year's budget proved to be \$15,000 short of meeting actual expenditures, so that it is necessary in making up the new schedule of expense to include funds to take care of the existing deficit. Two elections are to be held next year, which results in a further increase of \$4,000. Autos are to be purchased for the sheriff and county agent, for which the budget committee provides \$2,000, it being the plan to trade in the old cars as part of the purchase price. County care for widows and indigents, as well as indigent veterans, makes necessary an increase of \$4,500 for the two purposes. An addition of \$2,000 is carried for courthouse expense, and it is necessary to provide another janitor and more fuel and lights. The budget, however, eliminates the former items of office rentals, as all county officers are now in the new building.

Office Reductions

The various officers, have cut down their growing budget considerably. Sheriff Jackson and County Clerk Ayers are each eliminating a deputy, lowering the sheriff's budget \$760 and the clerk's budget \$270. They provide for extra clerk hire, but will use only what portion of the fund is actually needed. The treasurer's budget was cut \$354 and the assessor's \$525. The county court cut its budget \$250, but the county school superintendent added \$365. The budget for county ferries was reduced \$990, which was made possible by the elimination of the Scottsburg and Smith ferries. It was found necessary, however, to include \$2100 for the Goodferry ferry.

The budget committee provided \$25,000 for the county budget fund, instead of \$22,000 as raised last year, but is taking the increase out of the motor license receipts, instead of from the tax income. (Continued on page 6)

TURKEY MARKET STILL UNSETTLED

(O. S. C. Market Bureau)
CORVALLIS, Nov. 8.—(Special to the News-Review).—The San Francisco market reports an ample supply of live turkeys with the market unsettled. Dealers are operating conservatively. Live young toms selling at 22 cents and dressed toms at 34 to 40 cents. The Portland live turkey supply is liberal and dealers are buying slowly, generally paying 20 to 22 cents. The supply of dressed birds is shorter and dealers are buying faster, paying 22 to 23 cents and are buying 20 cents for fowls 2 to 6 pounds.

Texas turkeys alive at dresshouse are bringing 20 and 22 cents at Portland. 20 and 21 cents for hens and young toms in San Antonio district. Old toms 5 cents less. No. 2 made 10 cents less. Trading not yet active.
