American Women Defy Long-Skirt Edict of Paris

PARIS, Jan. 29.—There were standing room only available today in the salons where summer styles in women's clothes are being shown. The courtiers themselves were amazed at the crowds which came to their show and were prepared for the tremendous increase in the number of buyers and writers demanding a first peek at the new collection. There never have been so many gatecrashers dealt with as at the present show, and never so many creditless turned away.
Style makers are just realizing that this spring may be the turning point in Parisian style domination of America where the inherent movement against lengthening of the skirts and the rise de la Paix clothes psychology has been expressed in the anti-Paris style move organized in the women's clubs.
But thus far without exception the courtiers stand pat on the long skirt issue. Their answer to American women's protest has been to add a few more inches to the length of even sport clothes. Attention dresses are decidedly longer, midway between the top of the calf and the ankle, while evening dresses are ankle length or barely clearing the floor.
Some of the longest gowns have not yet been in the style but the fight will continue until February 6 when the last of the buyers have been convinced there will be no appeal from the long skirt edict. American women just may make up their minds to take them or leave them.
CHICAGO, Jan. 29.—Lawrence N. Heppner, first vice-president of the national association of merchant tailors, figures that between \$5,000 and \$10,000 is enough to keep the dressed man well dressed for a year. The association is holding its annual convention here.
Clothes for spring, Heppner said, will be wide-shoulder, narrow-waisted and with fairly wide trousers.

PROGRESS MADE IN OPENING WEEK OF NAVAL CONFERENCE
Understanding Reached at Private Confs. Paving Way to Agreement at Plenary Session.

LONDON, Jan. 29.—With a continued round-robin of private conferences and consultations, the national delegations to the five-power naval conference today made extensive preparations for tomorrow's important open plenary session at St. James palace. Out of all these scattered meetings there came continuing assurances of a progress although all delegations were extremely cautious about disclosing details. A consensus of statements from the five delegation headquarters indicated that in the week since the conference convened the following seemed today to have been or about to be accomplished.
First, and of primary importance, the British and French have approached a compromise combining the global and categorical methods of measuring tonnage so that each nation will be allotted a total tonnage which she may distribute among the various classes of ships. This will be discussed at tomorrow's plenary sessions with prospects of general acceptance.
Second, France and Italy temporarily have suspended their disagreement over the Italian claim to a navy as large as the French but with the understanding the Italian delegation will have an opportunity tomorrow to expend further her thesis of parity.
Third, the Americans, remaining aloof from these difficulties, have made substantial progress with their efforts to have cruisers considered first when ship classes are finally taken up.
Fourth, under American leadership the conference has determined to throw open all its plenary sessions to the press of the world.
Perhaps to this list should be added the general accomplishment of having brought the conference through its initial week without an important diplomatic encounter save only the Franco-Italian disagreement over parity.
Barriers Disappear
Especially in recent weeks the conference powers have realized it would be easy to stir sensitive national emotions at the very outset by muddying the waters of international conciliation. The Americans and British, following the behest of President Hoover and Premier MacDonald, particularly have been careful to avoid such a development.
In pursuance of a plan of caution the three-cornered cruiser problem has been kept in the background by the Americans, British, and Japanese. Great Britain and France appear to be adjusting quietly their differences over global tonnage and other subjects which a month ago seemed a serious barrier to agreement.
Italy's claim to parity with any other continental power and France's opposition to that premise alone have broken the bounds of the private conference room and approached public controversy. Even that today seemed quieted for a moment although one in the informed circles dreamed it had been settled.
LONDON, Jan. 29.—Drafting of a humanitarian code for the conduct of sea warfare, with particular reference to submarines, was under consideration today as one of the possible tasks of the naval conference.
As conversations between the national delegations proceeded in preparation for tomorrow's plenary sessions it was disclosed there was a strong disposition in some quarters to include discussion of immunizing naval warfare in the conference agenda.
Reference of Colonel Henry L. Stimson, American secretary of state and delegation head, in his radio address last night to the United States to this subject attracted wide attention. Colonel Stimson said that if abolition of the submarine was impossible the United States hoped to restrict its use. It was understood the French would like to go even further and draft a code covering other types of warships.
There was no expectation in informed circles that the abolition of submarines would be possible or that any code of sea conduct broad enough to deal comprehensively with the old question of "freedom of the seas" could be adopted.
Nevertheless some of the delegates saw a likelihood of important new precepts on the use of naval vessels being written into international law at the present conference. The Americans were unwilling to enlarge upon what the secretary of state said in his radio address.
The meeting of Umpqua chapter of the officers reserve corps last night. The officers took an examination on military correspondence, which they have been studying for several months.
