

LOW PRODUCTION COST REAL BASIS OF PROFIT BOOST

Expense Cutting Equipment Used by Farmers Boon to Them, Exchange Head States.

Many folks when they think of making more money think of higher prices, according to U. E. Hamilton, manager of the Douglas County Farm Bureau Exchange...

The only question then is to get the cost of production below the selling price, which will let enough people buy to make a ready market, Mr. Hamilton declares.

Examples Cited "Cold figures," he states, "show a power cost of 36 cents for tractors against \$1.00 for horses, a saving of 14 cents on a basis of 500 acres harvesting costs were \$1.41 for binder and thrasher, \$2.44 for loader and thrasher, \$2.18 for combine per acre. Of course, these figures vary according to localities, but the proportion of saving remains about the same.

"A power corn picker cut hauling costs 8 to 9 cents per bushel for Harris and Chaney at Myrtle Creek last year. "A hired combine cut harvesting cost in half for Huron Clough at Canyonville.

"A more powerful tractor cut cultivation costs from 31 cents an acre to 25 cents in the Busenbach orchard at Melrose.

"An Iowa farmer lowered his plowing and harrowing cost from \$3.50 per acre with horses to \$2.05 with a 3-plow tractor and \$1.31 with a 3-plow tractor.

"An Illinois corn grower reduced corn growing costs from 45 cents to 26 cents per bushel by changing to power machinery.

"A New Hampshire potato grower raised 11,000 bushels of certified potatoes at a cost of less than 50 cents per bushel with power equipment.
