Editorials on the Day's News

"HOW much money is spent annually by tourists in California?" There are many answers to that question, and they vary widely.

Judge Parker Rejected by Senate

OPPOSITION TRIUMPH BY 41-39 VOTE

Protests of Labor Unions and Negroes Effective in Prevention of Confirmation.

Supreme Court Seat Still Open to Appointment; Oregon Solons on Negative Side.

WASHINGTON, May 7.—The senate today rejected John J. Parker as an associate justice of the supreme court.

The vote was 41 to 39. The North Carolina judge missed confirmation after ten days of debate centering on his attitude toward organized labor and the negro.

It is the first supreme court nomination to be rejected since 1894.

The senate's decision leaves vacant the seat of the late Justice Edwin T. Sanford.

ROSEBURG DUE FOR AIR FREIGHT QUIZ

The possibilities of an Oregon air service, connecting all of the major points of the state with the through air transport and mail lines, is being investigated by the United Airways, Inc., of Portland, according to information received by the Roseburg Chamber of Commerce.

The local chamber has been requested to circulate petitions among the business men of the city to determine whether or not there is sufficient local interest here to warrant the establishment of the mail route. This first survey, if successful, will be followed by a more detailed investigation in an effort to secure an estimate of possible freight and mail tonnage from each place.

The cities which it is proposed to serve include Portland, Silverton, Salem, Albany, Corvallis, Eugene, Roseburg, Medford, Ashland, Klamath Falls, Lakeview, Hood River, Baker, The Dalles, Pendleton, La Grande, Ontario, Coos Bay, Bend and Burns. The petitions have been very liberally signed here, and local business men state that they would be able to supply a great deal of business to an air line.

FILIPINOS RAIDED BY NIGHT RIDERS

SEATTLE, May 7.—State highway patrolmen and sheriff's deputies will be assigned to prevent a recurrence tonight of demonstrations against Filipino laborers in the White river valley, near here, Captain Owen McGill and Sheriff Claude G. Bannick announced today.

Filipinos, driven from their bunk house by white raiders last night were unharmed but nervous today. Many of the Filipinos were reported by Captain McGill to have been kidnapped in their night clothing, carried in automobiles for several miles and liberated with a warning to stay away from the produce ranches on which they had been working.

The disturbance was said to have resulted from the replacement of whites by Filipino laborers, who were willing to work for half the wages paid the white men.

Sheriff Bannick expressed the opinion that the trouble was over, but added that patrol of deputies should be ready if anything happens. Captain McGill said he would assign every available man in his command to patrol the roads in the valley.

McGill said the raiders apparently were well organized and knew highway patrolmen on the jump by putting in a lot of fictitious alarms.

LUMBERMEN ASK DEATH OF TARIFF BILL

Passage Opposed If Items Providing for Duty on Imported Wood Are Not Restored.

Telegrams to Delegations in Congress Say U. S. Labor and Industry Need Protection.

PORTLAND, Ore., May 7.—Congressional delegations of Oregon, Washington and Montana today received a message signed by thirty-eight Pacific northwest logging and lumber firms demanding that they join in accomplishing the defeat of the tariff measure if items for the protection of the lumber industry are not restored to the bill.

The message, which followed the defeat of duties on lumber and shingles in the house of representatives, stated that the lumbermen regarded the present status of the tariff controversy as conclusive evidence that there was a "total disregard of western interests by representatives in congress from the east."

Another section of the lengthy telegram sent last night after a conference between representatives of the thirty-eight concerns, stated that the lumber tariff "is being used as a political football."

In still another section the telegram stated: "On account of the Russian and Canadian lumbermen using the United States for their dumping ground for surplus products, there is now a 25 per cent unemployment in this industry and unless there is early relief this unemployment may be increased to 50 per cent."

The lumbermen, who said the burden of this would be laid directly at the door of the representatives in congress, contended the idea that the northwest senators and representatives should remain regular in supporting a tariff which is said to have failed to provide for the prosperity of "the basic industry of the Pacific northwest."

AGITATORS BLAMED FOR SCHOOL RUMPU

BISHOP CANNON TO FACE FIVE CHARGES

DALLAS, Tex., May 7.—A reported contemplated attack on Bishop James Cannon, Jr., of Virginia, lent an early controversial hue today to the opening of the quadrennial conference, Methodist Episcopal Church, South, here.

The charges, expected to be brought by a member of the Georgia delegation, will deal specifically with Bishop Cannon's participation in politics, according to general reports current among delegates. The bishop has refused to discuss the charges, or to comment on the testimony given in Washington yesterday before the congressional lobby committee.

In this testimony, E. C. Jameson, of New York, prominent in republican affairs, testified as to an alleged discrepancy in a fund he gave Bishop Cannon for the fight against Alfred E. Smith in the last presidential race.

It was learned that five general charges have been prepared as a basis for the effort at prosecution of Bishop Cannon—that he has been an active lobbyist; that he has used the Methodist board of temperance and social service, of which he is head, in his lobbying; that he hoarded food during the World war; that he had dealings with a Wall street "bucket shop"; and finally, that in 1928 Bishop Cannon, through his attorney, Warren A. Chandler, of Atlanta and Bishop Collins Denny charged that Bishop Cannon had endeavored to form a religious-political combination which might precipitate a split within the church.

ANCIENT CITY FILLED WITH DEVOUT HOST

A first glimpse of the splendor of the occasion was had this morning when Cardinal Lepicier, the papal delegate, with a retinue of high ecclesiastical attendants, went to pay his respects to the buy of Tunis.

Eleven more great ships arrived at Tunis, bearing their quotas of pilgrims. Among them was the Aracelis with a large party of Americans.

When these delegations, among the last to come, had completed their journey, the scene was prepared for the formal opening of the world-wide congress at which Cardinal Lepicier will read the papal bull.

JACKSONVILLE, Fla., May 7.—Dr. Lincoln McConnell, former policeman, who turned author, lecturer and minister, finally becoming pastor of many leading Baptist churches in the south and southwest, died of a heart attack yesterday. He was 60 years of age.
