WHEN your grandmother went shopping, she had your grandfather hitch up the horses to the family carriage. Then they drove leisurely down town, bought what they wanted, loaded it into the carriage and came home.

If they happened to live several miles from town, "doing their trading" took all day.

WHEN you do your shopping, you get into your car, step on a button, the starter whirs until the engine takes hold, and you then drive out of the garage and down to the store.

Then you load your purchases into your car and come home.

ESSENTIALLY, it is the same process your grandmother followed, except that it is all greatly speeded. It makes little difference whether you live three miles or 30 miles from the store—except that if you live only three miles away you may spend more time hunting a place to park than you spend in driving back and forth.

More distance has been pretty effectively annihilated in these days.

HERE, the business engineers tell us, is the way your DAUGHTER will do her shopping:

Some time in the late evening, after business has closed for the day, she will take down the receiver of her telephone, call the store she wants, and a mechanical voice—not a human voice—will answer: "This is such and such a store. What is it you want?"

She will then dictate her order over the telephone, and a mechanical recording device will take it down and file it away.

EARLY the next morning—very much earlier than people now ordinarily go to work—these orders which have accumulated during the night will be transcribed from the recording device, put up in neat delivery boxes and delivered to the customers who ordered them over the telephone the night before.

The business engineers assert quite positively that by this process efficiency will be increased and costs will be cut.

IF you are a man, and feel the urge to smoke, you stroll into a tobacco store, pick out the cigar, or the brand of cigarettes, or the package of tobacco you fancy and say to the clerk behind the counter: "I'll have this one."

Whereupon he hands it to you, you pay for it, pass a remark as to state of the weather or who won the wrestling match last night, and go on your way.

HERE is what the business engineers are beginning to tell us of the tobacco store of the future:

It will have no counters and no clerks. It will have only large numbers of vending machines, each displaying a particular brand.

You will make your choice, drop a coin in a slot, the machine will deliver to you what you want, make your change, and in a mechanical voice will say: "Thank you; come again," or some similar phrase of set courtesy.

ONE man, we are told, will own many of these mechanized shops, and instead of standing behind his counter and watching his clerks and meeting his trade will spend his time going from one to the other keeping the machines supplied with merchandise and cor-

Highway District Trustees Named

NORBLAD PUTS O. K. ON NORTH UMPUQUA LIST

Four From Roseburg, One Each From Dixonville, Glide, Wilbur—All Big Taxpayers.

Next Action Is Survey, in Which Forest Service Will Aid; 2-Mill Tax Probable.

Governor A. W. Norblad this morning reported the appointment of trustees for the North Umpqua highway district, in accordance with the procedure authorized at the recent special election in which the district was approved by an overwhelming majority. The trustees named by Governor Norblad to conduct the business of the district are A. C. Masters, Roseburg; F. B. Lane, Glide; R. T. Blakely, Dixonville; C. A. Lockwood, Roseburg; N. Rice, Roseburg; Jesse W. Humphreys, Wilbur, and G. V. Wimberly, Roseburg. The next step is for the trustees to meet and elect a president and a secretary and to adopt regulations governing their meetings and methods of procedure.

The trustees were appointed by the governor upon recommendations made by the North Umpqua highway commission, which has sponsored the project, the names of the proposed trustees being suggested to him as those of responsible men sufficiently interested in the project to carry it through successfully. Governor Norblad adopted the list without change, and notified the commission this morning that the appointments had been authorized.

The trustees were named with a view of giving representation to each section affected by the district in proportion to the population. The men chosen are all heavy taxpayers, and are therefore concerned with economical conduct as well as an active construction program.

Forest Service to Aid

The board is expected to hold a meeting in the very near future to perfect its organization and will then contact the U. S. forest service to determine what measure of

FEDERAL DRY AGENT SHOT; NEAR DEATH

ARLINGTON, Wash., June 3.—Shot through the right lung while raiding a still on the farm of Antone Teppel, about 4 miles north of here last night, Daniel Dunning, federal prohibition agent, was in the Arlington hospital today in a critical condition. Doctors said he had but a slight chance to recover.

Dunning, who recently came in to prominence at Seattle, when he was "taken for a ride" by Jas. Williams and Jack Baze, now serving prison terms for the kidnaping, was shot by Joe Piskner, said to have been the operator of the still. Piskner, after using the gun, helped bring Dunning to the hospital here and was arrested.

Teppel, his son, Ray, 14, and Paul Spekain, a logger were arrested and taken to the Snohomish county jail at Everett by Richard Ginn, who returned to the farm after taking Dunning to the hospital and Piskner to prison.

IOWA REPUBLICAN PRIMARY WINNER



Supporting President Hoover's stand on the pending tariff measure, Congressman L. J. Dickinson (above) was nominated by Iowa republicans for United States senator in the state primary election yesterday. He had a 2-to-1 lead over his nearest opponent, Governor John Hammill, who openly opposed the tariff bill in its present form and declared that President Hoover should veto it. Dickinson will be opposed at the November election by Daniel F. Steck, democrat and present United States senator, who was renominated by his party without rivalry.

ROSEBURG CARAVAN WILL VISIT COAST

A caravan, composed of 50 or more Roseburg business men, will leave this city Friday, June 20, to visit Reedsport and Coos Bay to become better acquainted with the port facilities tributary to the Umpqua valley. Details for the trip were arranged last night at a meeting of the Roseburg chamber of commerce directors. It had been originally planned to make the trip on the 8th of June, but the date of Friday, June 20, has been found more acceptable to all concerned.

It is planned to go directly to Reedsport and there make a trip of inspection to the harbor and to Winchester Bay, learning first hand the port facilities afforded on the Umpqua and also to determine the needs of that port, so that better cooperation can be afforded in supporting future development. Luncheon will be secured at Reedsport and the caravan will then go to Marshfield and North Bend to meet with men of the Coos bay district to inspect the port there. Dinner will be provided here.

While the towns visited are to make arrangements for the meals the local delegation is insisting on paying for the meals, so that there will be no cost incurred by the host cities in connection with the trip.

Roseburg has also received an invitation to meet with the Coquille chamber of commerce on Wednesday, June 18, and it is planned to get as many as possible to attend the forum dinner there at 6:30 o'clock on that date. It is requested that all who can go to Coquille on the 18th advise Secretary Harding as soon as possible, so that reservations may be made.

LIGHTNING STRIKES TEN UNDER A TREE

PRO-HOOVER MAN WINS IN IOWA BATTLE

L. J. Dickinson, at Present Congressman, Named by G. O. P. to Run for Senator.

Has 2-to-1 Lead in Primary Count Over Tariff Bill Foe; Income Tax Man for Governor.

DES MOINES, Ia., June 3.—Congressman L. J. Dickinson, pledging support to President Hoover and the pending tariff bill, early today held nearly a two to one lead over Gov. John Hammill for the republican senatorial nomination in Monday's primary election.

Hammill conceded defeat in a telegram to Dickinson, which read: "Permit me to congratulate you on your primary victory and to assure you my good wishes for your future success."

Senator Daniel F. Steck was chosen without opposition to bear the democratic standard in the November election. He made no campaign.
With more than two-thirds of the precincts reported, unofficial totals showed Dickinson had 133,330 votes. In a statement he said "It is with sincere appreciation and a deep sense of obligation that I accept the mandate of my fellow republicans."

Returns from 1,651 of 2,432 precincts gave Hammill 77,045 votes. He had campaigned against the tariff measure, contending its agricultural rates were not in proportion to the new industrial schedules. He declared the Hawley-Smoot bill would be a detriment to Iowa farmers and that it should be vetoed by President Hoover.

CHIEF OF POLICE SLAIN BY MISTAKE

ARBECON, N. J., June 3. Chief of Police William M. Schofield, 41, of Arbecon, was shot and killed early today, when he was mistaken for an intruder while investigating an alleged disorderly house.

George Howard Much, 31, of Ventnor, N. J., was arrested charged with the shooting. Three others, including two women were held as material witnesses.
In a statement to police, Much said he recently rented the place for a summer home. Early today he heard a knock at the door and then saw it opened by a man in civilian clothes. Fearing the man to be a robber, he said he fired a shot with the intention of scaring him off, only to see Schofield fall dead.

Police said several complaints had been received about parties held in the place recently.

ATTEMPT MADE TO SLAY RICH WIDOW

CHICAGO, June 3.—An attempt was made early today upon the life of Mrs. Lottie Brenner Dechow, the wealthy and elderly woman who has brought perjury charges against her young husband, the self-styled "Count Von Buelow," alleging he married her under a spurious name.
The assassin fired two shots through her bedroom window. The bullets pierced the coverlet of her bed.

Mrs. De Chow, 55 years old and possessor of a fortune left her by the late Alderman Nate Brenner, had arisen five minutes earlier to go to the chamber of her sister. While in her sister's room she heard the shots and hurried back to her own.

Seeking a motive, officers inquired concerning the woman's feelings toward her deceased husband. She said that although she recently had sought his arrest on a charge of false swearing in the procuring of their marriage license, she and De Chow were now on friendly terms.

"I'm sure Henry wouldn't do it," she said. "He's traveled in bad company and lived off my money, but he wouldn't be that vicious."

HOOVER STANDS BY VETO OF MEASURE

Pension Bill Passed by Congress Held Attack on Principles of 70 Years Standing

WASHINGTON, June 3.—President Hoover said today he had not changed his opinion that the Spanish-American war veterans pension bill enacted over his veto yesterday by congress was unwise.

"I favored a liberalization of the Spanish war veterans pensions," he said, "because they have not been on a parity with other services, but I have not changed my opinion that it should have been worked out in such a way that rich men, or men having substantial incomes, should not draw pensions from the government."

"I have made no suggestion at any time of a pauper provision against veterans or anything akin thereto."

"I do not believe we should alter the principles which have been held for Civil war veterans all these 70 years, requiring that men claiming pensions should have at least 30 days service."

"Further than this, I do not believe it is right to call upon the national policy and to change our national policy and to change our national policy to men who have or may tomorrow destroy their health by vicious habits."

"I have received numerous communications from veterans supporting these views."

After President Hoover vetoed the bill last week, both the house and senate enacted it into law yesterday by large majorities.

Authorizing a more liberal pension basis, it would benefit approximately 114,000 veterans of the Spanish war, the Philippine insurrection and the China relief expedition.

It would cost the government approximately \$11,500,000 annually. It provides higher rates for those who served ninety days during the Spanish war, or less than ninety days with a discharge for disability incurred in line of duty.

The disability rates range from \$20 a month for veterans one-tenth disabled to \$60 for total disabilities.

When a veteran requires a regular attendant he would receive \$72 a month.

The rates based on age provide \$30 a month when the veteran is 62 years old, \$40 at 68; \$50 at 72, and \$60 at 75.

DISTRICT KIWANIS IN SESSION HERE

The district Kiwanis conference, with representatives from Eugene, Marshfield, North Bend, Medford, Grants Pass, Klamath Falls, Bend, and Roseburg, opened this afternoon at the parlors of the Elks lodge temple, with Dr. George E. Houck, lieutenant governor, presiding. There was a fine attendance, particularly in view of weather conditions, and the session opened in a very interesting manner.

Doctor Houck, as lieutenant governor, reported on divisional problems, membership increase, objectives, conventions and other district matters, after which a general conference and round-table discussion was presented.

Talks were made on the various activities of the clubs, after which discussions of each topic were held. Agriculture, attendance, business standards, classification, membership, good will, interclub relations, efficiency contest, Kiwanis education, reports, music, public affairs, publicity, underprivileged child and vocational guidance were among the topics scheduled for discussion.

The afternoon session was scheduled to conclude with an oratorical contest with competitors from each club. The winner is to compete in the divisional contest.

At 6:30 o'clock this evening the local and visiting Kiwanians and their guests will enjoy a dinner at the country club, after which there will be a brief program, at which Charles Walker, district governor, will be a speaker. The evening entertainment will conclude with a dance.

BOYS PLAY WITH SHOTGUN; 1 DEAD

KILLMATH FALLS, Ore., June 2.—Jack Harding, 11, was shot and killed by Frederick Williams, 16, late yesterday while the two boys were playing with a shotgun. Officials said the shooting was accidental.

COUNCIL MAY MAKE SPECIAL 10-MILL LEVY

No Money in Treasury to Pay Off \$40,000 Paving Bonds Falling Due in September.

Alternative Refunding at Higher Rate—New Fire Truck Tires Bought Over Protest.

A special 10-mill tax to be levied against all of the property in Roseburg, is being considered by the city council to meet a bond issue of \$40,000 due in September of this year. The bonds for which money is needed were issued 20 years ago to pay for the first street paving in the city, and the council at that time, as well as succeeding councils, made no provision for a sinking fund, so that no money is on hand to meet the bonds when they come due. The bonds have been coming only 4 per cent interest, so have not been comparatively expensive to the city.

The council, according to City Attorney L. B. Riddle, has the authority to levy a special tax to pay the bonds and get them out of the way, or can call a special election to vote on a refunding bond.

If a refunding bond is decided upon it will be necessary to issue a new bond at a much higher rate of interest, and at the same time to create a sinking fund to pay off the new bond.

The councilmen are rather in favor of voting a special tax and getting rid of the obligation without further difficulty. If a new bond is issued the payments, although strong over a long period of years, will be considerably more than if paid at one time, as there will be a heavy interest payment to make each year. It is felt that the best way would be to levy a special tax, even though it may create a much larger tax for one year, and wipe out the debt, thereby strengthening the city's financial position.

No definite decision, however, has yet been reached, and the matter will be brought up again at the next council meeting.

BOY, 16, RETRACTS MURDER ADMISSION

VANCOUVER, Wash., June 3.—CIVAN Campbell, 16, chore boy, who yesterday pleaded not guilty to a charge of first degree murder in connection with the death of Mr. and Mrs. B. A. Northrup, ranchers, today announced through his attorney he had repudiated the confession he is said to have made before a group of newspapermen and authorities.

Campbell was arrested after the farm home of the Northrups was dynamited to splinters by a charge of dynamite. He denied connection with the blast and told authorities he witnessed the explosion from the front yard of the farm home while enroute to round up stray cattle.

Four days after the explosion, Campbell, authorities said, confessed firing the dynamite which killed the rancher and his wife because they twitted him about his studies.

INFANT DEATH TOLL FROM SERUM IS 26

LUEBECK, Germany, June 3.—Deaths of two infants today increased the toll of anti-tuberculosis treatment administered here recently to twenty-six. One hundred three persons are still dangerously ill while 81 persons apparently have recovered.

BLAST KILLS THREE IN POWDER PLANT

TAMAQUA, Pa., June 3.—Three workmen were killed when the mixing house of the Atlas Powder company plant at Mixtown, seven miles south of here, was wrecked by an explosion early today. The victims were the only men employed in the mixing house which was blown to pieces by the blast.

"OLD PETE," DONE IN MAJORS, MAY PITCH ON COAST

PHILADELPHIA, June 3.—Grover Cleveland Alexander, veteran pitcher and one of the greatest in the National league in his best days, has probably come to the end of his major league career. Announcement was made today by the Philadelphia National club management that "Old Pete" had been unconditionally released.

"We are sorry to let Alex go," said General Nugent, business manager of the Phillies, "but he was not helping us and Manager Burr Shotton decided it was useless to carry him any longer. We are going to do everything we can to help Alex land where he wants to go and will see that he gets along all right until he locates."

Alex hopes to land a pitching job in the Pacific coast league. He feels he would like to pitch a little longer before turning to a job such as coaching. He says he realizes he can't win in the big leagues any more.

Alexander holds the National league record for victories, with 273 triumphs.

ZEPPELIN OFF ON RETURN TO EUROPE

LAKEHURST, N. J., June 3.—Grey veteran of tar-falling trails through the sky, the Graf Zeppelin, her motors singing a deep and solemn farewell, was headed out over the Atlantic ocean today for the seventh time.

The zeppelin, on her trip to Friedrichshafen, Germany, made a stop at Seattle, Spate, which her commander expected to reach in fifty hours.

A few minutes before she departed last night her commander indicated that the end of the Graf's career was in sight.

By a year from next fall, said Dr. Hugo Belmerer, he hopes to have three big ships, each able to carry 24 passengers and 20 tons of mail and freight, sailing on schedule across the Atlantic.

And by that time, he added, the Graf Zeppelin "can be put in alcohol and preserved."

Of the twenty-two passengers aboard, four were women. One of the women, Mrs. John H. Graves of New York, had never been in any kind of aircraft before. Two more, Mrs. Mary Pierce of New York, and Mrs. Charles B. Parker of Cleveland, set out last night to cross the Atlantic aboard the Graf Zeppelin for the second time. Two other passengers were Sir Hubert Wilkins, the explorer, and Lady Wilkins.

PENNIES SAVED BUY MARRIAGE LICENSE

SPOKANE, Wash., June 3.—Two Whitworth college students arrived last fall to save their pennies until they had enough to buy a marriage license. Yesterday they emptied a sack of pennies on the county clerk's desk and obtained the license and had 21 pennies to spare.

They were J. Glenn Julian, of Redmond, Ore., and Evelyn L. White, of Portland, who have been acting secretary to the president of the college. They were married last night.

REFUSES TO EXPLAIN HIS 1928 ACTION

Roman Catholics And Wets Attempt To Persecute Him, He Asserts.

Walsh Warns of Possible Consequences—Morals Alone Bases Fight, Cleric Asserts.

WASHINGTON, June 3.—Bishop James Cannon Jr. today flatly declined before the senate lobby committee to answer a question about his political activities in the 1928 presidential campaign.

Senator Walsh, democrat, Montana, in adjourning the committee informed the bishop that "of course you will have to take responsibility" for declining to answer.

Cannon replied the committee's investigation of him was "persecution."

This stirred the crowded committee into laughter, applause and hisses. "I cannot help but get the implication in that statement," said Walsh.

Cannon hastily replied: "I do not charge you, Senator, with persecution."

Just previously the bishop had charged that wet and Roman Catholic interests had tried to discredit him. Walsh is a Catholic and a dry.

Sees Ulterior Motive
When the question verged on the 1928 campaign, Bishop Cannon read the following prepared statement:

"This attempt on the part of this committee to go beyond its powers and to investigate my anti-Smith activities is clearly not only political but clearly and because I believe it to be an effort to attack me."

SQUATTER GETS 30 DAYS TO MOVE OUT

PORTLAND, June 3.—E. H. Best, Umpqua national forest squatter in government custody here for the fourth time on a charge of trespassing on a national reserve, today was granted release on his personal recognizance by Federal Judge McNary on condition that the defendant move with his family from his home near Fish creek desert, 45 miles east of Roseburg, and report to the court in person July 2.

Should Best fail to move within the month allowed, the government will press the charge to which he has pleaded not guilty. Otherwise the case will be dismissed. Judge McNary said.

Joseph K. Carson, Jr., attorney for Best, resigned from the case today, reporting counsel and defendant were in disagreement. Carson also resigned from the cases of J. E. Brocken and Edwin Martin, neighbors of Best, whose trials on like charges have been set for Wednesday and Thursday, this week, respectively.

NOTED EXPLORER IS SLAIN BY STUDENT

CAMBRIDGE, Eng., June 3.—Historic King's college, Cambridge, today was the scene of a double tragedy which ended in the death of A. F. H. Wollaston, famous explorer and Cambridge instructor, and D. N. Potts, an undergraduate who died in a local hospital from a bullet wound.

The dead explorer was senior tutor of King's college. He was a member of the 1921 Mount Everest expedition and had also traveled in Central Africa and New Guinea. He held numerous scholastic distinctions and was at the age of 55, one of the best known men in Cambridge university.

It was the police theory that during an interview in the college between Potts and Wollaston, at which the undergraduate drew a revolver, fired at Wollaston and then shot at WBBB before turning the weapon on himself.

Students, hearing the shots, rushed into the room to find Wollaston dead with a bullet through his heart. Potts mortally wounded and WBBB lying on the floor shot through the shoulder and leg.
