

MERGER MEANS WIDER TRADE FOR UMPQUA MELONS

The merger of Gamble-Robinson, one of the largest distributors of fruits and vegetables in the middle-west, with the General Fruit Corporation which was announced last week, places the latter company in a dominant position in the fruit and produce industry, directly affecting the Umpqua valley cantaloupe industry, according to Wesley Williams, local melon producer.

The General Fruit Corporation, with the acquisition of this latest group of branches, now owns over 100 branch distributing houses west of the Mississippi river, together with terminal brokerage offices in all the principal markets of the United States. This company has been actively behind the cantaloupe industry of Douglas county for the past two years and has his own contract with the Umpqua valley cantaloupe growers to obtain a major portion of his melons from this district.

Mr. Williams feels that he has been very fortunate in securing the services of this company in the exclusive selling of the "Pride of Umpqua" cantaloupes. With the services of an almost nation wide distributor available for handling the crop, the Umpqua valley grower is left free to devote his entire time and effort to the production and preparation for market of the highest quality of melon. With organized and positive control of both production and distribution, whereby the total crop of the district goes out under one brand and through one efficient distributing organization, there is every indication that commercial production of cantaloupes should become one of the larger agricultural activities of this county.

Mr. Williams says, however, that the finest distributing organization in the world is dependent in giving successful results, directly upon the cooperation of the grower or growers from whom it derives its supplies. To build a successful cantaloupe deal, or a successful deal in any other product, it is necessary to deliver to the distributor the finest product that can be grown, put up in the most careful and painstaking manner possible. It should always be remembered in preparing produce for market that each individual unit in any container of fruits or vegetables is carefully scrutinized by the ultimate purchaser or consumer with the desire to obtain the best possible article from that group.
