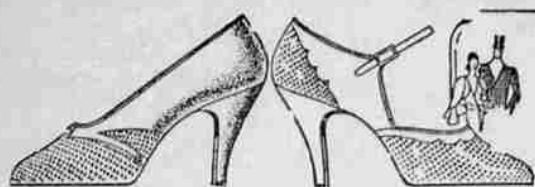

MYRTLE CREEK, Aug. 4.—Mrs. Mary Ann (Roberta) Stevenson, who died at her home here Saturday, August 2, was the daughter of Jane and Jesse Roberts who were the original owners of the present town site of Canyonville. She was born at the old fort on the north side of Roberts mountain, October 10, 1851. She was married to George H. Stevenson Oct. 19, 1866, by Rev. E. G. Browning, a pioneer Christian minister.

PEASANTS USED AS
HUMAN SHIELDS BY
CHINESE RIOTERS

(Associated Press Landed Wire)

HANKOW, Aug. 4.—How communists advanced into Changhai behind a human screen to shield themselves from the fire of troops defending the city was related here today by a wounded colonel of Hunan provincial forces.

The officer, arriving here for hospitalization, said the reds entered the city behind masses of fattered peasants. The peasants' hands were tied behind their backs.

Before realizing the helplessness of the peasants, provincial troops opened fire, the colonel said, but held their bullets when they saw they were slaughtering defenseless persons in large numbers.

Advancing then without opposition, the reds easily dispersed the provincial troops, inflicting heavy losses, and began their carnival of murder, robbery and arson.

Meanwhile the evacuation of Kuling, Kiangsi province summer resort, was speeded up as the communist menace persisted.

United States naval authorities also announced their Yangtze river patrol would be improved to cope with the situation in the communist ridden valley.

Changsha was shelled by a Chinese gunboat last night, dispatches said. Communist machine gun crews on the northern outskirts of the city returned the fire until the gunboat was forced to turn back.

Changsha, although most of the reds are believed withdrawn, still is in a precarious position. Communists remaining in the city are well armed.

The Siang river, on which Changsha is situated, was reported falling again today. Foreign naval authorities indicated should it reach a low level they believed communists would block gunboats from approaching the city by sinking boats loaded with stones above Changsha.

Farmers are busy people these times, and grain is being rushed into stacks preparatory to the annual visit of the threshing crews, and when one goes in touch with these men it is often necessary to go out into the fields where they are at work. These folks are affable, frank fellows, and while they are pitching bundles of wheat or other grain from wagon to stack will talk freely of their work, marketing problems, prices on various products of the farm, or politics. Most generally Douglas county farmers are well read on current issues. They not only read daily papers, but magazines and farm journals, and through radio and daily general market reports are in touch with quotations on grain, live stock or other products. Foreign quotations are familiar matters to many of these American farmers, and they compare domestic with foreign and discuss these freely. While working wheat on his farm near Wilbur one day this week, C. L. Spurling, along with three of his neighbors who were there, told of some of the problems these former folks were thinking about. Mr. Spurling went on to say that he got his information from news dispatches in a republican paper published in Portland, so, he declared, it must be accepted as probably correct.

Comparing the present price of domestic wheat in France at \$1.71, as given in the dispatches, with the price of wheat in the middle west of 85 cents and 87 cents in Chicago, Mr. Spurling explained how it was that the French farmer was able to command \$1.71 per bushel. To begin with, he said, France makes it compulsory that 90 per cent of the wheat milled there must be home grown. In addition to this a high tariff is charged against all wheat imported to the country. The average yield of wheat per acre in France, he alleged, is 29 bushels, against a much lower average in this country, where grain raising is carried on so extensively. These facts add to the prosperity of the Frenchman. First the American farmer exports wheat profitably on the lower average here and prevailing prices in our markets. Mr. Spurling said was vividly recalled by statistics on production which placed the cost of raising wheat in the United States at \$1.20 per bushel.

Leaving the questions of marketing and wheat yield, Mr. Spurling abruptly asked, "How do you like the nomination for governor on the republican ticket to fill the vacancy caused by the death of Mr. Joseph? Hardly waiting for any one to reply, this farmer added: "Well, here is one vote for the democratic nomination unless the right sort of an independent candidate comes into the field."

The question was then put to those three other neighbor farmers as to their opinion in this respect, and without a dissenting voice they all agreed as three school directors in a country district, as mentioned in an imaginary case: "There's my sentiments, too."

Red Clover's Value
Discussing farm crops and profitable feed for dairy cows, Carl Brannigan, living on the highway between Sutherlin and Wilbur, where he has made his home for many years, related to an acre of red clover that he has seen from the road he was on, that he was worth to farmers of the Umpqua valley. This particular acre of red clover has been cut twice

this season and is coming up splendidly for the third crop before winter. But that is not the most remarkable feature of the field. The peculiar thing about it is that it was never seeded to clover. How it got started Mr. Brannigan does not know. When the place was acquired some years ago the strip of land along the highway—this was before the Pacific highway was built—was used for garden and occasionally a grain hay crop. Barnyard fertilizer was applied to the field on one or two occasions, and the owner suggested that possibly there might have been some red clover seed in the refuse from the barn that was spread over the field. Whether or not this was so is conjecture, but at any rate the red clover got started, and it spread rapidly until there is now as fine a stand as any farmer could wish. This land lies at the foot of the hills along which the highway skirts its way, and is not any different from thousands of acres of similar land in the county. Mr. Brannigan finds it mighty convenient feed for his cows at this time, and believes that clover might become a very profitable feed for dairy cows if farmers would try it out more generally. This acre of clover on his small farm has no irrigation. Over on the Davis Hill road northwest of Wilbur, a couple of miles from the Brannigan place, Mr. Hume has a small field of red clover on the hill side that he also uses for his cows. This field, however, was seeded, but it furnishes a lot of green feed during these dry summer days when pastures are hard hit and grass is ripe.

HOOVER MOVES TO
HELP IN SERIOUS
DROUGHT DISTRESS

(Associated Press Landed Wire)

WASHINGTON, Aug. 5.—President Hoover announced today no one would be left without food in the drought-stricken areas.

The seriousness of the situation in a wide area east of the Mississippi and in the middle west has been the subject of conferences between Mr. Hoover and Secretary Hays.

The result was an order to make a detailed survey by the department of agriculture which will have a report next Monday.

President Hoover in his statement said:

"The drought situation has been the subject of several conferences between Secretary Hyde, Chairman Leage and myself. The department of agriculture has undertaken a detailed survey of the situation. They will report next Monday upon the condition in each area in the country. The information so far indicates great variation in the effect of the drought, both as between states, between counties in those states, and even between farms in the same counties."

Says Situation Serious
"There can be no doubt as to its most serious character in many localities, and that unless relieved there will be real suffering. The maximum intensity seems to lie in a belt roughly following the Potomac, the Ohio and the Mississippi rivers."

"The measures of assistance that the farm board and the other agencies of the federal government can and should undertake are being determined."

"It is evident already that large measures of feed movement to livestock in the drought areas or movement of animals out of the worst areas will need be undertaken later in the fall."

"It is too early to determine the precise character of relief; much depends upon the further spread of the drought; but no stone will be left unturned by the federal government in giving assistance to the afflicted areas. I have asked the railways to investigate the situation from a transportation point of view."

THREE DEMOCRATS
GET TOGETHER TO
STAGE POW WOW

SOUTHAMPTON, N. Y., Aug. 4.—Avered for the sole purpose of enjoying each other's company, Governor Franklin D. Roosevelt, John J. Raskob, and Alfred E. Smith were assembled in the Southampton today.

After a tour of the state parks along the south shore of Long Island, the governor arrived at 7 o'clock last night to visit his law partner, Basil D. O'Connor, at Westhampton.

At 10 o'clock the democratic national chairman and former Governor Smith left Canoe Place Inn, at Hampton Bay, where they were staying, for the O'Connor residence.

"This is the truth, Billy," the former governor said solemnly to one of the newspapermen who was a friend of his in Albany days, "we're just going over there to have a nice sociable time and tell funny stories."

Previously, Governor Roosevelt had said he and his old friend, "the happy warrior," "were going to get together to talk about their grandchildren." Political observers, however, insisted when Franklin D. Roosevelt, John J. Raskob and Alfred E. Smith, foregathered for a midnight pow wow, they just couldn't be merely telling funny stories and talking about the Smith and Roosevelt grandchildren.

There were a number of theories as to what may have been discussed at the conference. One was that it might have to do with the policies of the party on certain public questions to come up at the state convention at Albany, Sept. 30 and Oct. 1. Some of the observers had an idea, too, Governor Roosevelt's possibilities as a candidate for president in 1932 might come up.

For all any of the participants had to say, however, it was just a good old fashioned visit, purely social, and it was to be continued today at a luncheon to be given by Mr. O'Connor in honor of the governor at Canoe Place Inn. So far as newspapermen could learn, only the governor, the former governor and the democratic national chairman were at Mr. O'Connor's home last night.

Governor Roosevelt said yesterday he expected to see his predecessor at the luncheon today but there would be no discussion of politics.

"I'm not going to talk politics until September," he said, "this is only August."

ADVERTISE WHEN
BUSINESS WANES,
SAYS SPEAKER

PORTLAND, Aug. 5.—Fred P. Mann, Deville, La., N. D., outstanding independent merchant and former director of the United States chamber of commerce, told members of the Portland chamber yesterday advertising and "a fighting spirit" are essential to weathering periods of business depression.

Mann, here to attend the eighteenth annual buyers' week sponsored by Portland jobbers, told how he built a \$500,000 annual mercantile business in a town of 5500 persons.

"When business is hardest to get, it is a time advertising is most needed," he said. "A survey made in North Dakota in 1918 showed mail order houses were getting a third of the \$90,000,000 being spent in the state that year for merchandise."

"It also showed mail order houses were spending millions of dollars for catalogues and direct mail advertising while 75 per cent of the independent merchants did not advertise at all," he concluded.

Three hundred buyers from western states and Alaska have registered here for the week. A thousand more are expected.
