VAN WINKLE RULES ON WATER ACT TO GUIDE GOVERNOR

Norblad Soon to Decide if He'll Call Legislature to Deal With Issue of Power Sites.

(Associated Press Local Wire)
 SALEM, Ore., Oct. 2.—Cities in Oregon have authority under existing laws to appropriate by condemnation proceedings water power projects that have been constructed. This right is not confined to undeveloped water rights. These are answers given by Attorney General Van Winkle to one of a list of questions asked him by Governor Norblad as a basis on which the governor will decide whether he will call a special session of the legislature to consider power issues. The governor said he would not decide until Friday or Saturday whether he will call a session.

The attorney general's opinion is a general interpretation of the state water laws.
 Another question by the governor refers to the law requiring that actual construction work—except under applications by municipal corporations for municipal purposes—shall begin within one year from the date of approval of an application by the state engineer; and that construction shall be completed within five years. This law also requires the engineer, for good cause shown, to allow an extension of time, including an extension beyond the five-year limitation. The governor wanted to know whether these provisions were positive enough to cause a speedy termination of water power permits held in idleness for speculation by private companies or individuals.

Authority to Cancel
 The attorney general answers that he finds no specific provision for cancellation of a permit for failure to commence or complete construction within the time limited or extended, except in cases where a permit is also required from the federal power commission. In the latter case the opinion says the engineer is authorized to cancel his permit if a permit is denied by the federal commission. Regardless of whether a federal permit is required, however, the opinion is that the claimant who has failed to comply with the law has lost his right as against any other claimant who desires to file for the same rights.

Good Faith Evidence
 The governor asked also whether, under present laws, it is legal possible for a private company to file upon one or more power sites on a stream, and by doing a

minimum amount of work on one site to monopolize the entire stream to the exclusion of other companies or municipalities, or against the will of the authorities. The answer is that if all of the sites filed upon by the applicant are interdependent, then the prosecution of work done in good faith would bar the development of the other by another applicant.

Answering another question, the attorney general holds that, under the state laws, incorporated cities and towns have a right to condemnation and by payment of just compensation, similarly to a right reserved to the government under the federal water power act.

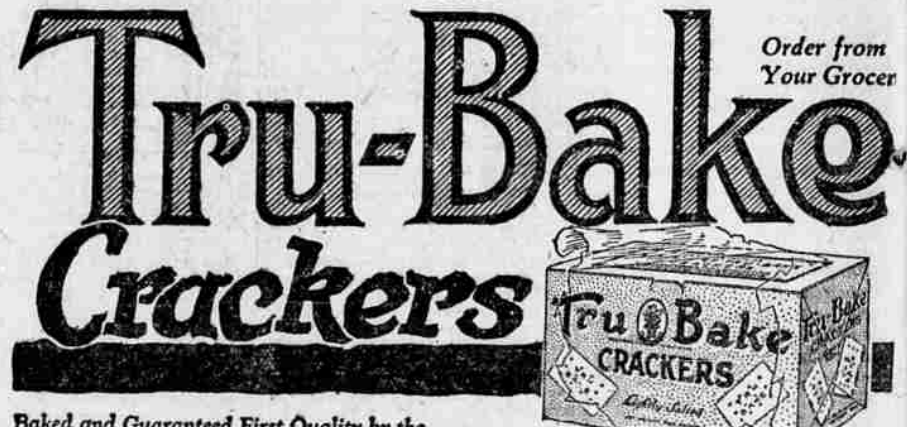

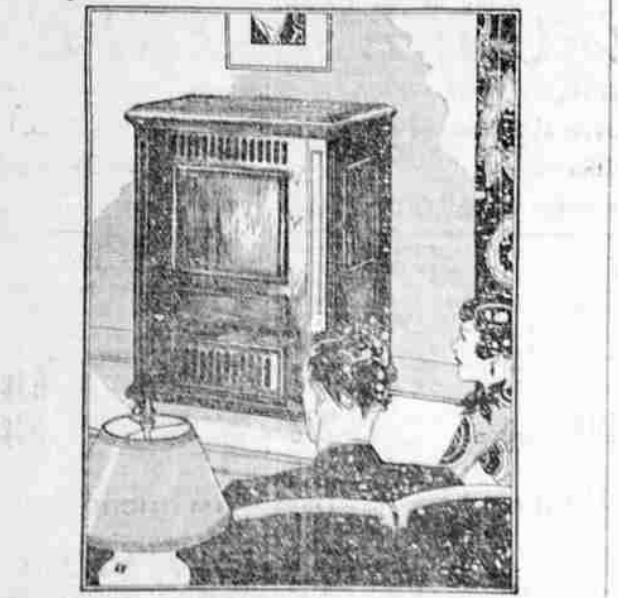
