Legislature

ON the whole, people of Oregon outside of Multnomah county are not very much concerned over this fight in the legislature over who shall appoint the commissioners for the Port of Portland. Senator Crawford expressed the sole interest we have in this subject when he said on the floor of the senate that the Port of Portland constitutes a disturbing element in the legislature. He is dead right. So far as the rest of the state is concerned, this Portland port matter has served only to slow up and disturb the legislature.

ONE of the bills sponsored by the League of Oregon cities provides that a city may create a sinking fund for the purpose of building garbage and sewage disposal plants. Whether we like it or not, this question of the disposal of garbage and sewage is one that we are going to have to reckon with. The present method, employed by some 50 cities in Oregon, of dumping sewage into the rivers is due to be changed. Eastern towns and cities have been compelled to get away from this practice for sanitary reasons. Thus far in the development of the west, population has been so sparse that there has been no considerable menace. The time is not far distant, however, when sewage filled streams will prove to be a definite menace to public health.

REPRESENTATIVE NICHOLS had a bad time with his house bill number 111 with which it is assumed he intended to repeal the high school tuition law under which all counties of Oregon but one are now operating. Due to a mistake in section numbers given in the bill, number 111 as introduced specified the repeal of the sections of the law known as the Wheeler act. Mr. Nichols withdrew the bill because of the fact, no doubt, that he favors the Wheeler law as opposed to the high school tuition law. This writer believes, however, that house bill number 111 as written should have been passed. The Wheeler law does not provide for the payment of enough per pupil for high school education and would without doubt if applied in Douglas county result in many students now living in districts which have no high school, being deprived of high school education.

A WAVE of protest against the proposed refunding of payments on the intangibles tax which have already been made, is being started. This is a knotty problem. The intangibles tax law was declared unconstitutional by the state supreme court after nearly a million dollars in taxes had been paid. There are two fundamentals involved in this discussion about refunding: The tax was passed by the legislature in good faith and the intention of the act was quite clear. Secondly, the state of Oregon is short of funds and actually needs every cent of the money collected. The argument most used by those who favor refunding is that if the money is not refunded it will be equivalent to breaking faith with those who paid the tax. However, we must not overlook the fact that if the refund is made, such act might easily be called breaking faith with those who pay only taxes on real property, since it throws the burden back on them.

ORCHARD crops are represented on this farm through the presence of some seventy prune trees and some peaches. These peaches were sent to him from his old home in Indiana and he hopes great things of them. They are just coming into bearing. The prunes he is not so enthusiastic about, in fact he is engaged in grubbing them out. He hasn't enough for a commercial orchard and too many for any other purpose, he says. He is going to garden the land they now occupy.

About an acre is seeded to vetch and oats. This he will use for pasture for his cow and hay. His cow is a good animal and supplies a considerable quantity of milk which he sells. A small flock of chickens is kept, and these do their bit toward the living afforded the Ramseys by this small farm.

The entire five acres is irrigated and this helps tremendously in lengthening the growing season on many of his vegetable crops far beyond their normal reach, and adding to the quality of the produce. Mr. Ramsey has lived on this place for the past ten years. He was born in Indiana and has since lived in five of the western states, rearing a family of four and educating them. He and Mrs. Ramsey are now alone, and sometimes they get just a little bit lonely when they think of their children, all of whom are far away. But soon they think of their neighbors who are so friendly, and then they think of Myrtle Creek, and the nostalgia entirely disappears. For the Ramseys are firm in their belief that Myrtle Creek is the best spot in the west. And they are not wishful to leave, ever.

GLENDALE MAN HAS CONFIDENCE IN EGG INDUSTRY

GLENDALE, Feb. 6.—A brooder house, 20 by 30 feet, is being planned by I. A. Zook who has a 14-acre place a half mile north of this city. It will join the present laying house on the south slope of the hillside and excavations are already being made for the new building. Mr. Zook, whose regular vocation is that of local agent for the Southern Pacific company, is making poultry his hobby. He has had a large flock of hens for several years and now has about 400 white leghorn hens. He expects to increase his flock by purchasing about 500 chicks this spring. While prices of poultry feeds and costs of raising chicks have not yet declined proportionately with the decline in egg prices Mr. Zook is optimistic about the future of the poultry business and believes that the poultry man will eventually come into his own again. Glendale and Cow Creek valley is ideally located for poultry raising. What is needed, says Mr. Zook, is a tariff that will protect the American egg from Chinese and other foreign competition.
