EVIDENCE AGAINST CANNON FINISHED

Bishop's Wife Reported to Have Given Information Basing Charges.

(Associated Press United Wire)
WASHINGTON, Feb. 6.—Taking of evidence against Bishop James Cannon Jr., was ended before a secret church board of inquiry late last night, as word came from within the hearing that among the testimony was an assertion that information on which part of the charges against the prelate are based, came from Mrs. Helen McCullum, now Bishop Cannon's second wife.

Today the temperance leader of the Methodist Episcopal church, South, came to the beginning of his own defense.

Austin O'Malley, a reporter for the New York Journal, was among the witnesses who appeared before the board of twelve elders near the close of direct testimony taking.

Bishop Cannon recently filed a \$5,000,000 suit for damages against William Randolph Hearst, publisher of the Journal, based on the publication of letters alleged to have been written by the bishop, and statements concerning him, which he claimed were libelous.

Frank Morgan, a Richmond, Va., detective, the last witness called, testified concerning documents previously presented, the evidence in which he had obtained during months of investigating the conduct of Bishop Cannon.

On leaving the hearing the detective said that he had been given "a warm time."

"I had questions fired at me from every angle," he said, "but I had the answers."

Robert Thomas, a Richmond lawyer, Dr. Eugene Crawford, an associate of Bishop Cannon on the church board of temperance, and Bert Ferrar, a handwriting expert, were other witnesses.

ANTI-DIPHTHERIA SERUM TO BE GIVEN

A new series of toxin-antitoxin treatments for the prevention of diphtheria will be started tomorrow morning, February 7, at 10 o'clock, according to Dr. B. R. Shoemaker, county health officer.

These treatments will be given in the offices of the Douglas county health unit in the court house, and will be given every Saturday morning thereafter.

Three injections of the serum given one week apart, are required to complete the inoculation. The entire series of injections are given for thirty cents, the actual cost of the serum. Because the person receiving the serum is not immunized against diphtheria until approximately five months later, it is necessary that every child receive the serum at once in order to resist the disease in the face of an epidemic. Dr. Shoemaker says: "Toxin-antitoxin is of no value if given in the face of an epidemic, he advises."

Doukhobors in Canada Plan Fifth Long Trek; Mexican Ranch Is Goal

CHIHUAHUA CITY, Mexico, Feb. 7.—Movement of the Doukhobors from Canada to the Santa Clara ranch near here, planned as soon as the Mexican government grants permission for the trek, will be the fifth great migration for the sect in its 300 years of history.

So well have the leaders of the communist religious colony managed its affairs in recent years that there will be plenty of funds left for transportation after the \$50,000 acres of the great ranch are purchased. Special combination freight and passenger trains probably will carry the Doukhobors and the trip will be made in greater comfort than any of the previous migrations.

Though the Doukhobors are not aggressive and make no attempt to impose their belief on their neighbors, the sect has been in more or less conflict with authority ever since it was founded in Russia during the 18th century by a wandering Prussian soldier of Quakerish ideals.
