## YOUTH DIES AFTER DRINK OF 'MOON'

ELLENBURG, Wash., March 24.—A 19-year-old youth, whom officers knew only as Larned, died Sunday afternoon in a road camp on the east side of the Vantage bridge after he had taken a drink of moonshine. It was learned here today. Authorities believe the liquor was obtained from a still in the neighborhood of the bridge.

Larned took the drink from members of a road construction crew, five of whom said they bought two gallons of liquor from R. C. Rankin, commonly known as "Alkali Ike," who operated a still station 20 miles east of Ellenburg.

Rankin, admitting sale of the liquor, pleaded guilty to its sale in superior court today and was sentenced to serve from one to five years in the state penitentiary.

All five workmen were ill. None of them knew Larned. They contractors immediately discharged the workmen.

## MISSING POSTAL MAN SHORT \$8590

ASTORIA, Ore., March 24.—Postmaster Charles Halderman announced today an audit of the books of H. F. Peacock, missing assistant postmaster, had been completed and the total shortage was found to be \$8,590.53. Peacock was under a \$5,000 bond. His properties in Astoria and Warrenton have been attached by Halderman and are believed to be of sufficient value to cover the balance of the shortage.

No further clues to Peacock's whereabouts have been developed since the finding of his abandoned automobile Saturday morning on Tongue point. Shortly before leaving Astoria he drew several hundred dollars from his personal bank account.

Bullets Wrecked Plan

Soon after that, Mallahan allegedly confessed, he was sentenced to seven years in Folsom prison for robbery. He was released last September, he said, and presented to Smith in Seattle. They went to California and planned a big payroll holdup. Smith's death from officers' bullets wrecked their plans, police said Mallahan told them.

Before his fatal brush with the officers, however, Smith allegedly told Mallahan he had "pulled" five robberies in Portland, aggregating \$40,975 in cash and checks. The holdups, Mallahan alleged, included the Parkrose bank, Portland, in 1925, where Smith obtained \$3500, and several Portland stores, the largest of which was \$26,405 from a department store in 1927.

40 SOLDIERS SLAIN IN REVOLT IN PERU

LIMA, Peru, March 24.—Forty or more soldiers were killed in the barracks at the Santa Catalina army post here early today, according to government reports, when the regiment, led by its non-commissioned officers, revolted against the Ocamo government.

The barracks, into which the revolutionary troops had been pursued by the loyalists army, were swarmed by cannon fire and almost demolished.

Martial law was declared this afternoon.

## RESCUE OF AIRMAN JUSTIFIES DEVICES

WASHINGTON, March 24.—Justification for the safety appliances on naval flying craft was seen today by Assistant Secretary Ingalls for naval aeronautics in the safe return of Verne Warren Harshman after being missing for five days in the Pacific.

## PAROLE SYSTEM IS SCORED BY BAKER

COLUMBUS, O., March 24.—Newton D. Baker of Cleveland, former secretary of war and member of the Wickersham crime commission, attributes the numerous prison outbreaks and disorders in this country to indeterminate sentence laws. The former secretary, appearing before the Ohio senate institutions committee last night, appealed for enactment of legislation giving the courts right to fix definite sentences. He declared the indefinite sentence, placing the prisoner at the mercy of the parole board, makes him suspicious and distrustful in fear he is being discriminated against. "His only thought is to get out of prison any way he can," Baker said.

## PAROLE SYSTEM IS SCORED BY BAKER

Baker declared that the "Judge is the last safeguard of liberty in this country." He contended the trial judge was more able to determine what the sentence should be than a parole board. He said he thought all sentences are too long and favored reduction.

## KLAMATH WINS TAXI PARKING TAX SUIT

SALEM, March 24.—The Oregon supreme court, in an opinion handed down today, dissolved the injunction restraining the city of Klamath Falls from enforcing an ordinance taxing B. B. Fenwick, engaged in the taxicab business for parking stand privileges. The court also sustained the demurrer of the city filed on the ground that the complaint of Fenwick against the city did not state facts sufficient to constitute a cause for suit against the city. The lower court was thus reversed.

The case is that of B. B. Fenwick against the city of Klamath Falls and its officers, the latter appealing the decision of Judge W. M. Duncan, who issued the injunction. Fenwick contended that the city does not have the power to add any burden or restriction above the regular city license fee, or to designate a parking place for cars for hire, and that he had the right to park his cars on any street. The supreme court held that the ordinance did not infringe any of the plaintiff's constitutional rights, and that the ordinance was valid.

## THIRTY KILLED IN OUTBREAK IN INDIA

CAWNPUR, India, March 25.—Thirty persons have been killed and more than 100 injured in rioting which has developed here in protest at the execution of Baghat

Allahabad and Lucknow. An auxiliary force was raised here to patrol the residential area.

Baghat Singh and the two who died with him were hanged after conviction of murder of a police official in Lahore in December, 1928, and of participation in the so-called Lahore conspiracy, an anti-British development of 1929.
