**Pension Question.**

THE NEWS-REVIEW is in re-  
 ceipt of the following question  
 regarding the state old age pen-  
 sion:

"Would a woman past 75  
 years of age be eligible for the  
 old age pension if she  
 owns any property even though  
 the income was totally inade-  
 quate to maintain her? If she  
 drew a pension would she be  
 compelled to give a lien on her  
 property to reimburse the state  
 for any money paid her?"

As we understand the law—either  
 the 1933 old age pension act or  
 the 1935 act and its amendments—  
 the pension is for the aged aged.  
 Under the terms of the act, real  
 property owned by the pension ap-  
 plicant is pledged to the state as  
 security for the pension payments.  
 The person who receives the pen-  
 sion, or his heirs, may redeem the  
 property upon payment of the  
 amount paid in pensions plus an  
 interest charge of three per cent  
 per year on the money. The home,  
 or other property of the aged per-  
 son, remains in his possession.

The News-Review is informed  
 that the state pension is granted  
 upon the basis of need. If an ap-  
 plicant has a small income, from any  
 source whatever, he is not barred  
 from receiving a pension although  
 the county court will consider the  
 other income when setting the  
 amount of the pension. The aim is  
 to add enough to the applicant's in-  
 come by means of the pension, to  
 care for actual need.

The passage of the sales tax will  
 not change these principles of the  
 existing old age pension system in  
 this state.

**Steamboat Camp Filled.**

THE CCC administration and the  
 forest service have kept faith  
 with this community. The fears ex-  
 pressed by the News-Review, not  
 long ago when it was announced  
 that the CCC company stationed at  
 Steamboat was to be taken out,  
 were groundless. A new company  
 has been sent to the Steamboat  
 camp and the work on the road up  
 the river has proceeded almost  
 without interruption.

The News-Review, remembering  
 the experience of last summer  
 when the company was removed,  
 feared that we might see a repetition  
 of what happened then. Last  
 year, you may recall, the Steam-  
 boat camp was vacated early in the  
 spring with the assurance that an-  
 other company would be sent in  
 immediately. The other company  
 failed to appear until late in the  
 fall so an entire summer's work  
 was lost. It developed, however,  
 that the trouble last summer was  
 due to the fact that CCC enlist-  
 ments fell off to such an extent  
 that the companies could not be  
 recruited as rapidly as was ex-  
 pected.

We are fortunate in the present  
 instance, in not having the Steam-  
 boat camp removed entirely. The  
 CCC program has been sharply cur-  
 tailed but through the efforts of  
 the forest service and local peo-  
 ple, the Steamboat camp was kept  
 on the list.

Now if a CCC company at Dia-  
 mond Lake can work toward Steam-  
 boat and the Steamboat company  
 continues on up the river, we shall  
 have a connecting road between  
 Roseburg and Diamond Lake before  
 too very long.

**HERE** are some more questions,  
 to which TRUTHFUL answers  
 would be interesting:

How much money was collected  
 for the Hauptmann defense fund?  
 Who contributed the bulk of this  
 money, and how much of it came

 are naturally anxious to place as

many obstacles as possible in the  
 way of enforcement of the death  
 penalty?

What was the money spent for,  
 and how, and was any of it spent  
 for the purchase of manufactured  
 evidence designed to discredit the  
 conviction of Hauptmann?

THERE are plenty of people, of  
 course, who could answer these  
 questions. The trouble is that most  
 of us would refuse to believe the  
 answers these people would give.

IT IS unfortunate that questions  
 such as these must be in peo-  
 ple's minds.

The fact that they are there in-  
 dicates lack of confidence in the  
 machinery we have provided for  
 the enforcement of law, and that is  
 a serious thing.
