### Too Many Demagogues.

WHEN the constitutional convention was in session in an effort to bring forth a document of government that would weld into one nation the thirteen independent colonies, two opposed ideas, among the many contentions, troubled the constitution makers. One group held that there was scant chance of getting the colonies to approve a sound and proper document and therefore favored the adoption of something that would get the votes without regard to merit. The other group, led by George Washington, stoutly maintained that the convention should sanction only a document that it believed right.

"If, to please the people, we offer what we ourselves disapprove, how can we afterwards defend our work?" asked Washington, and turned the tide. When the convention adjourned, few if any of its members believed that the colonies would ratify their work but they had offered something they could defend and were satisfied.

But that was 150 years ago. Public leaders of that time apparently had more courage and more sound judgment than the so-called leaders of today. Politics in America is now completely overrun by demagogues—men who advocate that which they do not believe solely because they hope thereby to get votes for themselves.

Any scheme is adopted by office seekers nowadays if it offers the possibility of votes. Veterans sought little legislation for themselves. Politicians, hoping to win support of veterans introduced nearly all of existing veteran legislation. Rural electrification is offered, not at the request of farmers but because it sounds like beneficial farm legislation hence worth votes. Tax plans bear heavily on the "soak the rich corporations" chord and the billion dollar tax bill is declared necessary because of what? Because there was too much spending? No. The supreme court is blamed for the high taxes!

We are in the grasp of the demagogues—but not hopelessly. We still have the ballot and need only to use it intelligently.

## TOP MOVIE STARS OF 1935 CHOSEN

McLaglen and Bette Davis Win Awards; "Mutiny on Bounty" Best Film.

HOLLYWOOD, Calif., March 6.—(AP)—The movie industry wrote "Best of 1935" today after the names of a tiny actress, towering ex-soldier and a salty epic of the sea.

Bette Davis—Victor McLaglen—"Mutiny on the Bounty."  
As symbols of peerless entertainment last year on the screen, gold statuettes were awarded to these three by the Academy of Motion Picture Arts and Sciences.

The eighth annual awards banquet last night, staged with an unprecedented fanfare of excitement and controversy, was boycotted by powerful guilds of actors and writers on the grounds the academy is "producer-controlled."

Of the 1,250 attending, about 10 per cent were from the acting branch of the industry, the smallest representation in several years.

But the academy's honors went chiefly to persons outside its membership.

Its poll gave Katharine Hepburn second place for "Alice Adams," and Elisabeth Bergner third for the British-made "Escape Me Never."

Paul Muni, a surprise "write-in" selection, closely contested with McLaglen, but finished second for his work in "Black Fury." The exact vote totals were not announced.

Charles Laughton, nominated with Clark Gable and Franchot Tone from the cast of "Mutiny on the Bounty," was third.

Only 2 of Academy Of ten players nominated for excellence awards, only two belonged to the academy, Gable and Miss Hepburn. The latter is on the suspended list for non-payment of dues.  
"The Informer," the picture that raised McLaglen from hardboiled wise-cracking roles to the pinnacle of movie artistry, was second choice among productions, followed by "Captain Blood."  
Only a few seasons back, Miss Davis was ready to leave Hollywood, her contract cancelled by her studio, but George Arliss asked her to stay and play in his next picture. She did. She is the wife of Harmon O. Nelson, childhood sweetheart and orchestra leader.  
McLaglen, London-born, but a naturalized American, is 50, served in the World war, once boxed Jack Johnson, and found a screen niche in "What Price Glory" with Edmund Lowe. Producers "typed" him as a "sex-you" character and he had a rep for repeating the part in picture after picture until "The Lost Patrol" gave him a welcome chance for something different.  
Last year "It Happened One Night" was voted the best picture of 1934 and its stars, Gable and Miss Claudette Colbert, received the acting awards.

### TEXAS REMEMBERS HEROES OF ALAMO

SAN ANTONIO, Tex., March 6.—(AP)—Texans remembered the Alamo today and the 180 heroes who died within its walls 109 years ago.

Patriotic ceremonies included the presentation of the flag of that state, states and 6 foreign countries whose sons were slain within the Franciscan mission building in Texas' war for independence from Mexico.

Governor McAllister of Tennessee presented the flag of that state, the former home of Sam Houston, first president of the republic of Texas.

Not a member of the garrison survived the storming by General Santa Anna's troops, March 6, 1836.

### SOCIALIZING OF MEDICINE RAPPEL

PORTLAND, Ore., March 5.—(AP)—Dr. George H. Winter, president of the American Dental Association, vigorously assailed proposals for socialized medicine here today.

He called upon 200 dentists at the annual convention of the Oregon Dental association to unite against "this danger."

He opposed "any plan of socialized health service that will include the major part of the population, whether it be by taxation or by compulsory payments."  
Reviewing the history of socialized medicine in England, Austria and Germany, he declared "this is not the time for outside agencies to interfere with progress in the science and art of dentistry."

## F. R. VOWS AID TO CHAIN STORES' FOES

WASHINGTON, March 5.—(AP)—In a conference with President Roosevelt, a delegation of independent business men asked today that, "if necessary," he send congress a special message urging quick passage of the Robinson-Patman bill to end "discrimination" favoring chain stores.

J. A. O. Preuss, counsel for the National Association of Retail Druggists, said afterward the meeting was satisfactory.  
The merchants went to the White House as Senator Borah of Idaho, candidate for the republican presidential nomination, took the first step in his "trust busting" campaign by urging passage of a somewhat similar bill.  
The Robinson-Patman measure would prohibit the granting of "discriminatory benefits"—such as special rebates, advertising allowances and other large purchases. Present law forbids "unduly discriminatory" prices only.

### U. S. LOSES ROUND IN PENSION FIGHT

WASHINGTON, March 5.—(AP)—Justice Jennings Bailey of the District of Columbia supreme court today overruled a motion by the government to dismiss the injunction suit brought by 135 major railroads to test the constitutionality of railroad pension laws.

The case now must be tried on its own merits. No dates for hearing have been set.

A railroad retirement act adopted by the previous congress had been declared unconstitutional by

the United States supreme court. In the present suit, all the nation's class 1 railroads joined in the attack on the constitutionality of the substitute laws — a pension act and a separate payroll tax law.
