LABOR RELATIONS ACT KNOCKED OUT

CHICAGO, March 24.—(AP)—Federal Judge John P. Barnes terminated the national labor relations act unconstitutional today and said he would grant an injunction against the national labor relations board in favor of the Bendix products corporation, South Bend, Ind.

He instructed attorneys for the corporation, a subsidiary of the Bendix Aviation corporation, to draw up a finding of fact on which his injunction would be issued.

The corporation had asked the order to enjoin the board from holding an election among its employees. The election was to determine whether local No. 1 of the International Automobile Workers or the Bendix Employees association would represent the employees in collective bargaining.

The judge's written opinion said: "The combination of majority rule and compulsory unilateral arbitration is the heart of the act. Take these out and the act is gone. Consequently, it is concluded that the whole act is unconstitutional and void."

In another paragraph he said: "If the act be so construed as to interfere with the control of the corporation's relations with its production employees, it is in violation of the 10th amendment as an invasion of control over purely local affairs."

RATTLER "RACKET" ON BOUNTY HINTED

BOLTON LANDING, N. Y., Mar. 24.—(AP)—Warren county officials are getting suspicious that some "rattlesnake bootlegging" is going on.

The officials recently increased the bounty offered for dead rattlers from \$1.50 to \$2.50 in a campaign to rid Tongue mountains of its oversupply of snakes.

So many snakes have been brought in since then that the Warren county officials suspect some of the rattlers are being especially imported from nearby Washington county—which has snakes, too, but pays no bounty.
