Back to Self-Support.

NO MORE aid is to be given to employable persons on relief rolls or to families that include an employable person if work is available. This is the announcement of the Douglas county relief committee. Exception is made in cases of legitimate reason for refusal to accept work. Linked with this action by the relief committee is a request for the lifting of jobs by farmers, ranchers, lumber camps and other industries in order to facilitate the contact of jobs with the jobless. Along with the county committee's tightening of relief requirements comes public notice from the WPA administrator at Portland that workers' acceptance of private employment during the spring and summer months will place them on a preferred status for future federal jobs. District directors have been instructed to close down projects wherever they are in conflict with harvesting or other private activities paying wages equivalent to the WPA scale. Thus it will be seen that there is a determination to restore idle employables to a self-supporting basis, and to relieve private industry of competition in hiring when it can at least meet project wages. This is as it should be if economic conditions are to be restored to normalcy. But the task is not so easy as it sounds. The spirit of individual initiative has been greatly sapped during the past three years of relief administration, private industry continues to grope through clouds of uncertainty, numerous strikes evidence the dissatisfaction of many who had employment and the congressional plans to continue relief appropriations, while unquestionably necessary, offer in a way encouragement to some of the able-bodied who still prefer to accept federal aid in lieu of jobs. Altogether, it is not an encouraging picture. Rather, it is a warrant for pessimism. Let us hope, however, that the good sense and the best of American manhood and womanhood that pulled the nation out of past economic miseries in the past will soon manifest itself in general betterment and stable conditions—that in spite of gloomy prophecies, political demagogues, inflammatory agitation, government blundering and fantastic schemes, the country will right itself by both individual and collective efforts, with the initiative of the former, as in the past, playing the dominant role.

Beware of Rabies.

THE state board of health, pointing to the "steady increase in the number of people who have been bitten by vicious dogs," urges citizens to give "the strange or stray dog a wide berth." Most of the danger from vicious dogs comes from the carelessness of owners who allow their dogs to run at large unmuzzled, said Dr. Frederick D. Stricker, state health officer. He warned owners not to fondle sick pets. "If bitten by a dog, the wisest thing is to have the wound cauterized with fuming nitric acid," the officer said, adding:

"Not everyone bitten by a rabid dog will develop the disease, but once the infection has developed there is no cure. For this reason, everyone bitten by a dog suspected of having rabies is advised to take the Pasteur treatment."

To Dr. Stricker's timely warning and advice should be added strict enforcement of the impounding law. A stray dog should not be permitted to run at large. If not a menace to public safety, a dog can be a menace to private property. He can be man's enemy as well as his friend. It depends chiefly on man, and if man suffers

THE Wolf Creek forest camp, under construction by the forest service on Little river, about a

quarter of a mile below the ranger station, will afford a mighty pleasant place for campers and picnickers to stay when it is completed. The Service has had a crew of men working intermittently there for some time, clearing out brush, marking out camp

sites, building stone stoves, big cedar tables and benches, piping spring water, etc., and constructing other necessary conveniences.

The camp is built in two units, both right on the banks of Little river, in a long narrow flat below the road. The lower camp is for overnight parties, with room for the erection of tents. The upper site is for picnic parties, with lots of tables and fireplaces in both camps.

The tables and benches are built of great cedar slabs, and are real works of art. They are exceedingly well constructed and strong, as a picnic table needs to be.

Plans are being considered for a joint ball diamond in a meadow adjoining the camps, and for a swimming pool in the river. The camps are shaded by a fine growth of trees, and should prove a popular stopping place. The distance from Roseburg is, I suppose, between 25 and 30 miles.

Carl Messing, forest service foreman, lives in the Wolf Creek ranger station. Mrs. Messing and her two twin daughters, Jean and Jane, are spending the summer there too, and they have a pleasant place to live. The new station house is of log construction, with large light rooms, and as fine a fireplace as I have seen for a long time.

The twins, 31 years old, are having the time of their young lives, and want to enter the forest service, too, when they grow up.
