SAN FRANCISCO "reformers" have unearthed a really juicy bit of scandal and graft in the police department. An investigation revealed that a surprising number of the San Francisco policemen were very wealthy men. Upon inquiry as to how he obtained his wealth, one officer stated that he had saved it out of his salary—but further inquiry revealed that the bank account he then possessed was greater than the total amount paid him in salary. The expression used there now is "as wealthy as a city cop."

PLANS are nearly completed for converting the forthcoming convention of the democratic party into a sort of great celebration. The nomination of Franklin D. Roosevelt is generally conceded, so to make the trip worth while for the delegates there will be a big show—sort of a "pageant of prosperity." Meanwhile the opposition is becoming solidly organized behind the Landon-Knox ticket. The election battle this fall will be a "honey."

"DEMOS Open Fire on G. O. P. Planks" said a headline in yesterday's paper. Just so the fire does not destroy the platform entirely, a little shooting will be a good thing. Last election the winning party platform went up in smoke almost at once with no single plank remaining.

MILLIONS out of work, underpaid college professors and others sorely afflicted by the prevailing financial stringency will doubtless feel deep sympathy for the promoters of the Louis-Schmelzing prize fight, scheduled in New York City tomorrow night. A gate of not less than \$1,000,000 was anticipated, whereas latest press dispatches indicate that the receipts may not exceed \$750,000. The latter sum, the public is further advised, will limit the two principals in the fistie exchange to a paltry \$200,000 each. This makes one realize that civilization's greatest benefactors, such as super artists in the field of legalized assault and battery, must accept less and less for their up-lifting endeavors. Soon they will have to be content with earnings no higher than that paid to mere scholastic educators and others of minor importance in our scheme of life.

A prospect for improved weather conditions was held out by the weather bureau today. Indications, it was stated, point to a break in the current storm tonight. Unsettled conditions are expected to prevail until about 9:30 p. m., after which clearing weather is anticipated.

STORM DAMAGE IN LANE COUNTY HEAVY

EUGENE, June 17 (AP)—Orchard crops, stretches of hay, and to some extent grains have suffered considerably in this section during torrential rains and hail storms of the past few days. The storms have been hitting only in strips, however. Hay is the worst hit of the crops.
The section north and northwest of Creswell was struck by a damaging hail storm Sunday afternoon, stones measuring one and

one-half inches in diameter falling for a few minutes.

FIVE MEN FINED FOR DRUNKENNESS

Fines for drunkenness were imposed in the city court by Recorder A. J. Geddes today upon Carl Chenoweth, Wm. L. Miller, Howard Velzian, Albert Stone and Louis Clark all of Roseburg. Fines of \$10 each were imposed on the defendants with the exception of Clark, who was sentenced to pay a fine of \$15. Fines were paid by Chenoweth and Stone, while the others are serving out the penalties in jail.

HALF-YEAR MOTOR RATES MAY BE PAID

One-half year license rates on motor vehicles will be accepted on and after June 20, Sheriff Percy Webb was advised today, and the sheriff's office will issue temporary stickers upon payment of the one-half year fee starting June 20. The half-year rates do not apply to passenger vehicles, which pay the flat \$5 fee, nor to dealers and wrecking houses or vehicles licensed by the state, county or cities.
