## Cooperation in Fire Prevention Asked By Forest Service as Public Prepares For Outdoor Recreation Over July 4th

The Umpqua National forest administration wishes the public to enjoy the recreational facilities of the forest to the utmost over the 4th of July and throughout the summer, but hopes for cooperation with forest officers in the prevention and suppression of forest fires. V. V. Harpham, supervisor, declared today.

Mr. Harpham calls attention to prescribed rules, and urges persons using the forests during the coming and future week-ends to cooperate by observing such regulations.

- The following acts are prohibited: 1. Building a campfire upon any national forest land without first obtaining a permit from a forest officer, except in a safe stove or at a designated forest camp where camp fire permits are not required, as shown by posted notices. 2. Smoking while traveling in timbers, brush or grass areas, except on paved or surfaced highways. 3. Going or being upon any national forest land, except at designated and posted forest camps with automobiles, other vehicles or pack horses, with the intention of camping thereon, without being equipped for each vehicle or pack train, with the following fire fighting tools: (a) one axe not less than 25 inches in length overall, with head weighing two pounds or more; (b) one shovel not less than 25 inches long overall with blade not less than 8 inches wide; (c) one water container, capacity of one gallon or more. 4. Pulling a camp fire in leaves, grass, or rotten wood, or other dangerous places, or in windy weather, without clearing around the fire pit and confining the fire to a hole. 5. Leaving any fire to burn unattended or failing to totally extinguish a fire before leaving it. 6. Throwing or placing a lighted cigarette, pipe heel, match, firecracker, or other lighted substance, or discharging fireworks in any place where they may start a fire. The latter rule, Mr. Harpham states, prohibits the use of firecrackers at any place within the national forest, as well as applying to any other place outside the national forest where such fireworks might start a fire.

## PRISONER TAKEN IN CHASE IS ACCUSED

nia authorities, who have wired the state police office here that they will return him to Oakland.

## Aroused Suspicion

Wilson was first taken into custody yesterday near Glendale junction, when the state policeman became suspicious that the car was "hot" because of crumpled license plates, which bore holes indicating that they had been on another vehicle.

When Wilson was unable to produce title papers he was placed under arrest for failing to have such documents, and his companion was held for vagrancy.

Under orders to proceed to Roseburg, with the officer following closely behind, all went well until the cars were a short distance south of Roseburg, when Wilson accelerated his car and attempted to elude the patrolman. He swung through the South Main street cut with Hoxie in pursuit and continued north on that street to Court street, when he made a perilous turn to the highway.

He missed the highway at the intersection with Jackson street, going north on Jackson until he realized his mistake, then swung over to West First and out to the highway where he turned north.

The pursuing officer cut across highways and parkways in the mad dash to overtake the fugitive and closed the gap considerably as Wilson reached the north city limits.

Traffic interfered with the high-speed chase until the cars reached a straightaway about two miles north, where the officer had an opportunity to open fire without endangering innocent persons.

Shooting left handed while traveling in excess of 75 miles an hour, Hoxie put the first bullet through the license plate and into the body of the car. The second hit the spare tire and the third ranged lengthwise through the auto from the rear window to the windshield.

The last shot cooled Wilson's ardor and he immediately stopped and surrendered.

Anderson left the car while it was travelling about 65 miles an hour on Jackson street. He was hauled over several times in his mad leap, but escaped with only minor injuries.

Deputy Sheriff Clifford Thornton, who had heard the screaming police siren, had joined the chase and picked up Anderson, then followed the race north, arriving shortly after Wilson had surrendered.

The two men were brought back to Roseburg for questioning.

Wilson, according to the police report, had resided until recently at Los Angeles. He drove his car to San Francisco, where he abandoned it, then went to Oakland and bargained for a car from the McDowell's Sales company, Oldsmobile agency. He asked permission to drive the car, a used Ford V8, for a trial, according to his reported statement, promising to

return the machine and pay the purchase price within an hour, if the car proved satisfactory, but instead proceeded north.

He confirmed Anderson's statement that the latter was a hitch hiker and had no part in the theft. The state police office said this morning that Wilson's statement concerning the manner of the theft of the car had been confirmed from Oakland.

Record Cited  
California authorities informed the state police here, it was reported, that Wilson was sentenced September 7, 1935, in Los Angeles county, to two years in the penitentiary on a bad check charge, but that he had been given a parole.

The California officers are preparing to return him to Oakland on the car theft charge.

Anderson was taken before A. J. Geddes, city recorder, acting in place of Justice of the Peace R. W. Marsters, who is absent from the city, entered a plea of guilty to a charge of vagrancy and was sentenced to jail.

## HERE'S ANSWERS TO HOW'S CAMPING

### Fishing Conditions in This County Also Included in Forestry Bulletin.

For the benefit of persons desiring to use the national forests over the week-end, the forest service here issued a bulletin this afternoon giving latest available information on road and stream conditions.

In the South Umpqua district the road to Camp Conifer is reported to be passable but rough. Trout fishing is reported to be good in the upper tributaries of the South Umpqua river. Fish lake is not as good as a week ago. The Tiller-Trail road is good to the summit, but is rough on the Jackson county side.

In the Bohemia district fishing is reported fair in the small streams. Brice creek road is in good condition to the summit of the mountain above the Champion mine. The Sharps creek road is very rough. Wild flowers are starting to bloom. Cars may be driven to the summit of Fairview lookout where a fine view is available of much of the Umpqua and upper Willamette watersheds.

Steelhead fishing is reported fair in the vicinity of Steamboat on the North Umpqua. The road to this point is rough but always passable. Cars may be driven July 4 and 5 to Glen Echo, five miles up the main river above the mouth of Steamboat creek. The road up Steamboat creek is open for 6 1/2 miles to Steelhead creek. Canton creek camp, with approximately one dozen stoves and tables in good shape for use by the public. Wolf creek camp at Wolf Creek guard station was recently improved, with the addition of a baseball diamond, five new camp stoves, tables, fireplaces, etc. Foot or horse trails both up and down the side of the river at Steamboat are in good condition for travel for approximately two miles each way.

Fishing for small trout is reported very good both on the North Umpqua and Little river.

Lake fishing at Diamond lake is reported fair, with few limit catches, but some rainbow trout as large as eight pounds have recently been taken. Fly fishing in streams of the Diamond lake district is reported fair. All roads and trails are open for public travel. Approximately 29 new tables and stoves are available for public use at Diamond lake and dining room service is available for those who prefer not to do their own cooking. Cabins for the week-end at Diamond lake lodge have all been reserved.

Attention is called in the bulletin to rules prohibiting smoking while traveling, requirements for a shovel, axe and water bucket as equipment if camping in the for-

ests; regulations against leaving fires unattended, and restrictions prohibiting the use of fire crackers within the forest.

The fullest public use of the forest is invited by the forest service, but cooperation in prevention of fire is requested.

Steelhead fishing is reported fair in the vicinity of Steamboat on the North Umpqua. The road to this point is rough but always passable. Cars may be driven July 4 and 5 to Glen Echo, five miles up the main river above the mouth of Steamboat creek. The road up Steamboat creek is open for 6 1/2 miles to Steelhead creek. Canton creek camp, with approximately one dozen stoves and tables in good shape for use by the public. Wolf creek camp at Wolf Creek guard station was recently improved, with the addition of a baseball diamond, five new camp stoves, tables, fireplaces, etc. Foot or horse trails both up and down the side of the river at Steamboat are in good condition for travel for approximately two miles each way.

Fishing for small trout is reported very good both on the North Umpqua and Little river.

Lake fishing at Diamond lake is reported fair, with few limit catches, but some rainbow trout as large as eight pounds have recently been taken. Fly fishing in streams of the Diamond lake district is reported fair. All roads and trails are open for public travel. Approximately 29 new tables and stoves are available for public use at Diamond lake and dining room service is available for those who prefer not to do their own cooking. Cabins for the week-end at Diamond lake lodge have all been reserved.

Attention is called in the bulletin to rules prohibiting smoking while traveling, requirements for a shovel, axe and water bucket as equipment if camping in the for-

ests; regulations against leaving fires unattended, and restrictions prohibiting the use of fire crackers within the forest.

The fullest public use of the forest is invited by the forest service, but cooperation in prevention of fire is requested.
