TROOPS SENT TO IDAHO STRIKE DISTRICT

GUARD COREY EXONERATED IN PRISON DEATH

Shots Fired to Halt Break, Coroner's Jury Finds; Hamilton Battling Lung Wound.

DOUGLAS "LIFER" FED WHILE OTHERS STARVE

SALEM, Aug. 3.—(AP)—There was one prisoner in the Oregon penitentiary who got food while 700 other convicts starved because of their defiance of prison rules.

He was Calvin Corey, who has served more than 45 years on a Douglas county murder charge. A guard gave the old man milk and bread. He took no part in the attempted escape of Friday.

"The old man is fussy and has no use for other convicts," Warden James Lewis said.

SALEM, Aug. 3.—A coroner's jury completely exonerated today the Oregon penitentiary guard who shot and killed Convict Thomas J. Baughn during the riot of 700 prisoners late Friday, holding the shot was fired "in the discharge of his duty in preventing a break from the penitentiary."

The six-man jury of local business men deliberated but a few minutes after taking testimony of officials and guards on duty during the outbreak which resulted in the death of Baughn and injury to two other prisoners.

Testimony tended to show, District Attorney W. H. Trimble said, that the one shot fired by H. H. Corey from tower 6 inflicted the wound on the three men. Two other shots fired by Roy Brenner were sent over the heads of the milling mob.

Without naming the guard, the jury held Baughn met his death.

Mrs. Heinline plans to maintain a home studio for instruction in piano music at Portland.

The conservatory here is to be reorganized for the coming fall season, according to present plans.

Wage Plan Launched

PORTLAND, Aug. 3.—(AP)—Oregon became the starting point today of a new organization to end unemployment—the People's American league, with Joe E. Dunne, former legislator and gubernatorial nominee, as president. Dunne said the organization was dedicated to establishing a \$5-a-day minimum wage scale.

Fish vs. Dams

MARSHFIELD, Aug. 3.—(AP)—Loe splashing, damming of streams and commercial fishing enterprises threaten the beauty and natural fish resources of Oregon's waters. The Oregon Isaac Walton league asserted at its annual convention here.

William F. Finley, national vice-president of the league, called for action to combat interests seeking to dam streams for power and other purposes. He charged that in building Bonneville dam, Oregon was trading the finest salmon stream in the country for power. He also expressed opposition to plans for further damming of the Columbia to create an inland waterways system.

Beavers to Be Moved

LA GRANDE, Aug. 3.—(AP)—The fabled industry of the beaver is going to cause a change in his address. In recent years the dam-building operations of the animals in the Grande Ronde valley have interfered so much with farmers' irrigation problems that federal biological officers have taken steps to trap the beavers and liberate them in forest areas.

PENDERGAST POWER FACES POLLS TEST

ST. LOUIS, Aug. 3.—(AP)—State-wide strength of the powerful Thomas J. Pendergast democratic organization of Kansas City will be tested in Missouri's primary election tomorrow.

Chief interest in a democratic gubernatorial fight are Major Lloyd C. Stark, Louisiana, Mo., nurseryman who has Pendergast support, and William Hieb, militant Columbia, Mo., farm editor and for many years president of the Missouri Farmers' association. Stark repeatedly avowed his faith in the Roosevelt administration.

Hieb likewise supported the national administration. His campaign was an out-and-out attack on the Pendergast faction.

Most active among the trio of republican gubernatorial aspirants was Jesse W. Barrett of St. Louis, former attorney general. He, too, assailed the Kansas City machine at every opportunity. He is opposed by James J. Barrett of St. Louis (no relation) and Claude L. Lambert, of Kansas City.

TOURISTS HURT ON CRATER LAKE ROAD

MEDFORD, Ore., Aug. 3.—(AP)—Miss Mamie Katnick of Thomas, West Virginia, and Walter Newberry of Marlow, Okla., two of seven persons injured in the wreck of a greater universities tour truck last Saturday afternoon on the Crater lake highway, were still in the hospital today.

Miss Katnick is suffering from a broken shoulder blade, and Newberry from a crushed foot.

An examination of Walter Miller of Marlow, Okla., first reported as possibly suffering from a fractured skull, showed he had only a severe head wound.

FARMER SLAYS YOUTH IN DISPUTE

TOLEDO, Ore., Aug. 3.—(AP)—Sheriff Ted McElwain said today that Jesus Caspanson, 55, an Olds farmer, confessed to killing Bob Corbett, 22, Portland, with a rifle last night after an argument over some farm land.

The sheriff said Caspanson shot Corbett three times as the victim sat in his automobile near Otis, berry from a crushed foot.

"Some other fellows were there, too, and all had been drinking but so far we have arrested only Caspanson," the sheriff said.

LOYALISTS OF SPAIN LAUNCH FRESH DRIVE

Repulse of Rebel Armies in Madrid Sector to Be Attempted; Warships Shell Fascists.

MADRID, Aug. 3.—Strengthened loyalists massed their forces today for a fresh assault on rebels in the Guadarrama mountain passes.

Confident leftists asserted they had "no doubt" the onslaught would be successful, at the same time predicting "we will win in the end" over the fascist insurgents.

New columns of liberals were mobilized for action in the north-east where rebels hold Zaragosa and the south at Cordoba and Seville.

The fascists were reported, in advance from the northern side of the lines, to be moving toward San Sebastian in an effort to regain control of the resort town.

Small forces of rebels still held their positions in the mountain gateways to Madrid, these advisers declared.

Renewed bombardment by loyal fliers turned gas and electric plants at Palma, Mallorca island, into a "formidable bonfire."

"After a fortnight's bloody civil war, I can truthfully say the situation from the government's point of view is definitely good," declared Julio Alvarez Delvayo, one of the leftist chieftains.

Reinforcements from Valencia moved into the Guadarrama battle lines in preparation for the expected loyalist advance. The government forces reported today the capture of La Zaida in a renewed drive on the Aragon front against the rebel stronghold of Zaragosa.

Warship in Action

The roar of Spanish guns was heard at Gibraltar today as loyal warships began action against rebels.

One government vessel bombarded the fort at Ceuta, Spanish Morocco, but drew away from the coast seeking shelter behind a British cable ship when the fire was returned.

Other war craft shelled concentrations thirty miles east of Gibraltar.

WITH THE REBEL FORCES ADVANCING ON SAN SEBASTIAN, Near Vera, Spain, Aug. 3.—(AP)—Insurgent fascists, determined to overthrow loyalist victors marched today in a second advance on the frontier city of San Sebastian.

The new campaign was ordered by Gen. Emilio Mola after rebel columns had been reinforced by an estimated 10,000 soldiers from Pamplona.

A basket lunch will be served at noon under the direction of G. W. Burt, chairman of the luncheon committee, assisted by Mrs. Monroe Nance, M. M. Meredith, C. R. Holmquist, Miss Pearl Jones, C. J. Lundsten and Mrs. B. A. Utterback. Entertainment will consist of music and games for both old and young under supervision of the entertainment committee composed of C. J. Lundsten, J. J. Meredith, Miss Myra Kamp, J. W. Payne and Morris Johnson.

Everyone attending the picnic is requested by the various committees in charge to endeavor to be at Umqua park at eleven o'clock to join in the program for the day and get acquainted with poultrymen and their families from other sections of the county.

CROP CONTROL POLICY SCORED BY HAMILTON

Refusal of Wheat Raisers to Join New Deal Plan Aided Nation, G.O.P. Chief Asserts.

ST. PAUL, Aug. 3.—(AP)—National Republican Chairman John D. M. Hamilton today contended the refusal of many wheat farmers to participate in the administration's crop control plan had "saved the nation from a threatening disastrous shortage of a basic food."

In the first address of his campaign organization swing through 15 western states, delivered before party workers, he said "the facts are that in the face of over \$100,000,000 paid the wheat farmers so far for reducing the acreage of the 1935-1936 wheat crop, farmers nevertheless increased their wheat plantings by eight per cent over the plantings of the preceding year. The sowings of wheat this year were 5,000,000 acres more than the year previous."

"There is an indicated world wheat shortage this year. In 1935 wheat imports increased from almost nothing to over 27,000,000 bushels. There are indications for the future much larger imports of wheat from foreign countries than even this alarming volume that has already developed under the farm policies of the present administration."

Pig Slaughter Rapped

Hamilton said "the destruction of 820,000 pigs, the slaughter of 200,000 prospective mother sows and the reduction of corn by 12,600,000 acres" had left farmers without reserve supplies to meet the drought shortage.

He labelled the dairy farmer a "forgotten man as far as Secretary Wallace is concerned" and claimed the reciprocal trade treaty with Canada had "increased eight fold" the importation of cheese from the dominion and doubled the influx of cattle.

WEEK-END MISHAPS IN OREGON KILL 6

(By the Associated Press)

Six persons lost their lives over the week-end in Oregon drowning and accidents.

One of the most tragic accidents took the life of a mother as she and her family tried out a new automobile her husband had purchased several hours earlier on Saturday.

Apparently losing control of the machine on a figure eight curve of the Columbia river highway near Crown Point, Fred Raymond, 47, and his wife and two daughters plunged over a 24-foot embankment, killing Mrs. Raymond and slightly injuring the others.

A plunge over a 60-foot embankment near Newport Saturday night killed Dale Boone, 25, and seriously injured two companions, Clayton Burgess and Bud Harris, all of Toledo.

Leotis H. Garcia, railroad section hand, was run over by a train near Salem. Reports said he was sitting on a speeder when struck. Apparently wading beyond his depth east the life of Wayne Plink, 9, in the Willamette river, near Eugene, and John Theiler, 18, drowned when he became exhausted while trying to swim between two islands in a Columbia river slough. Don C. Phillips, 29, drowned in the Willamette near Salem. He was believed to have been stricken with cramps.

LEOMA LOWDEN OF SCOTTSBURG DIES

Leoma Lowden, 78, a resident of the Scottsburg vicinity for the past six years, died Saturday at the home of his daughter, Mrs. Sadie Nottage. He was born at Seilo, Oregon, July 5, 1858, and for 40 years was a resident of Grants Pass. He was married at Jacksonville, Oregon, to Miss Martha Mee, who died several years ago. He is survived by three daughters—Mrs. Dora Peterson, Oakland, Calif.; Mrs. Sadie Nottage, Scottsburg; and Mrs. Cora Inman, Grants Pass. He also leaves a sister, Mrs. Mary Perrell, Jacksonville, Ore.; two brothers, John Lowden, Oroville, Calif., and William Lowden, Medford, and two grandchildren. Services will be held in the chapel of the Douglas funeral home, Tuesday, August 4th, at 2 p. m. Rev. C. A. Edwards, officiating. The body will be taken to Portland for cremation.

MURDER, SUICIDE RECORDER IN LANE

EUGENE, Aug. 3.—(AP)—Murder and suicide ended an argument between two well known men here, Jess Lowman, about 55, and Jack Vaughan, 55.

R. J. Downing, Lowell storekeeper, told state police that Vaughan entered the store Saturday and engaged in an argument with Lowman, at the climax to which Vaughan fired five shots into Lowman's body.

State police were summoned and found Vaughan in the back yard of his home, the top of his head blown off with a .2030 rifle. Police said Vaughan apparently had been worked into an emotional state through a family matter.

NAVAL CRAFT VISITS PORTLAND HARBOR

PORTLAND, Aug. 3.—(AP)—The Willamette river bristled today with a squadron of the sea power of the American navy—35 trim fighting craft which steamed up the river Sunday and today in a summer visit to Oregon.

Wednesday six more fighting craft will anchor in the harbor to complete the squadron sent here in celebration of fleet week. Some 6700 officers and enlisted men were aboard the vessels, which will remain here until next Monday.

HIGH INDUSTRIAL LEVELS ACCEPTED AS EVIDENCE OF STEADY RECOVERY STRIDE

Bright Business Picture Includes Record Electric Power Output, Busy Steel Mills and Automobile Plants, Peak Freight Movements, Fine Retail Trade; Losses in Crops May Increase Food Prices in Fall.

NEW YORK, Aug. 3.—(AP)—A mid-summer panorama of broad business revival unfolded today as Wall street sought to appraise the autumn outlook.

Busy steel mills, record electric power output, well sustained automobile production, a high level of retail trade, peak freight movement for the year and demand for new equipment by railroads were sketched into the July picture.

Business analysts accepted the latest statistical data as evidence that trade and industry, under momentum of a year of almost unbroken expansion, had held their recovery strides instead of slowing for the hot months in customary seasonal style.

How long the pace would hold was a matter of conjecture. Some authorities have painted the autumn and Christmas outlook in bright colors, taking the mid-summer record as an indication of a powerful underlying recovery sweep.

Others contend that crop losses from drought and a rise in food prices eventually would hit mass purchasing power. They trace the unusual summer showing of sustained business activity partly to the record peace-time outpouring of federal funds, mainly for the soldiers' bonus, and argue the stimulus of this money may be on the wane.

AUTHOR OF TRIBUTE TO LINCOLN DIES

SYRACUSE, N. Y., Aug. 3.—(AP)—Mrs. Mary R. Shipman Andrews, whose story "The Perfect Tribute," has become a classic narrative about Abraham Lincoln, is dead.

The noted author succumbed late last night in a hospital where she underwent an operation nearly a week ago.

First printed in Scribner's in 1906, the Lincoln narrative later was published in book form and sold 600,000 copies.

"The Perfect Tribute" tells of Lincoln's return from Gettysburg, where he delivered his renowned address. Fearful it had been a failure, the story goes, he starts for a walk alone.

He meets a young boy who says his brother, a Confederate soldier, is dying in a Washington prison hospital. He needs a lawyer to make his will.

Lincoln, without identifying himself, goes to the hospital, Mrs. Andrews writes. The prisoner, unable to see his caller, tells excitedly about the wonderful address the president had made.

Lincoln finally realizes that he did not fail, after all.

Born in Mobile, Ala., she was proud to remain, she said, "a determined southerner."

In 1884, she married William S. Andrews, who later became a judge of the New York state court of appeals. He is retired.

WOMEN VICTIMS OF UNKNOWN ATTACKER

PUEBLO, Colo., Aug. 3.—(AP)—Puzzled as to a motive, police searched today for an unidentified assailant who battered to death an aged woman and fractured the skull of her niece as the women lay in bed early Sunday, a four-year old child sleeping peacefully by their side.

Mrs. C. H. (Sally) Crumpley, 72, died before an ambulance reached the house. Her niece, Mrs. Lily McMurtree, 47, is in a hospital, her condition grave.

Mrs. McMurtree's grandson, Burton Beach, did not awaken as the assailant hidged the two women, apparently with a heavy club. The child was unharmed.

French Taylor, district attorney, said the women had no known enemies and there was no large sum of money in the house. He said that, from the absence of a known motive, he judged the slayer was a maniac.

The women's belongings were untouched.

Police said they were without clues.

NINE MINERS DIE IN BATTLE WITH FIRE

DUQUOIN, Ill., Aug. 3.—(AP)—Two southern Illinois counties ordered separate inquests today for nine coal miners killed by carbon monoxide gas as they battled a raging fire deep in the Union collieries' Kathleen mine at Dowell, five miles south of here, Saturday night.

Six of the miners apparently lost their lives as they tried heroically to rescue three companions. Twelve others overcame by the gas were revived.

Mine Superintendent Ed Leming said the fire started when a new transformer installed less than ten hours before exploded and sprayed burning oil.

Owens, American Negro, Ties World Sprint Record at Olympic Games

BERLIN, Aug. 3.—(AP)—Off the marks fast and moving into the lead after the first ten meters, Jesse Owens won the Olympic 100-meter sprint championship today, achieving the first of three gold medals he has set as his goal in the 11th Olympiad.

The brown buckeye bullet, a top-heavy favorite from the start of yesterday's preliminaries in the sprint feature, for the second time in as many days equalled the Olympic and the world record of 10.3 seconds in capturing the title.

Owens' time of 10.2 seconds in yesterday's semi-final was disallowed because of a strong wind at his back.

Ralph Metcalfe, husky Chicago negro flier, finished a yard and one-half behind Owens. Metcalfe was timed in 10.4 seconds.

The American negroes, running one-two for the second straight Olympiad, dominated the event from the start to finish, each winning their semifinal heats and then fighting it out in the final.

Metcalfe also was a close second to Eddie Total, Detroit negro, in the 1932 final.

ENTIRE COUNTY PLACED UNDER MARTIAL LAW

Five Logger Pickets Shot, Other Men Beaten With Chains as Climax to Month's Trouble.

BOISE, Idaho, Aug. 3.—(AP)—Governor C. Ben Ross signed a proclamation today placing Clearwater county—scene of a north Idaho lumbermen's strike—under martial law.

The mobilization order came after a blaze of gunfire on the picket line of the North Idaho loggers' strike sent five strikers to the hospital at Orofino with wounds, and 17 men had been arrested in the investigation of the clash.

Ninety Idaho national guardsmen and officers, under command of Col. F. C. Hummel, of Boise, were ordered to proceed immediately to Orofino, Clearwater county seat.

The strike, now a month old, centers around demands for higher wages and improved working and sanitary conditions.

Sheriff Asks Aid

Governor Ross, before signing the proclamation, said he received this telegraphic affidavit from Joel Wilson, sheriff of Clearwater county:

"Large bodies of men have banded themselves together, and are flaunting the authority of the law and resisting its process;

"Numerous acts of violence have occurred, such acts consisting of mobs beating individuals with dangerous weapons, and a gun fight resulting in the shooting of four men."

"Affiant expects further acts of violence from ambush, by reason of the high feeling existing in said county."
