EDUCATION CHANGE IN OREGON WIDENED

State to Receive \$113,000 Annually Under Newly-Enacted U. S. Law.

WASHINGTON, Aug. 6.—(AP)—The federal office of education predicted today vocational education opportunities in Oregon would be extended to "many more youths and adults" under enlarged federal contributions made possible by the newly-enacted George-Deen act. The office announced that under the act, passed by the 74th congress, Oregon would receive a federal contribution of \$113,298.33 a year for vocational education. The law became effective July 1, taking the place of the George-Elzey act and supplementing funds provided by the Smith-Hughes act.

Under the new act the federal government is appropriating for vocational education in the states and territories more than twice as much money as it provided previously.

States Must Share. The act provides that for the fiscal years 1937 to 1942, the states must match with state or local money only 50 per cent of the federal contribution.

The portion to be matched increases from 50 per cent in 1942 to 100 per cent in 1947.

Oregon's share under the 50 per cent matching program would be \$61,649.29 a year, the education office said.

The education office calculated the federal allotment would be divided as follows, including salaries and travel expenses of teachers, supervisors and directors: agriculture, \$28,282.34; trade and industry, \$31,364.82; home economics, \$35,551.23; distributive occupations, \$10,000.

The allotment for teacher preparation amounted to \$10,000.

The state's annual share was divided as follows: agriculture, \$14,141.17; trade and industry, \$15,828.41; home economics, \$18,825.62; distributive occupations, \$4,500; teacher preparation, \$10,000.

More Chance for Youth. "Approval of this legislation marks the passing of another milestone for education in our nation," said Dr. John W. Studebaker, U. S. commissioner of education. "It means extension of vocational education opportunities to many more youth and adults at a time when such training is very much needed. Farmers, industrial workers, and unemployed youth will be the chief beneficiaries."

There are 19,500 high schools located in centers of 2,500 population, or fewer, in the United States, he said. At present only 5,799, nearly all in rural areas, provide training for agriculture, a scientific management of which "requires careful preparation," he asserted.

"The unemployment problem also looms large in urban communities," he added. "The expanded program should take large numbers of youth off the labor market and off the streets."

"The additional \$3,000,000 provided for trade and industrial education will mean establishment of vocational schools in smaller communities."

From 1929 to 1930 the number of persons employed in manufacturing and mechanical industries increased ten per cent. During the same period the number of apprentices decreased 55 per cent, Studebaker said.

Exploitation Halted. In contrast to previous legislation, Studebaker explained, the new act "eliminates the use of any federal funds for the exploitation of learners as profit-making workers."

The act will extend home economics teaching to more than 300,000 girls in 3,225 high schools not now offering instruction in home-making. In addition adult classes may be organized throughout the nation to serve 200,000 women from homes affected by decreased income.

There are 6,000,000 persons employed in distributing farm and factory products to consumers, Dr. Studebaker said. The new act will open the way for many of "these workers to attend part-time and evening classes for their self-improvement."

Distributive occupations, he added, include retailing, wholesaling, brokerage, selling, and other similar merchandising activities. The new act authorizes an an-

nual appropriation of \$22,355,000, compared with \$10,686,003 a year under previous acts.

DIVORCE ENDS 19 YEARS' WEDDED LIFE

A decree of divorce was granted in the circuit court today in the case of Elwood D. Lewis against Anna Lewis on grounds of cruelty. They were married in Roseburg January 1, 1917. The plaintiff was represented by Attorneys John T. and J. V. Long.

BUTTERSCOTCH PECAN PINOCHE

MRS. GEO. FELT, Jr., Roseburg, Ore.

- 1 cup white sugar
- 1/2 cup brown sugar
- 1/2 cup white corn syrup
- Few grains salt
- 1/2 cup condensed milk
- 1/2 cup butter
- 1 teaspoon vanilla
- 1/4 cup pecans, broken

Put sugar, salt, syrup and milk in saucepan. Stir until sugar is dissolved. Bring to boiling point. Boil to 238° F. or until a little dropped in cold water will keep its shape. Remove from fire, add butter and vanilla and let stand ten minutes. Add nuts, beat until thick and creamy. Pour into buttered pan. When cold cut into squares.

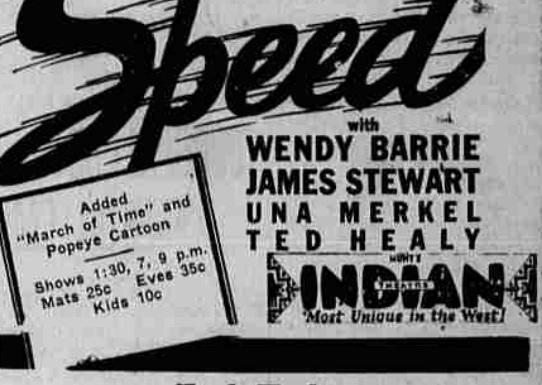
