MINING CONGRESS AID DECIDED ON

South Douglas to Unite in Roseburg Event; Young Fish Planted.

DAYS CREEK, Aug. 26.—(Special.)—At the regular meeting of the South Umpqua Rod and Gun club at Canyonville, Monday evening it was voted to enter actively in the mining congress to be held in Roseburg early in October. A plan to construct a small exhibition building in Canyonville for the display of mineral specimens was adopted. The mining industries of South Douglas will assist in this project.

It was reported that the planting of 100,000 steelhead fingerlings in the South Umpqua and its tributaries had been completed. John Amacher, supervisor of the planting, has planted 30,000 in Cow creek, at the mouth of Applegate, and 30,000 in Canyon creek and its tributaries. Earl Sumner released 20,000 in the South Umpqua at the falls and 20,000 in Deadman creek. J. A. Rhoads put 20,000 in Boulder creek, and 20,000 in Dumont creek. The remainder were planted in Myrtle creek by M. McDougal.
