The Heat Begins.

THE hot breath of scandal may, at this late date, near the blossoming hopes of new deal succession, H. G. Fokker, famed aircraft manufacturer has made an emphatic statement to the United States senate munitions investigating committee that the son of the president was involved in an airplane deal with the Soviet Union (Russia).

Elliott Roosevelt says: 1. That the planes concerned were not military planes; 2. that the commission said paid to him was not, in fact, paid to him but to a "salesman associated with him"; and 3. that there was no truth in the implication that he was endeavoring to make a half a million dollars out of the deal.

But young Roosevelt does not deny that he had a contract with the Fokker company. He does not deny, in fact he admits, that he was to receive a total of \$50,000 for two years "work."

That is a pretty stiff salary for a young man to earn selling airplanes. There is nothing illegal about it so long as the planes are not war planes, and there is no reason why the son of the president should not make as much money for himself as possible. But in this election campaign when the president is talking about saving the common man from the financial clutches of the economic royalists there is something decidedly incongruous in the Fokker-Roosevelt deal.

It is time for some definitions. Just how much money, for example, does it take to make a person an economic royalist? A likely answer would be, any new deal opponent who makes more than five dollars a day is an economic royalist.

The workmen in the Fokker plane shops probably feel that Elliott Roosevelt's contract for \$50,000 salary in two years makes him an economic royalist.

But enough of the scandal mongering. The simple fact is that neither presidential candidate is or has been a benefactor of mankind. Each wants to be elected—and who can blame them? It is good campaign thunder to attempt to draw class lines in this country and to align class against class. It is good, that is, if the sympathies of the class with the most votes can be successfully played upon.

This country has never been class conscious and never will be so long as our free school system is maintained and free speech and a free press exist.

The Roosevelt are wealthy. Had the Russian airplane deal been made young Roosevelt would have had more wealth. Doubtless Governor Landon has plenty of money. Such facts have little bearing on the future of this country.

The great decision to be made on November 3 is a decision between two different, distinctly different, theories of government. The new dealers want the federal government to be all things to all men, they favor regimentation—direction from the top, and the leaning is definitely toward the left, as they say in Europe—or putting it another way, the drift under new dealism is toward socialism. The opposition party believes in more control by the states, less federal domination and a definite trend toward individualism as opposed to socialism.

One or the other of these vastly different theories of government will be chosen by the people on November 3.

PARIS ROUNDS UP FASCIST GROUPS

Raids on 28 Centers Mark Start of Movement to Crush Organization.

PARIS, Oct. 8.—(AP)—Government agents today raided 28 centers of Col. Francois de la Rocque's fascist party in a swift campaign to crush the organization.

Documents seized in the raid were turned over to investigating magistrates to determine whether the social party should be dissolved on grounds it is merely the outlawed croix de feu under another name.

Still defiant after the raiding parties had ended their work this afternoon, de la Rocque charged the government was operating "under orders from Moscow," and was committing acts which "dishonor it."

He declared he would continue his activities.

The investigating squads raided the party leader's suburban home in Versailles, besides descending on the organization's principal and secondary headquarters, the office of the fascist newspaper le Flambeau, the center of the party's "sports society" and the homes of de la Rocque and other party leaders.

(French leftists have charged the party with being a camouflage for activities of the disbanded croix de feu nationalist league.)

Informed sources predicted a government decree dissolving the party would result from the investigation.

Discount Rate Cut.

The bank of France, decreasing its discount rate to the lowest point during the regime of the socialist Blum government, disclosed today a 7,000,000,000 franc (\$159,242,000) rise in the value of its gold reserves.

The gold increase was announced in the first weekly statement of the bank since devaluation of the franc. It was coincident with a decrease of from 5 to 3 per cent in the discount rate, in keeping with France's new easy money policy.

The reduction was the second since devaluation of the franc. Last week, when the bureau resumed operations, the rate was dropped from 5 to 3 per cent to facilitate the flow of capital into productive enterprise following the cut in the gold content of the franc.

The rate on advances against securities was reduced from 4 to 3 per cent today and on 30 day loans from 3 to 2 1/2 per cent.

BROWDER DEMANDS \$50,000 FOR ARREST

TERRE HAUTE, Ind., Oct. 8.—(AP)—Attorneys for Earl Browder, communist candidate for president, has filed suit for \$50,000 damages against Mayor Samuel Beecher and Chief of Police James C. Yates, based on Browder's recent arrest when he came here to address a campaign rally.

In one complaint \$25,000 is asked for loss of time and in another the same amount is sought for alleged false arrest and malicious prosecution.

Browder was arrested on a vagrancy charge when he arrived from Chicago and was held in jail overnight. The charge was dismissed the following morning on notion of the state.

Browder said recently in New York he plans to return here Oct. 10 for another campaign meeting but Mayor Beecher asserted the communist candidate will be jailed again.

WIFE OF OREGON'S EX-GOVERNOR DIES

PORTLAND, Oct. 8.—(AP)—Death last night claimed Mrs. Lena Hutton Olcott, 64, wife of Ben W. Olcott, former governor of Oregon. Mrs. Olcott had been ill for more than a year.

Besides the widow, she is survived by three sons, Chet, student at Stanford university; Gordon, student at Oregon State college, and Richard, student at the University of Oregon.

Also surviving are her mother, Mrs. Owen D. Hutton, and a brother, Harry, of Salem; a sister, Mrs. Oswald West of Portland.

Mrs. Olcott was a native of Salem and received her education there. She became the wife of the ex-governor in 1912 when he was still secretary of state. Noted for her work among charities, Mrs. Olcott was a director of the Albertina Kerr nursery of Portland.

She was long a member of St. Paul Episcopal church at Salem.

SUTHERLIN HIGH SCHOOL COSTS LOW

SUTHERLIN, Oct. 8.—An investigation of per student cost of high schools in Douglas county recently made in the county school superintendent's office in Roseburg showed that the school costs per student were lower in the Sutherlin high school than in any of the other seventeen high schools of Douglas county. Sutherlin's annual cost per student was only \$63.22 and this was closely followed by Lookingsburg with a cost of \$63.37 per student. Highest cost per student was \$174 with the other sixteen schools ranging between, the average being \$168.50. During the school year of 1935-36 the average daily attendance in the Sutherlin high school was 74.1, averaging nearly twenty-five students for each of the three teachers.

This was the highest pupil-teacher ratio in Douglas county high schools. However, Roseburg followed with slightly over twenty-three students for each of their eighteen teachers.

U. S. POLITICAL OBSERVATIONS

President Roosevelt's repudiation of communistic support took the headlines when he spoke at Syracuse, but those who studied his words minutely found another interesting item bearing on the subject of national party alignment.

Four years ago accepting his first nomination at Chicago, Mr. Roosevelt said:

"In this campaign I shall not use the words 'republican party,' but I shall use, day in and day out, the words 'republican leadership.' And that is what he did. Always in the 1932 campaign his attacks were directed at the republican leaders, at the republican administration at Washington, at the republican candidate against him, but never at the republican party.

But at Syracuse, delivering what he called the opening speech of his campaign for reelection, he said: "There is no difference between the major parties as to what they think about communism. There is a very great difference between the two parties in what they do about communism. We in the democratic party, and so on.

Why the change? "Opposes Reverse Situation. Of course it could be assumed that since the president did refer to "the republican leadership" in other sections of the Syracuse address, his use of the word "parties" was nothing but a slip of the tongue, and of no consequence.

Mr. Roosevelt is not given to slips of the tongue, however, when he is making political speeches. He is an old hand at the business, and conceded to be one of the most expert. His remarks at Syracuse were prepared before hand with care—it might be supposed with special care, since this had been advertised as an opening thrust at the opposition.

So when he defined that opposition as the republican party, it is reasonable to believe that he meant something by it. What could he have meant except that the situation had changed since 1932, and that he meant to take full cognizance of the change?

Nor is this working of the presidential mind inexplicable when the conditions of 1932 are compared with those of 1936. Then, Mr. Roosevelt was accepting the nomination of what had been recorded at the polls for twelve years as the minority party. He must split off a part of the majority party if he was to win. He did not propose to denounce and alienate the party as a whole.

Now the latest recorded majority is the other way.

Change Significant. If it is fair to draw any conclusion from this, it must be that the president now regards the republicans who have gone over to his standard in the past four years as firmly welded into the reconstituted democratic party.

Conversely, he now deals with the republican party as definitely a minority party, and he does not hesitate to attack it by name. The change in psychology is a significant one. In its possible long-term effect on political alignments, it far overshadows any question of how the comparatively insignificant communist vote lines up in 1936.

There remains, naturally, the question whether Mr. Roosevelt's judgment about this is correct—whether the republican groups which have supported him have definitely left their party and joined his, or whether they merely have been taking a walk. Perhaps more can be told about that after the election returns are in.
