Egg Imports Increasing.

POULTRYMEN, and those who supply feed and other things to the egg producing industry, are greatly concerned over the fact that the importation of eggs into the United States from other countries is increasing by leaps and bounds.

Within the last two years, foreign countries have increased their shipments of dried yolks alone by more than 100%. In 1932 the importation of this product amounted to 1,192,640 pounds. In 1934 this importation had increased to 2,319,987 pounds. Nor is this the only form in which poultry products are imported. Imports of frozen yolks and of shells have increased proportionately.

In other words foreign imports of eggs in various forms almost equal the total egg production in Oregon—and Oregon is an important egg-producing state.

If egg importations could be sharply limited or stopped entirely, now life would be given an important Douglas county industry in the form of a wider market with possibly a little better price. Some states have already passed laws restricting the sale of imported eggs. The Oregon legislature should give serious consideration to similar legislation, although Oregon is not of course the major market for eggs produced here and federal action will be necessary for actual relief.

SMITH RIVER ROAD JOB NEARS FINISH

Working under unusually favorable weather conditions, the county road crew employed in graveling the new grade of the Smith River road will complete surfacing of a two-mile section this week, the county court reported today.

When the work was started recently it was feared the rain would prevent completion of the job, but the continued dry weather has enabled the trucks to complete the required hauling of gravel.

The county court is in receipt of numerous letters of appreciation from Smith River residents for its work in putting the road in shape for winter travel. It will be the first time the residents of that district will have road connections to Reedsport during the winter months.

As a result of the construction of the road, the Smith River district has been a virgin field for automobile salesmen. Heretofore residents have been required to travel almost entirely by boat, except for a few months during the summer, when those living in the upper district could travel over a forest service road. Since the construction of the county road, nearly every family in the district has acquired a new automobile.

HARPER DELIVERED TO STATE PRISON

Frank Harper, recently sentenced to three years in the state penitentiary, after pleading guilty in the circuit court here to an indictment charging an attempt to obtain property by false pretense, was taken to Salem and turned over to prison authorities this morning by Deputy Sheriff Clifford Thornton.

Harper, who has served terms in state prisons of Kansas and Colorado, and is wanted in various California and Oregon cities on bad check, embezzlement and false pretense charges, recently lost a fine motor car to state officials on extradition to Oregon, following his arrest at Crescent City, California.

In addition to the three-year sentence, two one-year terms were imposed on indictments charging obtaining money by false pretense, the two lesser sentences to run concurrently with the three-year term.

ROBIN REED FIGHTS SUIT FOR DIVORCE

SALEM, Ore., Nov. 26.—Robin Reed, of Reedsport, former Olympic wrestling champion, seeks dismissal of the divorce complaint of Eva I. Reed lodged against him in circuit court here and says he is anxious and ready to support his wife and child but protests against any separate maintenance provision when she is living apart from him as her financial condition shows she possesses \$125,000 of real and personal property in her own right, he says. This, he states, was largely due to the careful care and management which he has given to it.

He alleges that subsequent to the filing of the complaint on October 3, this year, the two became reconciled and resumed marital relations but later she left him and returned to Portland. He says for this reason the complaint should be dismissed, in a further answer he discloses the financial situation of the couple.

He says that Reed's incorporation of a lumbering, owner of a camp-ground and newspaper, produces a net income not to exceed \$500 a year and has produced no more for several years. She owns 192 shares of stock in this enterprise and he owns 201.

The Marion Credit & Finance Agency, in which they are also interested, he says, has a net worth of \$4900 and practically no net income.

Conditional contracts of sale he owns for sale of the amusement devices known as "Loopo-Plopes" have a face value of \$4000 but an actual value of not to exceed \$12,000, subject to the financial ability of the purchaser to pay or on necessity for re-possession.

The defendant, he says, has other personal property to the value of about \$10,000, also three trucks and trailers valued at \$2500, but he also has debts and liabilities of more than \$22,000.

He says when his wife left him and went to Portland she took \$1500 and \$100 from joint bank accounts and household furniture and personal effects valued at \$3500.

He says the last time she departed from home she said she would not return.

NEW PENSION PLAN URGED IN OREGON

SALEM, Nov. 27.—The Oregon legislature in January will be asked to take definite action toward establishing of a national old-age pension system insuring a monthly pension of \$50 to all persons who have reached the age of 65 years. Dr. Frank S. Schultz announced Wednesday.

Dr. Schultz said all members of the legislature had been requested to attend a mass meeting here Saturday afternoon when the pension proposal would be discussed.

Frederic Nelson, Townsend candidate for United States senator at republican primary election, will give an address.

Noted Negro Tenor Billed At Eugene

UNIVERSITY OF OREGON, Eugene, Nov. 27.—A triumphant return engagement of Roland Hayes, famed negro tenor, at McArthur court on the university campus Sunday afternoon, December 6, will provide the year's outstanding concert attraction for Willamette valley music lovers.

The concert, second of the Associated Students' 1936-37 Greater Artist Series, will mark Hayes' third appearance in Eugene. In 1935 and again last February, Hayes attracted near capacity audiences of around 4000, who requested that the world famous artist be brought back.

Hayes' marvelous interpretations of both negro spirituals, of which he is regarded the world's outstanding singer, and art songs by Wagner, Debussy, Franz and Leet-hoven, have won him the plaudits of both critics and music lovers throughout Europe and America.

The songs of the American negro, known where of good music is sung and loved, have been given new dignity and raised to a parity with the finest art songs of the old world by Hayes. His singing of such favorites as "Swing Low, Sweet Chariot," "Water Boy" and "Wee Wee There" is said to be without parallel in the entire musical world.

DIVIDENDS, BONUS VOTED BY PENNEY'S

At a meeting of the board of directors of the J. C. Penney company, held November 24, a dividend of \$1 per share on the common stock was declared for the quarter ending December 31, 1936, according to word received today by Glenn Owen, local manager.

At the same time an extra dividend of \$3.75 per share was declared. Both are payable December 15, 1936 to stockholders of record at the close of business December 1, 1936.

The board of directors also approved the payment of a special Christmas bonus for associates of the company. This bonus will equal two weeks pay for employees in the stores, offices and warehouses of the company who have been regularly employed for over one year, and a proportionate amount for those employed for shorter periods. E. C. Sama, president of this company, stated that this is not a payment on any permanent plan but is additional 1936 remuneration for loyalty and service that have played a part in making this the greatest year in the history of the Penney company. The number of employees affected will be somewhat in excess of 25,000.

SAILOR REPORTED BEATEN TO DEATH

CHARLESTON, S. C., Nov. 26.—(AP)—The body of a young sailor, believed to have been the victim of a maritime strike violence in New York, lay in a morgue here today with an autopsy pending.

Coroner Devereaux brought the body of Charles J. Evans ashore in a coast guard boat from the Standard Oil tanker H. M. Flagler, which he met at sea. A fellow seaman was quoted as saying Evans had been beaten last Saturday night in New York after he had decided to quit the ranks of striking seamen and accepted a job aboard a vessel.

"About six or eight" men gang-ed Evans, the informer related, and beat the life out of him. They knocked him down and kicked the life out of him. Later he died.

Federal authorities prepared to investigate the case. Evans' home was given as Everett, Wash.
