

SCHMELING WANTS CRACK AT BRADDOCK

NEW YORK, Dec. 1.—(AP)—Max Schmeling, who apparently trusts nobody in these United States, is coming here personally to see they do not give him the "old run-around" in the matter of a shot at the title of heavyweight champion James J. Braddock.

From Berlin, the German, who leaped back into the pugilistic spotlight with his surprising 12-round knockout of Joe Louis last June, cabled the New York state athletic commission he would be on hand December 31 when contracts for his promised fight with Braddock next June are scheduled to be filed.

When his September bout with Braddock was postponed because the champion was temporarily kayoed by an arthritis attack, Schmeling sailed for Germany with the promise of both Braddock and the New York state athletic commission that he would be the first to get a chance at the title held by the erstwhile New Jersey longshoreman.

Since then Schmeling has read with considerable alarm reports that they are planning to match Braddock with Joe Louis in a decision in Atlantic City in February. He knows that if Louis should knock out Braddock, the negro would be hailed by the public as the unofficial heavyweight champion.

The New York commission has been trying for weeks to have Braddock post a \$5,000 guarantee that he will go through with his agreement to June.

MINNESOTA VOTED GRID TEAM NO. 1

NEW YORK, Dec. 1.—(AP)—Minnesota's place on top of the national football heap for 1936 is emphasized in the year's final Associated Press poll of sports writers.

The seventh ranking list gives the Gophers a margin of 23 points over Louisiana State. They were picked for the top place by 25 of 35 experts who cast ballots. Nine of the other ten listed L. S. U. first, while the others named Santa Clara's unbeaten and untied outfit.

Over the seven weeks span, the Gophers were picked for first place four times. After their defeat by Northwestern they dropped to second for three consecutive weeks but even then gave the Wildcats a close run. Pittsburgh, which climbed back to third place the final week, and Washington, the Pacific coast's Rose Bowl entry, also have been in the first ten every week. Louisiana State's record shows a steady climb from 13th place to second.

The voting in the ranking poll, on the customary 10-5-3-2-1 basis, gave Minnesota 332 points this week, Louisiana state 309 and Pitt 237. Alabama, which is reported to have the "inside track" for the Rose Bowl nomination, dropped from third to fourth with 218 while Washington was fifth with 216.

Lee charged that Roy Bishop, head of the Oregon Worsted company, also was one of the incorporators of the Foundation plant.

The union secretary said, too, that his group "is willing to arbitrate all issues and abide by the decision" but that Bishop, while consenting to arbitration, "said he would not abide by a decision and resume if the decision proved unfavorable to him."

Walter W. R. May, manager of the Portland chamber of commerce, said he feared loss of the Oregon Worsted company "unless something can be worked out shortly."

CONVICTION OF STRIKER IN ASSAULT CASE UPHOLD

SALEM, Dec. 1.—(AP)—The Oregon supreme court upheld today the conviction of James Carroll, member of a striking seamen's union, for assault on J. Kessler at Portland May 2, 1935, during a strike against employers engaged in oil shipments.

Carroll, charged jointly with Clarence Gradi, and others for assault and robbery upon Kessler

and two other seamen, alleged strike breakers, as they left the "Larry Kohney," was sentenced to six months in the Multnomah county jail and fined \$250 by Circuit Judge Jacob Kessler.

The defendant's appeal held the lower court error, since testimony showed Carroll was not present when the alleged robbery was committed. The court held, however, that the defendant was present with Gradi when coercion was used in forcibly taking the seamen to the place where the robbery was committed.

The opinion, written by Justice P. R. Kelly, stated that it was not an influence "that the jury could find the fact was definitely proved that Carroll desired to assault Kessler. There is direct testimony to that effect." The court affirmed the conviction and sentence.

time in the center of Madrid. The government, reporting heavy insurgent losses, contended its own lines were intact.

During the night the town of Fuenferral, about 3 miles due north of Madrid, was ripped by nearly 40 fascist aerial bombs in what was interpreted as part of the insurgent drive to cut off the Escorial road to the northwest and further encircle the city.

However, it was announced officially that government activity was growing more intense on other fronts.

Victoria, in the north was attacked again, and both Talavera and Toledo in the southwest were subjected to government artillery fire.

The press, calling Madrid the Verdon of the Spanish war, urged an extension of government attacks on other insurgent strongholds to relieve the pressure on the capital and force the fascists to fall back on their old positions. The newspaper Juventud said the insurgent losses since the siege of Madrid began had reached 10,000.

Socialist commanders described the insurgent attack in the north as "the heaviest" since the beginning of the war.

Fascist troops followed up the barrage of bombs and shells tossed into government barricades blocking the entrance of the insurgents into the capital. Government artillery responded to the bombardment immediately while socialist soldiers were rushed to reinforce the entrenched positions on the outskirts.

Rifle and machine gun fire sent a rain of slugs into the "no-man's-land" between the opposing lines. There was no indication as to the possible success of the insurgent attack. Strong government forces have repulsed the fascists during the last few days fighting.

Earlier the barricades around Pozuelo de Alarcón, seven miles west of the capital, halted the fascists' renewed drives on the El Escorial highway, commanders claimed.

(Dispatches from the fascist lines reported capture of Humera, four miles from Madrid, by Gen. Francisco Franco's forces.)

Socialist defense officials decried the insurgent attack as "violent assaults" in the hope of broadening the battle front to take in the entire northern sector.

They said fighting was "well beyond the city" although scattered skirmishes were still going on in battered University city.

The insurgents again attacked the outlying districts from the air, the bombardment being concentrated on socialist fortifications around the model prison.

LOYALIST ARMIES LAUNCH OFFENSIVE IN NORTH

BILBAO, Spain, Dec. 1.—(AP)—Spanish government armies of the north pushed forward on two fronts today in a combined offensive directed at Burgos, seat of the insurgent junta.

Supported by tanks and grenade throwers, the advance proceeded thus:

1.—A "standard army" of the west seized the village of Soncillo, near a main highway to the insurgent "capital," and forged ahead.

2.—East of this force, Basque militiamen from Bilbao fought their way to within 10 miles of Vitoria, which is about 70 miles northeast of Burgos and commands another main road leading to it.

The Basques hoped to take Vitoria, then push along the road to Burgos, arriving there in time to launch simultaneous attack on the fascist "capital" with the Santander army.

A fierce battle, lasting for hours, took place just outside Villarreal. The Basques, preceded by a long line of grenade throwers, drove insurgents out of their positions at the point of bayonets.

Another column charged up Mount Corbea to the west, seized insurgent trenches and captured the source of Vitoria's water supply.

Today the Basque artillery was shelling the Mondrago, or northwestern corner of the triangle, in preparation for an infantry assault. The road from Mondrago to Vitoria was cut.

TOM MIX SETTLES ACTION AT MEDFORD

MEDFORD, Ore., Dec. 1.—(AP)—The damage suit in federal court of Harvey Deck, 73, Gold Hill prospector, against Tom Mix, movie star and circus owner, for \$10,000 was settled out of court yesterday for a "substantial sum," according to Don Newbury, attorney for Deck.

The aged prospector claimed that he sustained injuries when he attended a performance of Tom Mix here last May and was accidentally lassoed by Mix, who attempted to rope a horse.

strengthening of the processes of constitutional democratic government," as the "best means to prevent any future war among ourselves."

Adding that these processes should be made to "conform to the modern need for unity and efficiency" and at the same time to "preserve the individual liberties of our citizens," the president said:

"By so doing, the people of our nations, unlike the people of many nations who live under other forms of government, can and will insist on their intention to live in peace."

Democracy Leads Way

As a second move toward peace, the president urged the American people to "strive even more strongly than in the past to prevent the creation of those conditions which give rise to war."

"Lack of social or political justice within the borders of any nation is always cause for concern," he said. "Through democratic processes we can strive to achieve for the American the highest possible standard of living conditions for all our people."

Men and women blessed with political freedom, willing to work and able to find work, rich enough to maintain their families and to educate their children, contented with their lot in life and on terms of friendship with their neighbors, will defend themselves to the utmost but will never consent to take up arms for a war of conquest."

Trade Barriers Hit

In this connection, the chief executive denounced trade barriers asserting "it is no accident" that the nations which have erected the highest are those "which proclaim most loudly that they require war as an instrument of their policy."

"It is no accident," he added, "that because of these suicidal policies and suffering attending them, many of their people have come to believe with despair that the price of war seems less than the price of peace."

Mr. Roosevelt discussed his proposal for the American nations to stand "shoulder to shoulder" against aggression after asserting "this is no conference to form alliances, to divide the spoils of war, to partition countries, to deal with human beings as though they were the pawns in a game of chance."

Picturing war abroad as a "catastrophe which impends," he said:

Faith in God Needed
"In the determination to live at peace among ourselves we in the Americas make it at the same time clear that we stand shoulder to shoulder in our final deliberations that others who, driven by war madness or by hunger, might seek to commit acts of aggression against us, will find a hemisphere wholly prepared to consult together for our mutual safety and our mutual good."

Peace in America, the president said, must be grounded in faith, but this faith "will not be complete if we fail to affirm our faith in God."

Contending that "plain people everywhere" want peace, the chief executive said:

"Truly, if the genius of mankind has the invention of the weapons of death cannot discover the means of preserving peace, civilization as we know it lives in an evil day."

Purpose Supported

Delegates from all the American states represented here hailed the conference as bearing the "whole-hearted support of citizens of all western world republics."

They gave full credit for the conference proposal to President Roosevelt, who first suggested the meeting last February.

Outstanding among the projects to be considered is United States Secretary of State Hull's proposed neutrality treaty to bind the American nations in strict agreement not to assist belligerent nations in time of war.

The proposal would establish a

permanent consultative committee made up of the foreign ministers of the western countries who would conduct their discussions by radio-telephone and cable action to prevent the outbreak of war involving any American nation.

WASHINGTON, Dec. 1.—(AP)—For eight years, brawny "Gus" Gennerich stood at Franklin D. Roosevelt's elbow watching every movement of visitors and crowds to see that no harm came to his chief.

When Mr. Roosevelt was elected governor of New York in 1928 Gennerich was "horrified" from New York City police department to become his bodyguard. He had been with Mr. Roosevelt ever since.

From his youth, Gennerich was known as a strong man. Almost 30 years ago he was a "one man track team" with the Pastime A. C. of New York.

Later he was a star on the police department track team, besides winning medals for bravery in the line of duty.
