FEHL LOSES ROUND IN DAMAGE ACTION

PORTLAND, Oct. 21.—(AP)—Earl Fehl, former Jackson county judge, lost a motion in circuit court yesterday to bar Attorney General I. H. Van Winkle and Assistant Attorney General Ralph E. Moody from representing Governor Charles Martin in a \$548,000 damage action. Judge James W. Crawford ruled that the governor acted in his official capacity in denying Fehl good time credits on his four-year prison term for the theft of ballots in Jackson county, and was entitled to representation by the attorney general's office. The judge said it was Van Winkle's duty to aid the governor. Fehl charges the governor with "unconstitutional violations" in his complaint.

SCHOOL TO BE INSPECTED AT REQUEST

Labor Department Expert Will Examine Rose and Fullerton Buildings, Word Received. C. H. Gram, state labor commissioner, has been requested to assign a state building inspector to the task of determining the condition of the Rose and Fullerton grade school buildings in Roseburg. A. J. Geddes, clerk of the district school board, announced today that in compliance with the request from the Roseburg school board for an impartial inspection and report, the matter had been referred to the inspection department of the labor commission, where experts in that line are available. Acting upon a recommendation of the Roseburg chamber of commerce, the school board, which finds the Rose school to be rapidly deteriorating and in need of replacement, has asked for an impartial report. Hazard Increasing The board has been advised by its own inspectors that the building, while not yet hazardous, is rapidly becoming so, and replacement will soon be necessary. An effort recently was made to secure approval of a PWA project for reconstruction of the building, but before the application was acted upon the work of the PWA was curtailed. Voters of the district approved a \$55,000 bond issue to meet the district's share in the proposed \$90,000 project, which included as well the erection of a modern building to replace the Fullerton school. Facing inability to secure PWA assistance, the chamber of commerce recommended to the school board that a thorough inspection be made by a disinterested and qualified inspector, who will report on the physical condition of the Rose school property and the need for replacement. New Bond Plan Looms With this impartial report of facts available as undebatable information to the voters, the school board will, upon the chamber's recommendation, submit to the voters of the district, according to (Continued on page 6)

MISSING YOUTH, 3, FEARED DROWNED

Bloodhound Leads Officers to Lake Chautauqua in Intensive Search. JAMESTOWN, N. Y., Oct. 21.—(AP)—A bloodhound, brought here by state police in the search for three-year-old Timothy Heer, led police straight to a dock at Lake Chautauqua today. Police said this increased their fears Timothy, son of a Jamestown business executive, had been drowned. Timothy has not been seen since noon Tuesday when he disappeared from his father's home, 250 yards from the lake. Federal investigators are participating in the search with Sheriff Chadwick. Dragging in the lake since Tuesday has failed to produce a body, and the parents said they had no reason to believe Timothy had been kidnapped. Mrs. Leo J. Heer last night made a motor tour of the fashionable suburb where the family lives, exploring her three-year-old son over a police patrol car amplifier to "come home to mother." Later, Police Chief Charles A. Sandberg said he had rounded up "about a dozen degenerates for questioning" in connection with the tow-headed child's disappearance. Timothy's father, secretary of the Jamestown Furniture Market association, described the boy as "friendly with everybody." He expressed doubt that his son had either drowned or been kidnapped. Sheriff Chadwick said the boy's doctor had told him the youngster "had been ill and could not have walked more than a mile." In connection with kidnapping and abduction speculation, Police Capt. Edward Scholm reported a degenerate recently accepted an eight-year-old girl and attempted to assault her. On land, a force estimated by Chadwick at 1,500 peace officers, boy scouts, American Legionnaires and volunteer neighbors, pushed a highly organized A. TRANSACTIONS TAX RAPPED BY OSBORNE

A. F. L. Official in Oregon Urges Defeat of Move of Townsanders. PORTLAND, Oct. 21.—(AP)—The first organized opposition to the proposed special session of the legislature to enact an old-age pension transaction tax was under way today following an appeal by Ben T. Osborne, secretary of the Oregon State Federation of Labor, to 45 affiliated unions to combat the proposal. "Do not be deceived. A sales tax by any other name is just as odious as if it were called a sales tax," Osborne said in a letter to the unions and to central and district councils. The letter urged that union members refrain from signing petitions being circulated by the Townsend organization asking the session, and that they write legislators opposing the proposed tax if the session is called. It asserted that the suggestion of a transactions tax for pension purposes was a subterfuge for the real purpose of the move being to "relieve large property owners and to prevent the imposition of heavier income taxes upon the larger incomes." The letter returned that Oregon voters had turned down proposals for a sales tax on three previous occasions.

TAHOE CITY STRUCK BY \$100,000 FIRE

(AP)—Fire of unknown origin early today swept through three Tahoe City buildings, including the rebuilt postoffice, causing damage estimated by firemen at \$100,000. The other buildings were the women's clubhouse and the Tahoe Mercantile company. All buildings fronted on Lake Tahoe. The fire started in the mercantile building. The postoffice had been built after a disastrous fire razed it three years ago. At that time firemen were able to save the mercantile building and clubhouse.

CRUTCHES GO INTO GRAVE WITH OWNER

OMAHA, Neb., Oct. 21.—(AP)—Walter S. Jardine, one-time Omaha business and political leader who was a cripple for 78 of his 80 years, had his last wish granted today. His crutches were buried with him. C. H. GOLFING STAR IDENTIFIED IN THEFT OF 1930

"Montague" of Hollywood Accused by Ex-Convict of Role in Deed at N. Y. Roadhouse. ELIZABETHTOWN, N. Y., Oct. 21.—(AP)—Hollywood's golf wizard, John Montague, was identified today as a participant in a \$700 Athlone roadhouse robbery in 1930 by a man who has served a prison term for the crime. Roger Norton, 35-year-old Cleveland, Ohio, truck driver, once convicted of the crime, sat calmly in a witness chair and testified. Montague, then known as Laverne Moore, was an accomplice in the roadhouse robbery. He has admitted he is Laverne Moore, formerly a resident of Syracuse, N. Y., but denied participation in the robbery. Events Recited. Norton, who came here voluntarily to testify against Montague on the seven-year-old charge, told in detail events of the August, 1930, night when Kin Han's roadhouse was held up at Jay, N. Y., 25 miles north of here. Norton said he and Moore were stopped once by state troopers near Schroom Lake, N. Y., south of here, en route to Schenectady after the holdup, and that Moore "talked his way out of it." They parted at Schenectady, Norton said, with Moore explaining he was going to return to his Syracuse home. That was the last he saw of Moore, he added, until brought here to testify against him. Norton testified he and Laverne Moore met William Carleton and John Sherry at Mechanicville, N. Y., and proceeded from there nearly 100 miles to the roadhouse.
