Reverse the Publicity

THE chairman of the Oregon Fish commission has announced that there may be a publicity campaign to "protect the commercial fishing industry from harmful opposition." That is all well and good and would be a reasonable thing to do. But the commission must watch itself when it dishes out publicity to see that the whole story is told. That commission is appointed to serve the people of the state of Oregon—not just the commercial fishermen.

Chairman John Veach said for publication: "The game commission does not propagate a single salmon, yet thousands of licenses are sold to sportsmen who fish at Oregon City (Willamette river salmon)." He doubtless was making reference only to the Columbia river fishing industry in that statement but he should, in all fairness, have pointed out that one of the important activities of the game commission is the propagation of steelhead. Those fish, paid for by game licensees, are taken in commercial nets. This is true of the Umpqua especially and the same statement may apply to other streams as well.

The fish commission has not succeeded in restoring or in even keeping up the run of chinook salmon in the Umpqua though it is making a very genuine effort to do so. On the other hand it was not for the sake of steelheads in the nets at the mouth of the river, the efforts of the game commission would be more than adequate to maintain a good steelhead run in the Umpqua. As it is, without very much increase in the steelhead angling on the upper river, the run of steelheads grows smaller year by year—at least the fishing is getting poorer.

This newspaper has no quarrel with the commercial fishing industry of the Columbia river. It is an important Oregon asset. We believe, however, that the commercial fishing for chinook and steelhead on the Umpqua is destroying vastly more in the way of future recreational value than it can justify by its small annual catch.

Chairman Veach apparently needs to know a great deal more about the entire situation so far as the coastal streams are concerned. Publicity, as goes the saying about charity, should begin at home in this instance. Let the chairman of the commercial fish commission examine the records of the travel information service of the state highway commission. Let him also inform himself as to angling conditions on the upper Umpqua. Such a campaign of publicity would do the state a lot more good than the one the fish commission plans to put out—judging from some of the opening statements.

DODGES DEBTS WITH 12,000 BAD CHECKS

CHICAGO, May 11.—(AP)—Walter H. Wood, 55-year-old plumbing equipment executive, was arrested today after telling an amazing story of check writing.

Assistant State's Attorney Richard H. Austin said Wood told of writing 12,000 worthless checks during the past year in an effort to keep ahead of his creditors.

Arraigned before Judge John J. Rooney in felony court, on three charges of operating a confidence game, Wood was released on a \$1,000 bond.

The prosecutor said Wood's financial troubles began three years ago after he had suffered a \$12,000 fire loss. For several months, he added, Wood cashed more than 1,000 checks a month for as much as \$5,000 a day.

Austin said he kept cashing checks at currency exchanges to obtain funds to pay debts and cover previous checks on his depleted account.

A 18-hour period was required to clear a check by the time it was cleared, Austin said, new checks had been cashed to cover it.

Austin said Wood's financial status was disclosed when operators of a currency exchange sent a check to the bank to be certified instead of clearing it in the usual manner. He estimated creditors would lose \$2,000.

Wood is president of the Modern Equipment company and headed the bankruptcy division of the federal department of justice in Chicago from 1921 to 1928. He was charged with operating a confidence game.

OREGON EVENTS FLASHED FROM WIRE SERVICE

LAFFETTE, May 12.—(AP)—Miss Affie Belle Belcher, 77, lifelong resident of Yamhill county and a past president of the Rebekah assembly of Oregon, died in Portland Monday.

PORTLAND, May 12.—(AP)—The biological survey announced today the United States circuit court of appeals at San Francisco upheld yesterday the migratory bird treaty act prohibiting shooting over baited areas.

The court sustained a lower court in denying an injunction sought by four southern California duck clubs. The clubs petitioned the court to enjoin federal game agents from arresting members hunting on baited grounds.

PORTLAND, May 12.—(AP)—The U. S. marshal's office said that William Robbins, assistant postmaster at Lebanon, was under arrest on a charge of opening and extracting money from the mail. Robbins was freed on \$1,500 bail.

TOLEDO, May 12.—(AP)—R. C. Remrose's three small children saw a large animal run under a farm building. It looked like a dog. What Remrose shot was a six-foot cougar worth \$25 in bounty.

WASHINGTON, May 12.—(AP)—Appropriation of \$500,000 for construction of fish cultural stations and stream surveys by the fisheries bureau on the Columbia river and its tributaries was authorized yesterday by President Roosevelt.

SALEM, May 12.—(AP)—Marcus Hodgson, 70, was found dead yesterday in his apartment. His right wrist had been slashed, and police headquarters listed the case as suicide.

PORTLAND, May 12.—(AP)—Dr. Gerald G. Vandervliet, 29, Nyssa physician, rode from Burns yesterday in an ambulance which stopped every 50 miles to allow him to rest from the pain of a fractured hip.

He was injured in an automobile accident April 29 and lay for five hours in a swamp before aid arrived. The young doctor was brought here on a specially constructed frame to absorb the bumps of the long journey.

PORTLAND, May 12.—(AP)—Three weeks ago Knute Lien lost a wallet containing \$11 on the Columbia river highway. A man who sized himself Harvey Hungry returned the wallet and cash from Detroit. He found the money while hitchhiking. It was just enough to get him home to a job.

PORT TIE-UP PERIL AT PORTLAND ENDS

PORTLAND, May 12.—(AP)—The departure of the Shepard line freighter Sage Brush for Seattle removed the threat of a port closure last night.

CIO longshoremen, ignoring picket lines established by the sailors' union of the Pacific and the marine firemen's union, completed working the cargo just before midnight.

The picketing unions protested against the company's employment of members of the CIO national maritime association, asserting that the action violated a contract with west coast seamen.

Police carrying sawed-off shotguns stood by while the 48 dock workers walked past 200 pickets and unloaded 450 tons of cargo. Ed Coonstein, agent of the SUP, said approximately 150 seamen walked off seven other vessels in the Portland harbor, refusing to return to their jobs until the Sage Brush sailed.

FEDERAL LOSS ON HOME LOANS CITED

WASHINGTON, May 12.—(AP)—The government has lost about \$2,000,000 as a result of taking over more than 80,000 homes under its emergency home loan program, John F. Fahey, chairman of the home loan bank board, told a senate subcommittee yesterday.

Fahey said that most government loans were in homes on which mortgage payments and taxes were delinquent "two and three years."

The \$2,000,000 loss, he said, included interest, as well as back payments, taxes and foreclosure costs. There were 70,000 foreclosures and 12,000 homes were surrendered voluntarily.

Fahey estimated that 250,000 home owners loan corporation borrowers had been delinquent at times but said most of these were repaying the delinquencies along with regular mortgage payments.

Fahey said about 1,100,000 homes had been financed, at an average of \$3,000.

ASIAN EXHIBIT IS VIEWED AT CHURCH

An unusual and interesting display of articles from India and Palestine is attracting much interest this week at the First Methodist church in Roseburg. The display is the property of Rev. S. Raynor Smith, pastor of the church, who spent a number of years in India, and who has traveled extensively through the Holy Land.
