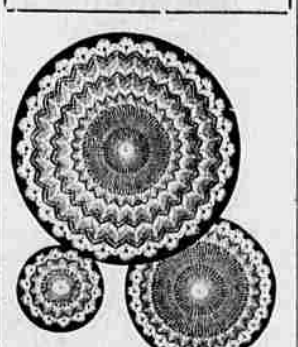
## FLORENCE NIGHTINGALE TENT PICNIC TONIGHT

## CHARLES P. HOWARD, C.I.O. LEADER, DIES

COLORADO SPRINGS, Colo., July 22.—(AP)—Death left unfinished today one of Charles P. Howard's last assignments as president of the International Typographical union and ended his unique position of serving two labor leaders bitterly opposed. The colorful committee for industrial organization secretary, who would have surrendered the presidency to an American Federation of Labor man Sept. 1, died last night at a Colorado Springs hotel following a heart attack. He was 59.

## EX-COP CONVICTED OF SLAYING WIFE

SHELTON, Wash., July 21.—(AP)—A superior court jury today convicted Bernard Leuch of the first degree murder of his wife and recommended the death penalty. The wife, Lena, was found shot to death in their home last June 1, Leuch, former St. Cloud, Minn., policeman, insisted she shot herself because of his relations with a young Olympia girl. Experts testified that the wound and other circumstances indicated she could not have taken her own life. Charles H. Lewis, defense attorney, said he probably would appeal to the state supreme court.

PORTLAND, July 22.—(AP)—Among 130 persons naturalized in Federal Judge Claude McCulloch's court yesterday was James H. Mackie, vice-president of the First National bank of Portland. He renounced allegiance to the British empire.

## RANCHER SLAIN IN FEUD OVER WATER

KINGMAN, Ariz., July 22.—(AP)—Herbert G. Jordan, 63-year-old stockman, faced a murder charge today in connection with the slaying of James M. White, 48, another rancher, in a feud over water in isolated Taweeep valley. Jordan was brought to the county jail by Sheriff Graham from Bundyville, near where the killing occurred Tuesday. Sheriff Graham said he learned the slaying resulted from a quarrel over watering stock at Mt. Trumbull springs. Tanks and pipelines from the spring were on White's ranch, the sheriff said, and White objected to Jordan using them to water his stock.
