

HARD LUCK SWATS LOS ANGELES TEAM

Lillard Snaps Ankle, Mayo Also Hurt; Sacramento Loses to Beavers.

Old Man Hard Luck, who kept the Los Angeles Angels out of the money in last year's Pacific Coast baseball race, caught up with the team again last night.

The hard pressed league leaders lost the services of two of its best players by injuries and a 12-inning game to Hollywood Stars, 6 to 5.

Gene Lillard, strike-out expert of the Angels, will be out for the rest of the season with a fractured ankle received in the 10th inning when he slid into second base. Before he was hurt, Lillard had used his bat to help the Angels tie the score twice. In the fifth he hit a homer with one on base and in the ninth scored the tying run after he turned a fly ball into a two-bagger and came home on a single by Stutz.

The second Angel casualty was Eddie Mayo, second baseman, who was hit in the elbow by a pitched ball. He was sent to the hospital for examination.

Beavers Beat Sacos
Despite their loss, the Angels still held their one-game league lead as the Portland Beavers took a close 4-to-3 game from the second place Sacramento Senators. San Francisco displaced San Diego in third place by beating Seattle 3 to 2 by virtue of a first-inning homer by Jennings. San Diego lost to last place Oakland, 3 to 1, and the Oaks bunched three of their hits in one inning to score all their runs.

Five singles, a walk and a wild throw gave the Portland team all its runs in the first inning. Barton of Sacramento hit a home run in the sixth inning and the Senators then proceeded to fill the bags with only one out. Callow's short fly to right, taken by Froderick, and "Randy's line drive over first base" marred by the Beavers' playing manager, Sweney, ended the rally.

Seattle lost a chance to tie the score in the last of the ninth in-ning when McCormack, Seattle out-fielder, stumbled as he raced from third to home. He was tagged before he could get moving again.

gave Clark 38,689; Pope 35,535.

In addition to the straight out administration issue, other factors which entered into the Pope vote were his stand on reciprocal trade treaties, for which he was praised recently by Secretary Hull and leadership in sponsoring new deal farm policies in the senate.

Short of an open endorsement by the president, Pope had substantial Washington backing. Not only did Hull write him a few days before the primary but Postmaster General Farley spoke in his behalf.

Gov. R. L. Cochran, gave anti-third term tradition in helping in Nebraska's primary yesterday as additional returns today kept piling up his eight to one lead over his nearest opponent with more than half the state's 2,927 precincts tabulated.

Returns from 1,453 precincts in the democratic race gave Cochran 75,547 votes assuring him of re-nomination. His nearest competitor trailed with 60,603. Charles J. Warner was the republican choice.

Ohio Governor Beaten
Reform Candidate Charles Sawyer was virtually assured of the democratic gubernatorial nomination today over CIO-baiting Gov. Martin L. Davey.

Debatable election observers indicated Sawyer's margin might run as much as 20,000.

After holding a comfortable lead, Sawyer said it slowly dwindled as Davey received heavy support from rural counties, but late returns from Cleveland and Summit county (Akron) put the former lieutenant governor back in the lead.

Governor Davey waged a vigorous campaign on an anti-CIO platform and promised to tell John L. Lewis to "go to hell" after the returns were in. John W. Bricker was unopposed as the republican nominee in November.

The campaign was complicated in its closing days by social security board action. Davey was bringing political pressure on old age pension beneficiaries.

In Arkansas the race for democratic nomination for governor had Gov. Carl E. Bailey almost 6,000 votes ahead with three-fourths of all precincts reported.

Returns in the Idaho democratic gubernatorial race gave former Gov. C. Ben Ross 28,275 to 20,941 for Gov. Barzilla W. Clark.

BOISE, Ida., Aug. 10.—(AP)—Rep. D. Worth Clark, who campaigned as a "conservative, not a New Deal democrat" steadily in-creased his lead over Sen. James P. Pope, ardent administration fol-lower, in Idaho's nip-and-tuck dem-ocratic senatorial primary today.

With complete returns from 611 of the state's 802 precincts, Clark, Pocatello lawyer, who told voters he was not "an administration yes-man," had a lead of 2,665 votes—37,077 to Pope's 34,312. Pre-cincts in all of Idaho's 44 counties were represented in the vote.

New Deal Given Swat
For weeks in advance of the pri-mary the contest was regarded na-tionally by political observers as a test of the New Deal's popularity in Idaho and perhaps in the west, because of Pope's close identifica-tion with the national administra-tion and his loyalty to President Roosevelt.

Clark opposed such administra-tion measures as the reorganization and court revision bills and termed himself an adherent to the sola-

tionist philosophy of Senator Borah, Idaho republican, whom he frequently commended in his cam-paign addresses.

Uncle Loses to Ross
One of the important contribu-tors to Clark's lead was Bonneville county, home of two of his uncles, Mayor Chas. Clark of Idaho Falls and Gov. Barzilla W. Clark, dem-ocratic candidate for re-nomination, who apparently was defeated by former three-term governor, C. Ben Ross, in a four-way race for the democratic nomination for the chief executive's post.

Another heavy contributor was Eootenau county, stronghold of Townsend old-age pension plan disciples who endorsed Clark for the senate.

Former State Sen. Donald Callahan, Wallace lawyer, mining man and financier, turned two op-ponents for the republican sena-torial nomination, Walter Ander-son, Pocatello lawyer, and Frank H. Adams, Twin Falls produce dealer and one-time Chicago news-papierman.

Governor Clark conceded his de-feat in a telegram to Ross, which read: "Returns this morning seem to assure your nomination. Accept my congratulations and I assure you of my support."

Opposing Ross in the general election will be C. A. Bottolfsen, Area and Blackfoot newspaper pub-lisher, who defeated R. H. Young, Parma, in the republican gubernatorial primary.

Rep. Conston L. White was un-opposed for the democratic nomi-nation for a fourth term in the first district.

Other Contests
Nine democrats battled it out for the second district democratic con-gressional nomination, Secretary of State Roy H. Yanderson and former Atty. Gen. Roy H. Miller running neck and neck, far in front.

Henry Dworschak, Burley and Idaho Falls newspaper publisher, de-feated Z. Reed Miller, Boise lawyer, for the republican second district nomination.

With 296 precincts out of 413 in the second congressional district the vote was:

Democrat: Miller, 7,821; Mas-ters, 7,522; C. W. Larson, 2,426; Mrs. Frank E. Johnson, 2,359; Glen Taylor, 5,178; D. C. Ray, 2,354; Leo Hood, 6,544; W. C. Thorn-ton, 2,247; Cyril M. Whittle, 1,734. Republican: Millar, 5,629; Dwor-schak, 9,483.

Returns from 588 precincts com-pleted gave these votes for dem-ocratic state officers:

Governor: Barzilla Clark, 20,941; Charles C. Gossett, 16,334; W. P. Whitaker, 8,870; Ross, 28,275.

Under a new two-party ballot, Idaho voters were not required to state their political affiliation. Political observers pointed out it could be possible for republicans to vote the democratic ticket in order to ballot against the ardent New Deal junior senator.

Postmaster General James A. Farley, democratic national chair-man, in an address at Boise July 14, said it was "highly important" Idaho elect a "democratic senator" who will support the president in any program he undertakes.

Farley added "there is no senator in Washington who has been more loyal or sincere in support of the administration than was Senator Pope."

have given Japanese the majority voting power in negotiations to settle the dispute over the exact location of the frontier line.

(Foreign Minister Litvinoff of Soviet Russia told the Japanese ambassador to Moscow the commission should be composed of two Russians and one representative each from Manchukuo and Japan. The concession announced today, therefore, seemed of marked im-portance in diplomatic efforts to settle bitter fighting along the frontier.)

GERMANY APPEARS UNLIKELY TO AID JAPAN MATERIALLY
BERLIN, Aug. 10.—(AP)—Ger-many's position in the Soviet Rus-sian-Japanese border dispute ap-peared today to be that of a watchful observer, unlikely to give ma-terial aid but sympathetic to Japan, which is linked with Germany in a pact against bolshevism.

An outline of the frontier situa-tion was given to Foreign Minister Von Ribbentrop by the Japanese ambassador on Monday.

The Japanese embassy described the ambassador's call as "one of his regular informative talks, especially in view of present de-velopments in the far east where Germany, as a partner in the anti-bolshevik pact, (which also in-cludes Italy) is interested."

There was no further official in-dication of the tenor of the con-versation, but German sympathy has been apparent in denunciations by the controlled press of soviet forces as invaders and peace break-ers.

NEW UNIT OF GUERRILLAS ORGANIZED BY CHINESE

SHANGHAI, Aug. 10.—(AP)—The formation of a "regular army" flying the banners of "loyal and righteous national salvationists" was proclaimed today by Chinese guerrillas at suburban Pootung.

Chinese reports said the touch-and-go fighters, who have claimed repeated victories over Japanese units throughout China, are in-creasing rapidly in numbers in an-ticipation of an expanding guer-rilla campaign.

Rumors grew guerrillas from Pootung across the river from Shanghai, had entered Shanghai's foreign areas and planned ter-rorist celebration Saturday, anni-versary of the start of Japanese-Chinese fighting in Shanghai.

Police found a new hand gren-ade in downtown Shanghai and de-duced it had been dropped hastily by a would-be terrorist. Defense troops, voluntarily units and po-lice estimated to number 15,000 strengthened precautions against the feared terrorist. Apprehension grew.

BOSTON ROOKIE, 38, WINS 16-4 GAME

Bill Harris Triumphs Over Athletics; Larry French Blanks Cincinnati.

Bill Harris, 38, just up from Ital-y, may put the Boston Red Sox back into the middle of the Ameri-can league scrap. Harris, acquired last week to help out the young-ster Boston hurlers, limited the Ath-letics to ten hits, fanned five and came up with a 16-4 victory yester-day.

Yesterday's victory came in a good spot, for the long-leader New York Yankees took a 4-2 set-back from Washington when Chase set them down with six hits and drove in the winning run himself in the ninth inning. Cleveland's second place Indians split a double-header with the Browns losing the first game 4-3 when Mills outlasted Feller, then winning the second 8-1.

Those results put Boston 63 games behind New York and 13 behind Cleveland.

French Scores Shut-Out
In the National league, the Chi-cago Cubs made the best gain when they whipped Cincinnati 3-0 in a mound duel between Larry French and Paul Derringer, and broke a tie for third place.

Pittsburgh's league leaders downed the St. Louis Cardinals 1-0 when Baners hurled a two-hit game, fac-ing only 31 batters, and won it himself in the third when he singled and progressed home on Hanley's double and Lloyd Waner's base hit. The second-place New York Giants snapped their losing streak to beat Boston 5-1 with a three-run seventh and some relief flinging by Coffman.

The Detroit Tigers held to four hits by Knott, beat the Chicago White Sox, 4-1, when York belted his 23rd homer with two mates on deck. The Brooklyn Dodgers ham-mered out 9-6 decision over the Philles.

eight of a mile downstream from the point where Frey fell into the river. It had been carried across the stream and was lodged against a rock in shallow water.

Darrell Smith, son of the camp foreman, swam across the river with a rope with which the body was brought back across the stream.

Efforts to Revive Futile
Lieutenant Sleeter immediately started artificial respiration, al-though the body had been in the water from 30 to 45 minutes, and at the same time sent in a call for an inhalator, which was rushed from Roseburg by Deputy Sheriff Clifford Thornton. After more than two hours of labor, however, Lieut. Sleeter found that further resusci-tation efforts were futile.

Coroner H. C. Stearns, notified by Swin, gave permission for the removal of the body, which was brought to the Roseburg Undertak-ing company parlors.

Mr. Frey was an expert fly tier and was in the employ of the Sierra Tackle company at San Gabriel. He was a personal friend of W. H. Gor-don, owner of Gordon's camp at Steamboat.

that the proposed school construc-tion and repair work suggested will be sent back to the PWA as skilled labor will be required al-most entirely.

Swim Pool Outlined
Mr. Hockley showed much inter-est in the plans submitted by J. E. Dent, chairman, and Al Bashford of the Roseburg board of school di-rectors for the proposed swimming pool. The plans as tentatively drawn call for an open air pool 50

by 110 feet in size. The walls would be so constructed that the pool may be covered at some future date. A building, 97 by 31 feet at one end of the pool, would contain dressing rooms, space for heating, filtration and chlorination equip-ment, lifeguard stations, etc. The project is estimated to cost be-tween \$25,000 and \$30,000.

Rather than issue bonds to cov-er the cost of the local participa-tion in the project, the school board proposes to include the item, amounting to about \$13,000, in the regular budget. This will bring the budget to an amount in excess of the six per cent limitation and it will be necessary to call an elec-tion to pass upon the enlarged budget for the year of 1938-39.

Such action by the board would result in a tax increase of approxi-mately two mills for one year only. Thus the entire cost would be paid at one time, eliminating an in-crease in bonded indebtedness and payment of interest over a long period of years.

This plan was explained to Mr. Hockley, who approved of the method, and agreed that the appli-cation could be filed subject to the outcome of the election. It is prob-able that a vote will be taken prior to the budget meeting and the voters asked to authorize the bud-get committee to include the mil-lage levy in the coming budget.

Water District Proposed
Members of the Roberts Creek water district board informed Mr. Hockley that they have practically completed work on their applica-tion and will have it filed in the near future. An election is planned for September 25, at which time residents of the district will be asked to approve bonds in the sum of \$24,000 to provide funds for the local participation in the estimated \$45,000 project.

The district, formed two years ago, plans to take water from Cooper springs, which flow ap-proximately 150 gallons of water per minute, and to distribute it through approximately nine miles of pipe line to more than 50 fam-ilies in Glenary, Roberts Creek and Green districts. The project would cover the cost of a reservoir and pipe lines. The district covers approximately 7,000 acres and in-cludes three school districts which now lack an adequate water sup-ply. Tests of the water, Mr. Hock-ley was informed, show it to be of excellent quality.

ARMSTRONG BIDS FOR FISTIC FAME

Defeat of Ambers Tonight Will Give Negro Crowns of Three Classes.

NEW YORK, Aug. 10.—(AP)—Henry Armstrong, an intelligent little negro with spindly legs and a fantastic amount of stamina, will be shooting at first immortal-ity when he meets Lou Ambers, the lightweight king, in a 15-round title fight tonight at the Polo grounds.

If he beats Ambers, as he is favored to do, Armstrong will hold the featherweight, lightweight and welterweight championships. He will, presumably, have proved him-self the greatest fighting man in the world between the 115-pound bantamweight limit and 147 pounds, where the middleweights begin.

That is a span of 29 pounds, right out of the heart of boxing. No fighter, black or white, has ap-proached such a record before. Every time Henry pumps his tire-less arms tonight he will be aim-ing at a target previously thought beyond any man's reach.

Offhand, the human threshing-machine would appear to have as-sured tonight's victory when he gave Barney Ross, the aging wel-terweight champ, a fearful beating last May. That made Henry cham-pion of bigger men than Ambers according to the books. But Am-ber's has been stubborn, and Henry has to prove it.

As a matter of fact, he figures to have a lot more trouble with Ambers than he had with Ross. Ambers, though colorless, is a clever little man with a fighting heart and good legs. All he needs to make him a great champion is a punch.

Ross, incidentally, has picked Armstrong to win.
