

PORTLAND'S GUARD TEAM WINS SHOOT

SALEM, May 17.—(AP)—Five Portland national guardsmen, members of Company H, 186th Infantry, won the national military rifle team championship, defeating 271 national guard, regular army and army reserve teams from all parts of the nation.

The team, scoring 1,900 out of 2,000 points, also knocked the national guard company title in competition with 219 teams from throughout the country.

Results were received by national guard headquarters here today from the national guard bureau in Washington, D. C. All shooting was on home ranges.

Last year company C, 162d Infantry, Eugene, won the national wide national guard company championship. It placed sixth this year.

The 186th Infantry regimental team placed third in national guard competition against 27 other regiments. It was fourth in the regimental competition against all other national guard, army and reserve teams.

Members of the winning company team and their scores are: Sergeant Kellon R. Peterson, 285; Corporal Valerius Robertson, 280; Sergeant Joseph C. Clark, 271; Sergeant Lloyd J. Hines, 281; and Private Thomas P. Brady, 277. A perfect score is 400.

Besides a national trophy, the winning company will get individual gold, silver and bronze medals to be presented at the Oregon national guard encampment at Camp Clatsop next month.

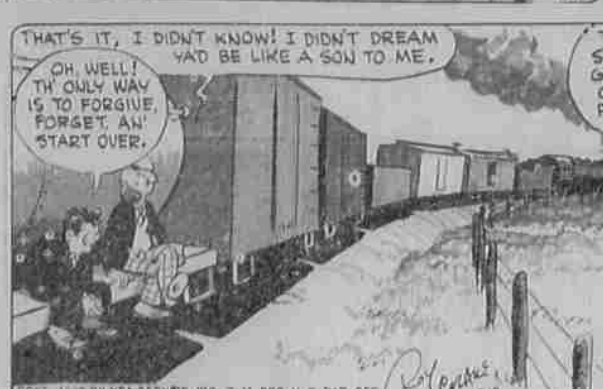
