

LEROY UNBEATEN IN "PRO" RING CAREER

California Scrapper Will Offer Bennet Warm Go on Roseburg Card.

Bobby Leroy, scheduled to box Dallas Bennett, claimant to the Oregon state light heavyweight championship, in the main event of the American Legion's outdoor fight card, Thursday, June 29, is rated as one of the most promising youngsters in California. Pat Padelford, local matchmaker, reported today.

The boxing card will be one of the pinhead events of the program for the opening day of the state convention of the Eagles lodge. The arena will be set up at Finlay field and accommodations will be provided for more than 4,000 spectators.

Tue Wilson of Eureka, Calif., manager of Leroy, informs Padelford, the latter reports, that his fighter has never been beaten in more than a year and a half of professional fighting. Wilson also states that the fighter is a great crowd pleaser. Leroy in his last bout defeated Charlie Crawford, one of the leading California light heavyweights.

He will, however, be up against very tough opposition at Roseburg as Dallas Bennett has been training over the best in his weight division. He is putting in a great deal of hard work to prepare for the battle. He is training in a summer camp in the mountains, where he is doing much climbing, wood cutting, etc., to improve his wind and strength.

Supporting Card Also Good. The second fight also is attracting much attention. Carl Wasson, Roseburg, who has made a sensational start as a professional fighter, is to be matched with Carl Mosier, said to be a tough and aggressive boxer. Mosier has not previously appeared in a local arena. Wasson is very conscientious in his workouts and is boxing several hard rounds daily in addition to road work and conditioning exercises.

In one of the preliminary matches, Bob Fenton, the deceptive Sutherlin youngster who has blasted out four knockouts in as many fights, will be up against a plenty tough boy when he meets Shue Brunster of Marshfield. Brunster is of much the same type as Fenton, according to advance reports, and an interesting encounter is anticipated.

Several other preliminaries will round out what is expected to be one of the best cards in many years.

MINING SUIT AT MEDFORD SETTLED

MEDFORD, June 22.—(AP)—An order dismissing the suit of the Most Rev. Francis J. Beckman, Archbishop of Dulague, against Philip Suetter and others of Grants Pass, Ore., was signed Thursday by Circuit Judge Norton. The injunction against Suetter was also ordered vacated. The litigation was based on a Josephine county mining deal.

The dismissal order, according to Attorney George M. Roberts, counsel for Suetter, was the result of a contract of settlement entered into last Saturday at Grants Pass, between the parties concerned and their counsel.

Under the terms of the settlement, Suetter receives certain mining properties and equipment and money. Attorney Roberts said, Suetter surrenders to the archbishop promissory notes executed by the archbishop and held by Suetter, amounting to approximately \$150,000. It was further explained.

The archbishop, under the terms, is to pay indebtedness outstanding by reason of the operation of the mines, and purchase of equipment, the indebtedness including promissory notes held by third parties, it was explained.

It was announced both parties were satisfied and expected resumption of their respective mining properties.
