ROY GARDNER FREE OF FEDERAL COURT

PORTLAND, Ore., July 10.—(AP)—An indictment charging Roy Gardner, one-time notorious train robber, with sending obscene matter through the mails was quashed today by Federal Judge Fee.

Gardner, who served prison sentences at San Quentin, Leavenworth and McNeil Island, was accused of writing obscene matter to Mrs. Ardith Homan, of Lodi, Calif., newspaperwoman, in a dispute over collaboration of his life story. The letter was mailed at Medford, Ore.

In a memorandum opinion mailed from Fort Lewis, Wash., to Edward Heck's, Gardner's attorney here the jurist said:

"The letter is vulgar, coarse and reflects the character of the defendant and the environment in which he has spent many years, but it is not criminal under this statute."

MAY BOOST STAFF OF WELFARE OFFICE

A supplemental quota of eight men is expected by the Douglas county welfare commission, John I. Diefenderfer, executive secretary, reported today. The county was given an original quota of 12 recruits. Forty-five applications were received and investigated, of which number 22 applicants were found eligible. Twelve were assigned last Thursday to the All-Oregon camp at South Umpqua falls.

Some of the other counties of the state it was reported, have failed to fill their original quotas and the vacancies will be filled by supplemental quotas assigned to counties which had a surplus of applications.

The addition of eight to the original 12 will permit assignment of all except two of the eligible young men seeking placement. Mr. Diefenderfer states, in the event these two applicants cannot be immediately placed, they will be given preference at the October enrollment period.

SAFETY EDUCATION COURSE SCHEDULED

Individuals qualified to teach the principles of safety in schools, lodges, civic organizations, and other groups will be trained at Oregon's first college course in safety education, to be offered at the University of Oregon Portland summer session, July 17-28, it was announced today.

The course will be sponsored by Earl Snell, secretary of state, in cooperation with the state system of higher education. In charge of the work will be Kenneth N. Beadle, director of the division of education for the national conservation bureau, New York City, and Hugh E. Rosson, director of traffic safety for Oregon, from the secretary of state's office.

The course is designed to provide a scientific background for those carrying out programs of safety instruction in schools, civic organizations or other groups. Snell said in describing the course. It will be of special interest to teachers who are interested in becoming competent safety instructors in their school systems, he said.

PRISONER IN DRY AGENT CASE FREED

BATON, N. M., July 10.—(AP)—Harold Cameron of Clovis was unconditionally free today of murder charges placed against him nearly two months ago in a revived investigation of the nine-year-old disappearance of Federal Prohibition Agent Ray Sutton.

Cameron was released from jail here Saturday on recommendation, Under Sheriff Byrch Telford said, of Special Agent D. W. Black of the federal alcohol tax division. He may be returned, however, as a material witness in case Allen Loo-troff 48, is brought to trial.

Loo-troff, arrested at a sheep camp near Wain Wain, Wash., and charged with slaying Sutton, remained the only suspect still held. Cameron's mother and brother, arrested with him at Clovis, were released some time ago.

Sutton last was seen near Clayton August 25, 1930, when he was believed on route to the mountain country in search of a illicit still. His brush-covered automobile was found in an isolated region two months later. That was the last trace of him.
