Los Angeles Downs Sactos, Portland Gains Win Over Hollywood.

Little Dominic Dallascandro, San
Diego outfielder who is leading the
Pacific Coast league in batting, was
an unpopular guy with the Seattle
baseball club today.

Dallascandro connected for a
sharp single in the ninth inning at
San Diego last night to score Pitch-
er Tobin with the run that gave
San Diego a 5-4 victory over the
first-place Rainiers.

With Los Angeles' 4-0 victory over
Sacramento, the Seattle loss cut the
Rainiers' lead to three and a half
games.

Tobin, who relieved Crashead on
the Padre mound in the second,
opened the ninth with a triple, and
came home on Dallascandro's sin-
gle. Ferguson had walked and
McDonald had popped out.

Los Angeles got an unearned run
in the fifth at Sacramento to break
a streak of 23 innings without scor-
ing a run, then tied the score in the
seventh and won in the ninth on a
double by Jimmy Collins, which
scored Emiliani.

Flores beat Bill Schmidt in a
pitchers' duel.

Ed Levy, lanky first baseman
Oakland just received from Newark
of the International league, drove
in four of the Oaks' seven runs
with a double and a triple as Oak-
land beat San Francisco 7 to 5, at
Oakland.

At Hollywood, the rising Port-
land Beavers set the Hollywood
Stars deeper in the basement by
winning a see-saw game, 6 to 5, on
Frederick's sacrifice fly which
scored Rosenberg. The Beavers
scored three runs in the first on
Manager Bill Sweeney's triple.

KLAMATH SPORTS OPPOSE DOE KILLING

KLAMATH FALLS, Ore., Aug. 1.
—(AP)—Klamath sportsmen op-
posed to doe shooting in the area
near the Lake-Klamath mule deer
refuge have sent a letter to Gov-
ernor Charles Sprague asking his
interest in the situation.

The state game commission at
its July meeting decided to open
the season in the area for the shoot-
ing 500 does by special permit.

Since then circulation of peti-
tions opposing the action has been
started by a group of sportsmen
here. A petition bearing about 100
names has been sent in and it is
reported about 1000 names have
been signed to petitions not yet col-
lected.

In a letter to Governor Sprague
the opponents of doe shooting cite
recent seasons' loss of both east and
west of Klamath Falls and possible
heavy loss of deer in these areas.

They urge Governor Sprague to
take an interest in their efforts to
prevent doe shooting.

For two years considerable con-
troversy has prevailed in this sec-
tion of the state over the question
of altered overgrazed conditions on
the winter range of the mule deer
in northern California not far from
the state line. Oregon deer from
the Lake-Klamath area winter on
this range.

Doe shooting has been proposed
as a method of reducing the herd
which winters in the northern Cal-
ifornia district. The commission
hold a hearing on the question in
Klamath Falls before taking ac-
tion.

furniture. In the many years
he has followed this
interesting avoca-
tion, he has largely
furnished his home
with splendid chairs,
tables, buffets, lamp

hogany, walnut, maple, myrtle
and other of the hardwoods which

war. He has taught the use of
nearly every musical instrument.
He has a large and valuable col-
lection of concert and symphony
music.

RUFFING DEFEATED

Top Pitching Trio Has Bad
Day in Majors; Cubs Win
Behind Larry French.

Reputations may be priceless
but three of baseball's foremost
pitchers will tell you today that
this is just idle prattle in the ma-
jor arenas.

It's disrespectful enough that the
world champion New York Yankees
and the National league leading
Cincinnati Reds should be called
on the same day. Yet this not only
happened yesterday with their re-
spective pitching technicians, Red
Derringer and Paul Feller, in the
control booth, but the same short-
circuit cut down young Bob Feller.

Ruffing had not been beaten by
the Detroit Tigers since June 1937
and had won 13 consecutive games
from the Bengals but the Tiger
troupe routed him 5-2 in their au-
tumn opener at New York.

Greenberg took personal charge
of the rebuttal, hitting his 20th
home of the season with two on
in the first and later getting his
32nd double.

Giants Beat Cincinnati
The New York Giants preserved
one claim to distinction by edging
out the Reds 5-4 in 10 innings and
remaining the only team which
holds a margin over the Reds for
the season. They have won eight
of their 14 games with Cincinnati.
Derringer went the route for the
Reds even though he blew a three
run lead in the sixth when the Gi-
ants bunched six hits for four
runs, launching tripled with two on
to spark this rally and then slugged
the winning run across in the
tenth.

It was Cincinnati's first setback
in 11 games.

Feller's nemesis was young Bob-
by Doerr, who hit two home runs,
the second with the bases loaded,
to pace the Boston Red Sox to a
7-5 triumph over the Cleveland In-
dians.

Larry French Wins
The first day of August also pop-
ped up with a couple of other fea-
tures. For one thing Philip K.
Wrigley, owner of the Chicago
Cubs, chose to see his hirings
perform—an unusual pastime for
him. Luzzy Dean's \$185,000 throw-
ing arm took this occasion to go
on the blink again and Manager
Gabby Hartnett pushed Larry
French into action. The veteran
left-hander, who had complained to
Wrigley the day before that he
wasn't getting enough work, there-
upon pitched the Cubs to a 6-2 vic-
tory over the Phillies.

For another there was an out-
burst of 15 triples—baseball's rare-
st hit—in seven of the day's
eight games including five in the
St. Louis Cardinals' test with the
Boston team. Nine hits two with
men on base and the Martins
Stu and Pep, each contributed one
as St. Louis won, 4-3.

Dixie Walker hit two for the
Dodgers, driving in two runs, as
Brooklyn beat the Pittsburgh Pi-
rates 5-3.

In the American league Gullant,
Washington catcher, hit a three
bagger with the bases loaded in the
fifth to lead the Senators to a 7-5
victory over the St. Louis Browns.

The Chicago White Sox downed
the Philadelphia Athletics 4-1 on
the effective bludgeoning of
Knott and a helpful two run homer
by Rosenthal.
