

ABDUCTION, MURDER OF GIRL ADMITTED

BOCA RATON, Fla., Aug. 10.—(AP)—A man booked as Charles Jefferson, 34, confessed to police today he had abducted two Miami high school girls with the intention of holding them for ransom, killed one and held the other captive until early today.

Leif E. W. Melchen of Miami detectives announced the confession at the Boca Raton police station, where Jefferson was held after his arrest near the scene of the slaying of 17-year-old Ruth Frances Dunn.

Melchen reported Miss Dunn and Jean Bolton, 19, were found in the man's automobile which he drove into a lonely beach section about 600 feet off the ocean highway between Miami and West Palm Beach.

Jefferson, also known by several aliases, admitted criminally assaulting Miss Dunn Monday night, the detective lieutenant stated.

"He said he killed Miss Dunn because she cried for help and because he was hysterical despite his warning they were to remain quiet," he reported.

Nude, shot three times and stabbed twice, the body of Miss Dunn was found beside a swamp early this morning two miles north of Boca Raton, in Florida's gold coast winter vacation area.

Miss Bolton was under a physical man's arm at her mother's home. Her mouth lapsed and she became nervous state, she told of having been bound and held captive since leaving her home Monday with Miss Dunn and Jefferson, who professed to be a "talent agent" for movie tests at Palm Beach.

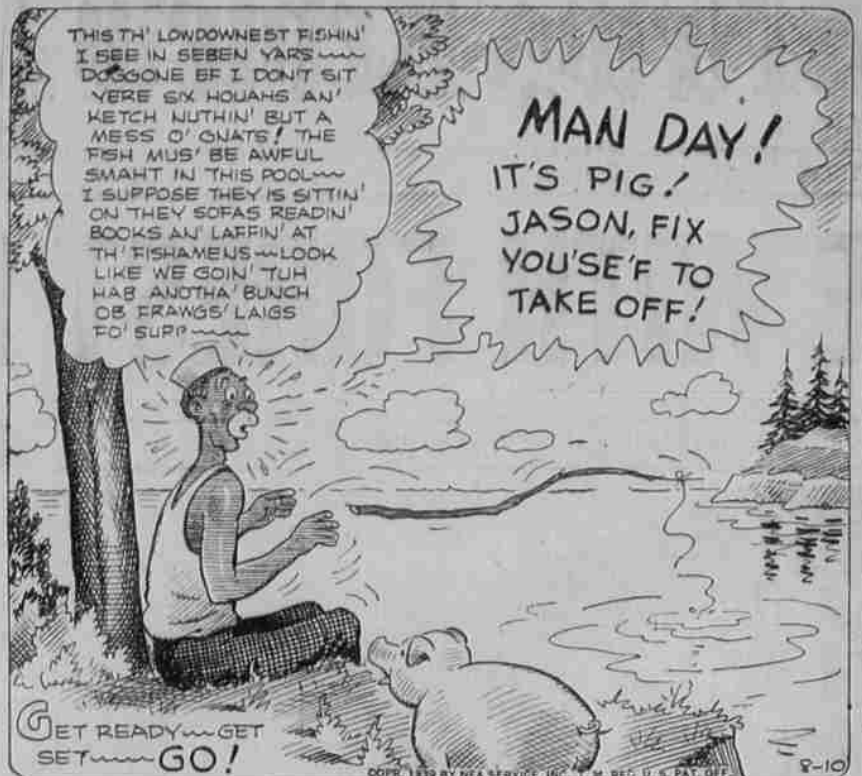

KLAMATH INDIAN MONEY BILL SIGNED

WASHINGTON, Aug. 10.—(AP)—President Roosevelt signed yesterday a bill providing for distribution of \$20,000,000 obtained by the Klamath Indians against the federal government.

The measure would divide \$2,800,000 among the Indians. Each would receive \$100 cash and \$2,500 credit for purchase of land and other capital investments; give \$300,000 to the tribal loan fund, \$370,000 for payments of \$1,500 each to about 250 members who received no individual land allotments and place the balance in the tribe's capital reserve fund.

BUSINESS PROGRESS CITED BY HOPKINS

WASHINGTON, Aug. 9.—(AP)—Secretary of Commerce Hopkins said today business progress during July represented a continuation of a "recovery movement" started in May, with activity well ahead of a year ago in all major lines.

Prospects for third quarter business have improved, he said, and business policies generally reflect less hesitancy.

Retailer commitments in wholesale markets are enlarged, Hopkins' report showed, and industrial purchasing has expanded. Orders in many clothing lines showing substantial gains over the earlier part of the year were cited as indicative of the more confident attitude toward fall business.

Construction operations were at a seasonal peak, activity in the industry being even greater than in the summer of 1937.

Retail trade in July was well ahead of a year ago, with marked gains in consumers' durable goods such as automobiles, refrigerators, furniture and electrical appliances, and gasoline consumption was at record levels.

Consumers' budgets were said to have benefited from lower food costs as compared with a year ago. Consumers' incomes in July were on a higher seasonally adjusted basis than in June, following a substantial rise in employees' compensation from May to June.

COUNTY WARNED ON PAYMENTS FOR AID

A detailed analysis of welfare laws passed by the recent congress, coupled with warnings that old age assistance expenditures must be closely checked to comply with federal regulations, marked a meeting here Monday evening of the Douglas County Welfare commission. Gouly, state administrator, who outlined the new changes in federal regulation, and who warned that federal funds might be withdrawn if help was given persons not dependent upon the public for subsistence.

PILING SHIPMENTS HERE SHOW GAIN
