GOVERNOR C. A. BOTTOLFSEN

of Idaho and Governor Clarence D. Martin of Washington have set good examples for executives of other sugar beet growing states to follow: Governor Martin set aside a week in early June as "Washington Sugar Week." Governor Bottolfson followed, designating the two weeks period, July 17 to 29, as "Idaho Sugar Week." Both of these governors have thus effectively called attention to the importance of the beet sugar industry in their states and have urged all consumers to use the home produced sweetening element.

Back of such official recognition of the western beet sugar industry lies more merit than simply selling a home-made product to the home folks by calling attention to the importance of this basic industry in the economic life of these states, these executives have also indirectly pointed the need of better legislative control over the whole sugar business. To say the least, it is a legislative paradox that "freezes" the American beet sugar industry at present levels while our own producers are growing and refining less than 30% of our own national requirements, and the other 70% is being imported from Cuba, the Philippines, and our insular areas.

If our memory serves us right, the president of the United States has shown his unkindness to the American beet sugar industry on more than one occasion. He has called it a "necessarily expensive industry," and he and his cabinet members have unjustly charged that present legislation assuring to the domestic sugar industry its share of the American market already costs the American consumer \$250,000,000 a year, or enough to purchase "fifty bottles of milk and fifty loaves of bread annually for every family in the United States, including the undernourished one-third."

That these charges are wholly unjustified, is known to every informed economist. Just why should the administration single out the beet sugar industry on charges of raising prices of farm commodities, when they kill little pigs, and otherwise curtail farm production in an effort to raise the prices of farm commodities in the interests of the producer?

IN THE SECOND PLACE, SUGAR PRICES

to the American consumer are close to the low all time price level which is further proof that the consumer is not being gouged at the expense of the sugar beet grower. Finally, who wants to open the flood-gates of American markets to foreign goods produced at labor costs at less than one-fifth of our own? When have we in America decided to buy all our necessities from Japan, Cuba, or the Philippines, or other places where standards of living are pitifully low and wages shamefully depressed? Should the Department of Agriculture legislate the American beet sugar industry out of existence simply because minimum wages for field labor are five dollars a day in Oregon, compared with 20c a day in the Philippines, or 70c in Cuba?

We think this is not the American answer. It is high time that we give a thought to the welfare of our next-door neighbor in our governmental "good neighbor policy." As Abraham Lincoln is credited with saying, "When we spend a dollar for goods made abroad, that dollar may come back or it may not. But when we spend a dol-

lar for American-made goods, we know we have that dollar." Maybe this country still needs more of the philosophy of Abraham Lincoln, and less of the theories concocted by amateur economists in Washington.

France, with the world's finest army, would swim over the Alps, converge on the Italians on the other side and batter them to a pulp. At the same time, a combined British and French fleet, immensely superior to Italy's fleet, would be pounding Italy's long and exposed coastline.
